Accommodation of Interests and Abilities	X		According to data and responses submitted by the school, it has met the standard established in Test 3 for provision of athletic opportunities during each of the past three school years. The school currently offers all KHSAA sanctioned sports for girls at the varsity level except soccer and swimming. A total of 11 team sports are offered for both boys and girls. The last two student athletic interest surveys have shown a marginal interest in girls soccer (30 in 2008-09, and 15 in 2009-10). School officials were alerted to the fact that, although the indicated interest has decreased, it should be validated for authenticity in order to meet the standard of Test 3 in the future. KHSAA officials reviewed the school's Title IX file. It was found to contain the school's original audit report from February 14, 2002, all the annual reports to KHSAA for the past five years, a current board approved salary schedule for coaches, sample game schedules for all sponsored sports at the school, a seasonal sports calendar for boys and girls basketball, written facility usage schedules for all shared facilities (see Medical and Training Facilities and Services), written guidelines regarding awards and recognition of athletic accomplishments (see Publicity), written designation of locker room space and athletic storage space assigned each team, written Gender Equity Review Committee meeting minutes for the past three years, a written uniform review and/or replacement plan based on a four-year rotation, and written guidelines relating to equitable provision of travel and per diem (see Travel and Per Diem). School officials were commended for the development of a comprehensive and user friendly Title IX file.

Equipment and Supplies	X	DATA ON THE RE-VISIT REPORT WAS INVALID IN THIS CATEGORY, THEREFORE, ANNUAL REPORTS WERE USED FOR EVALUATION IN THIS AREA. According to the February 14, 2002 report, the school was satisfactory in this area, and a uniform review and/or replacement plan based on a four-year rotation was being implemented. Data on the school's 2009-10 annual report indicates that the school was spending approximately \$91 per female athlete compared to approximately \$103 per male athlete for provision of equipment and supplies. All the uniforms reviewed during the visit were found to be comparable in quality and quantity. The school still implements a four-year rotation plan for the replacement of uniforms.
Scheduling of Games and Practice Time	X	The February 14, 2002 audit report indicated the school was satisfactory in this area and was meeting the minimum standard for provision of prime time playing opportunities for girls basketball. According to the school's 2009-10 girls basketball results posted on the KHSAA web site, 45% (5/11) of the girls home games were played on prime dates, and a review of posted game times indicated that prime time requirements were also being met. The school's re-visit report showed that the scheduling of competitive events for "like" sports were comparable over a two-year period. The visit showed that all shared practice facilities were assigned equitably.
Travel and Per Diem Allowances	X	DATA SUBMITTED ON THE RE-VISIT FORM WAS INCORRECT IN THIS CATEGORY REQUIRING THAT ANNUAL REPORTS BE THE BASIS OF THIS EVALUATION. According to the 2009-10 annual report, the school was spending approximately \$170 per female athlete compared to approximately \$69 per male athlete for the provision of travel and per diem. The school's Title IX file contained a set of written guidelines for the equitable provision of travel and per diem. The section of guidelines relating to provision of meals and motel rooms for overnight trips needs to be more specific in relation to what is provided for student athletes.

Coaching	X	The February 14, 2002 audit report rated this category as satisfactory and stated that salaries were comparable for coaches of female teams. According to the 2009-10 annual report, the number of coaches provided for "like" teams shows equivalence. According to the re-visit report 71% (5/7) of the girls head coaches are on-campus employees compared to 57% (4/7) of the boys head coaches. The 2009-10 annual report documents that the total amount expended for coaches' salaries for "like" sports showed parity. A review of the school district's extra service pay schedule for coaches appeared equitable.
Locker Rooms, Practice and Competitive Facilities	X	At the time of the February 14, 2002 school visit, dugouts and a storage/concession stand were being constructed at the softball field. The most recent visit showed that this project has been completed, and the amenities provided at the softball field are improved. An inspection of the baseball field indicated that the boys maintain a slight advantage. The baseball field still has a superior press box and dugouts. The school's next facilities improvement project should continue to have the softball facility as a priority. The four outdoor tennis courts are very well appointed and have been significantly improved since the first visit. Although there is an overall shortage of athletic storage space, the space that is available seems to be assigned equitably. There is also a shortage of locker room space at the school. It does appear that each team has been assigned a place to dress. It is requested that the Gender Equity Review Committee review the dressing room assignments for girls teams in an attempt to ascertain if the existing space could be used more equitably.

Medical and Training Facilities and Services	X	The school currently provides a small weight training room with a limited amount of equipment. The school has a written usage schedule for the facility that was a part of the Title IX file and was also posted at the facility. This schedule did not show specific designated times for use of the room by female athletes and should be expanded to do so. (See KHSAA Recommended Action.) The weight room's current location is equally accessible to both male and female athletes. There is equipment provided at the facility that is appropriate for use by females. When the equipment inventory is updated, it is suggested that more small hand weights (5 pounds and below) be added. No athletic training services are currently available at the school.
Publicity	X	According to the re-visit form, the school spends approximately \$14 per female athlete compared to approximately \$19 per male athlete for promotions, publicity, and awards. According to the re-visit report, the school has one cheerleading squad that cheers at all home and away football games, all home and away girls and boys basketball games, and at all post season tournaments for football and boys and girls basketball. The school band plays at selected home boy/girl double-header basketball games.
Support Services	X	The February 14, 2002 audit report indicated that expenditures for male and female sports were comparable and, at that time, there was only one athletic booster club for all sports. The school currently has no active athletic booster clubs. School or district funds are used for all athletic purchases, and purchase orders are required. According to the school's 2008-09 and 2009-10 annual reports, total athletic spending was well within acceptable parameters both on a percentage and per athletic basis.

5. Brief Summary/Analysis of the Corrective Action Plan (Form T-60)

The school's most recent corrective action plan calls for the following:

- developing a uniform rotation plan;
- improving the monitoring of athletic expenditures to insure equitable distribution of funds;
- · upgrading outdoor athletic facilities; and
- · upgrading of athletic equipment.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

No major deficiencies were observed during the recent school visit. It is recommended that the following areas be addressed so the school can move closer to "equivalence" in all areas.

- In the area of Travel and Per Diem, the current guidelines should be expanded to include the provision of meals and motel rooms during overnight trips.
- In the area of Publicity, the current guidelines should be expanded to include specific standards which need to be met in order to have a banner hung in the gym.
- In the area of Locker Rooms, Practice and Competitive Facilities, the Gender Equity Review Committee should review the current assignment of locker rooms for provision of parity. (See KHSAA Recommended Action.) Continued improvements at the softball field should remain a priority until provision of amenities there are equivalent to those at the baseball field.
- In the area of Medical and Training Facilities and Services, the current weight room usage schedule should be expanded to include specific time slots when the facility is available for use by female athletes (teams).
- In the area of Accommodation of Interests and Abilities, the school should pursue the validity of indicated interests that are designated on the student athletic interest survey if Test 3 is an area in which compliance is necessary.

7. KHSAA Recommended Action in relation to new deficiencies

Although no new deficiencies were designated during the recent visit, the following areas of concern need to be addressed in order for the school to maintain its non-deficient status.

(Locker Rooms, Practice, and Competitive Facilities) On or before <u>January 15, 2011</u>, the school is to submit to KHSAA written minutes from a Gender Equity Review Committee meeting in which the current assignment of athletic locker rooms is reviewed. Any proposed changes in teams assigned to specific dressing rooms should be included in this document.

(Medical and Training Facilities and Services) On or before <u>January 15, 2011</u>, the school is to submit to KHSAA a revised usage schedule for the school's weight training room. This schedule should include specific blocks of time designated for female athletes (teams).

8. KHSAA Recommended Action in relation to reoccurring deficiencies

No deficiencies were designated by the February 14, 2002 audit report.
