Accommodation of Interests and Abilities	x		According to the data submitted on the 2012 Student Interest Survey, students in grades 8 thru 11 were surveyed with a return rate of 90%. There are currently 26 sport level opportunities for males and 24 sport level opportunities for females. Archery has been added to the sport offerings for the 2013-14 school year.
Equipment and Supplies	x		Uniforms viewed appeared to be of high quality (NIKE) and equivalent in quantity for all teams. The baseball team chooses to use Speedline uniforms. There was written evidence of a 4- year uniform review/replacement plan in the Title IX file.
			All other equipment viewed appeared to be equivalent in quality and available for all teams equally. A two-year expenditure average shows approximately \$205 spent per male athlete and \$137 spent per female athlete.
Scheduling of Games and Practice Time	x		Interviews with coaches and the athletic director indicated practice time and facility rotation was equitable at each shared facility. Priority was given to the in-season sports.

			Game schedules viewed appeared to be comparable and equitable for all sports.
Travel and Per Diem Allowances	x		There was written evidence of a \$5/meal per diem policy. Interviews with the administration and athletic director indicated the present written Travel/ per diem policy is being discussed and revised by the Gender Equity Committee.

Coaching	X	There was written evidence of a school board approved pay schedule for coaching positions that showed equivalence and parity for all sports. A review of the number of on-campus and off-campus coaches showed equitable access for male and female athletes. The current ratio of athlete to coach is 11:1 for males and 10:1 for females.
Locker Rooms, Practice and Competitive Facilities	x	There was written evidence of locker room assignments for all teams. The amenities of practice and competitive facilities appeared to be well maintained, comparable and equivalent. All teams were assigned on-campus storage and office space. Soccer, football, basketball, volleyball, and tennis have practice and competitive facilities on campus. There are two gymnasiums (small and large) shared by the basketball teams.
		Off campus venues are: Lincoln Trail for golf, Gannon pool at Fort Knox for swimming, Dixie E-town Lanes for bowling, Freeman Lake for tennis and cross-country. Cross-country competitions were held at the Fairgrounds.

Medical and Training Facilities and Services	x	Central Hardin High School has a contract with Hardin Memorial Hospital for the services of an athletic trainer. The trainer attends practices and competitions on a daily basis. It is recommended that the trainer's schedule and emergency contact number be posted on the training room door. Physicals for athletes are offered for \$10 during the summer and spring.
		Central Hardin has one weight room located in the field house. It appears to be easily accessible to female athletes and is equipped with female friendly weights and machines. Interviews with the athletes indicated the weight room facility is available for use by all teams and an advanced sport conditioning class for male and female athletes is part of the school curriculum. A written schedule for weight room rotation was present in the Title IX file but it needs to be posted on site to ensure parity.
		Written emergency plans for all venues were present in the Title IX file.
Publicity	x	Central Hardin has one cheerleading squad that cheers at all home and district away football, girl's basketball and boy's basketball games. A pep band also performs and is scheduled through the athletic director to ensure equity.
		There are fall, winter and spring programs that encompass all male and female teams.
		There was written evidence of an awards guideline that included provision for earned awards, Senior night and banner display,
		Interviews with athletes and coaches indicated an awards night/banquet recognition program was held for all sports.
Support Services	Х	There was written evidence of signed and notarized agreements on file for football, golf, volleyball, baseball, softball, and soccer booster clubs. These booster clubs have off-campus accounts and currently follow procedure outlined in Redbook for approval of fundraisers and disclosure of accounts. It is recommended that the administration develop a process that provides for oversight ensuring equity in expenditures by the booster clubs.
		Total athletic spending for a two-year period appears to fall within acceptable parameters both
