The audit team recommends that the Gender Equity Committee find a way to obtain a higher percentage of return and to include eighth graders.

5. Brief Summary/Analysis of The Corrective Action Plan (T-60)

The Audit Teams discussed several items that need to be added to the Corrective Action Plan. Forming a girls' golf team was listed on the 2000-2001 plan but not included on the 2001-2002 plan. A girls' golf team has not been started. However, there have been several items listed for correction that have been accomplished. One item listed as softball dugouts has been placed on all Corrective Action Plans since 1999 and has not yet been completed. Concrete pads have been poured; the fence has been taken down; the field is supposed to be completed by the start of the 2003 softball season. This project was scheduled to be completed in 2000 according to the Corrective Action Plan. The Audit Team strongly recommends that this renovation be completed by the start of the 2003 softball season.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

No deficiencies were found.

7. Facility Recommendations or Concerns

The Audit Team strongly recommends that the softball field be ready for play by the start of the 2003 season. This should include new dugouts and a new fence with

protective covering.
