This interest was indicated on the student survey. However, these sports had to be cancelled due to the fact that the coach was called up for active military duty. The KHSAA Audit Team strongly recommends that these teams be reconvened for the 2003-2004 school year.
Equipment and Supplies	X		Some items on the team sheets did not correspond to some items on the summary sheet. Corrections were made and placed in the Title IX file. Additional storage is needed for equipment and supplies. The KHSAA Audit Team recommends that the Gender Equity Review Committee establish a written policy for the replacement and rotation of uniforms.
Scheduling of Games and Practice Time	X		Some team sheets were not signed. "Prime time" scheduling does not apply due to the fact that girls' basketball has not been played for the past two years. However, the 2000-2001 schedule indicates that 40% of the girls' basketball games were played during "prime time".
Travel and Per Diem Allowances	X		Form T-16 was not completely filled out. The Athletic Director will complete this form and place it in the Title IX file.

5. Brief Summary/Analysis of The Corrective Action Plan (T-60)

The 1999-2000 Corrective Action Plan stated that all items are in compliance and, therefore, lists no items for compliance. The 2000-2001 Corrective Action Plan stated, "We feel we are in compliance with all items." The 2001-2002 Corrective Action Plan listed one item, which was to get more girls interested in JV and varsity basketball. Although this is a very good and needed goal because girls' basketball has not been played for the last two years, the KHSAA Audit Team suggests that this goal be broadened to include all girls' interscholastic participation. The overall girls' interscholastic participation has decreased from 50.5% to 36% in the last year. Specific suggestions on how to reach this goal as well as a specific time table should be included. There were other items that the KHSAA Audit Team suggested to the Gender Equity Review Committee that needed to be included in their plan.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

There were no observed deficiencies.

7. Facility Recommendations or Concerns

The KHSAA Audit Team strongly recommends adding more storage for equipment and supplies. Storage space is very limited. Also, the weight room is small with only four universal machines and no other equipment. It is in an upper corner of the gym and is in a cage.
