Accommodation of Interests and Abilities	<b>X</b>		The Accommodation of Interests and Abilities is rated as satisfactory. For this school year, 2004-2005, female students have the opportunity to participate in basketball, softball, golf, soccer, swimming, track, tennis, and volleyball. This past fall cross country was offered; however, the season was not completed due to the unexpected loss of the coach. In reviewing the KHSAA Title IX Re- Visit Verification Forms, it appears that there has been a decline in the percent of participation for female athletes during the past three years. It was the opinion of the Athletic Director that the KHSAA Annual Report to be submitted in April 2005 would show an increase in participation since freshman and junior varsity volleyball teams and a junior varsity soccer team were added for this year.
Equipment and Supplies	X		Members of the swimming team buy their own uniforms. For all other sports, uniforms are purchased with funds from the team's individual budget. The Athletic Director is responsible for approving all uniform purchases. It is the recommendation of the KHSAA Audit Team that the written policy for the purchase of uniforms be revised to more accurately reflect current practice.

Scheduling of Games and Practice Time	<b>X</b>	A rotation plan is in effect for the use of the gym for the basketball teams, and a practice field and a game field for the soccer teams are shared equitably. For the 2004-2005 basketball season, the girls' team is scheduled for four of their home games to be played during prime time. This represents 40% of their home games during prime time. School personnel are encouraged to continue with at least 40% of the girls' basketball games during prime time for upcoming seasons. The basketball schedule also reflects a number of double-headers and it was mentioned by a student-athlete that the start times are rotated for the boys' and girls' games.
Travel and Per Diem Allowances	X	The school board pays for the cost of transportation by bus and van for the teams' travel. It is recommended that the Gender Equity Review Committee develop a written policy for meal allotments. It appears there may be a lack of parity in the meals that are provided for the various teams.
Coaching	X	A copy of the board approved salary schedule for the supplemental positions is kept with Title IX documents. The coaching staffs for girls' sports include numerous females. All girls' teams, other than softball, have at least one female coach.

		involved in selecting a site for a new high
		school. The planning and construction of the
		high school will require a minimum of three
		years and decisions have not been made
		regarding competitive facilities. Also, it is not
		certain how the facilities located at the current
		high school location will be used in the future.
		Although it is not a Title IX issue, it is hoped
		that facilities can be completed for the tennis
		and track teams. The on-campus softball
		facility includes concrete dugouts, scoreboard
		and a press box. Although the field does have
		lights, it appears that there may be question if
		they provide adequate illumination for
		nighttime play. Due to safety issues, school
		personnel are strongly urged to review this
		situation. Also, it was mentioned during the
		Audit Team's visit that the facility would be
		greatly enhanced with the addition of running
		water for restrooms and a concession stand.
		The gymnasium, built in 1965, was remodeled
		approximately five years ago. It is
		recommended that the Gender Equity Review
		Committee develop a written policy for the
		display of banners and awards. A volleyball
		court was added, there are now two courts each
		with their own scoreboard. The soccer,
		basketball and softball teams share the girls'
		athletic locker room. The boys' and girls'
		athletic locker rooms are comparable in many
		respects except that the girls must use a
		restroom located near the locker room. It is
		recommended that the girls be provided with
		another locker room and that it be appointed
		similarly as the boys' locker room.

Services			local agency was not fulfilled, but school
			personnel are endeavoring to retain medical
			services this spring. The most urgent need
			relative to this benefit is the lack of an
			appropriate weight training facility for female
			athletes. Although girls do have access to the
			field house weight room, it is not properly
			equipped for females. The Athletic Director
			indicated that universal machines are stored off
			campus. School personnel must immediately
			develop at plan to remedy this situation.

Ť			sports. Schedule cards are printed for boys'
			and girls' basketball, volleyball and football,
			and baseball and softball. There is one
			cheerleading squad at Garrard County High
			School and the cheerleaders perform at an

			activity. All gate receipts are proportionally
			divided among all teams; however, the funds
			are used to pay for officials. There are a
			number of booster groups with varying levels
			of supporter activity and organization. All
			booster organizations, other than football, have
			school accounts. Any expenditure by these
			groups requires that a "request to purchase"
			form is completed, and if approved, a purchase
			order is cut. It is recommended that a revised
			agreement for the football group be signed in
			an effort to gain consistency in the oversight
			and management of booster organizations.

## 5. Brief Summary/Analysis of the Corrective Action Plan (Form T-60)

The majority of the items included in the Corrective Action Plan submitted with the KHSAA Title IX Re-Visit Verifications Forms this past fall involved facility improvements. Specifically, listed items were the completion of the upgrades to the soccer field and the addition of a track and tennis courts. Additionally, the plan included increasing participation opportunities for female athletes through offering a freshman team and two junior varsity teams.

## 6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

It is imperative that female athletes have access to a weight room that is suitably equipped for their needs. It appears that universal machines are available and they should be located in an area that is welcoming for female athletes.

## 7. KHSAA Recommended Action in relation to new deficiencies

School personnel are to develop a plan including a timetable that clearly delineates the actions that will be taken to ameliorate the deficiency described above. The plan is to be submitted to KHSAA by **April 15, 2005**.

#### 10. Comments

The Title IX documents were organized in notebooks and were well presented. However, it is noted that minutes from Gender Equity Review Committee meetings from previous years were missing. Every effort should be made to secure these documents and include them with the other relevant Title IX information. Minutes from the Gender Equity Review Committee meeting held on January 31, 2005 were on file. During the Re-Visit, the KHSAA Audit Team was assured that at least three meetings would be held this school year. The Athletic Director, who also serves as an Assistant Principal, is new to his position at Garrard County High School and seems to be diligently working to provide leadership for the interscholastic athletic program and implementation of Title IX.

Interviews with student-athletes and coaches at Garrard County High School indicate that improvements have been made during the past few years and that the administration supports athletics for females and males on an equitable basis. The students stated that there has been more emphasis on academics and they are pleased with the greater number of prime time games for girls' basketball. Both coaches and students would like to see facilities for tennis and track added.

Plans for continued improvement of the athletic facilities are somewhat uncertain at this time due to the school board's decision to construct a new high school. However, it is important that arrangements for a weight room that is suitable for the needs of female athletes be made without delay. Also, it is highly recommended that the lighting at the softball field be scrutinized to determine if there is a safety issue that should be addressed. Finally, the KHSAA Audit Team strongly urges school personnel provided a locker room for female athletes that has restrooms and is appointed comparably with the male athletic locker room.
