Accommodation of Interests and Abilities		X	According to the school's most recent submission of forms to the KHSAA, it meets none of the standards established in the three tests for opportunities (Forms T-1, T-2 and T-3). The school visit showed that with the addition of the freshman volleyball team and the pursuance of the girls' soccer interest, the school should meet the standards in either or both Test #2 and Test #3. (See Comments section.) The school's student survey was discussed and the need for a significantly greater number of responses was emphasized. The school's Corrective Action Plan was discussed. School officials were alerted to the fact that this plan should focus on major areas of need related to equity.
Equipment and Supplies	X		The proper method of completing summary forms was discussed. There appears to be a general need for storage areas for several sports. School officials are currently working on a plan to address this need. The school does have a uniform rotation plan.
Scheduling of Games and Practice Time	X		Prime time scheduling was discussed. The school is currently playing 31% of its girls' basketball games in prime time and is working to make further progress in this area. There appears to be general parity in the scheduling of practice facilities.
Travel and Per Diem Allowances	X		There is a discrepancy between summary sheets and team sheets in the area of meal allotments. The need for school officials to be involved in insuring equity in this area was emphasized. All other sections in this area appear to show parity.

Coaching	X	The school is working hard to employ female coaches for girls' sports.	
Locker Rooms, Practice and Competitive Facilities	X	Equity exists, but additional space is needed for all sports.	
Medical and Training Facilities and Services	X	It was suggested that the school have a posted weight room schedule and look into purchasing more weight equipment that can be used by female athletes (i.e. universal type machines). Again, consistency between team sheets and summary sheets was reiterated to school officials.	
Publicity	X	There appears to be overall parity in this area. Cheerleading was discussed. The school has one cheerleading squad which cheers at all girls and boys home games and 3 selected boys and girls away games.	
Support Services	X	School officials were alerted to the fact that the T-35 and T-36 forms should reflect expenditures from all sources including booster clubs. Booster clubs were discussed and the need for administrative involvement and control was emphasized.

5. Brief Summary/Analysis of the Corrective Action Plan (T-60)

The school's most recent Corrective Action Plan calls for improvements in the following areas: Publicity (local radio shows and policy for gym banners), facilities (additional locker and storage rooms), scheduling (increasing prime time games for girls), participation opportunities (expansion of girls volleyball and soccer programs), and coaching (employing additional assistant coaches in girls basketball).

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

The major deficiency observed was the school's failure to meet the standards of any of the opportunities tests. (See Comments section)

7. Facility Recommendations or Concerns

The major facility concerns discussed with those present were the need for improvements in the school's weight room and increased storage area.
