Equipment and Supplies	X		No major deficiencies were noted. However, it would be beneficial for school personnel to develop a written policy concerning the purchase of uniforms.
Scheduling of Games and Practice Time	X		All boys' and girls' basketball games are double headers. Some Friday night game times have been alternated.
Travel and Per Diem Allowances	X		No major deficiencies were found. However, the school should provide transportation to the park for softball and baseball practice and home games.

Locker Rooms, Practice and Competitive Facilities	X		Although no deficiencies were found overall, both boys' and girls' locker rooms are inadequate. There is only one locker room for all boys' sports and one locker room for all girls' sports. Also, only two small areas are provided for storage of equipment within the building.
			More storage room is desperately needed. The girls' softball field is also used by a men's softball league. Therefore, the outfield dimensions are not desirable for softball and should comply with National Federation Softball Rules. A temporary fence should be purchased for use during girls' softball games. There are no tennis courts for either boys' or girls' tennis teams and the teams must travel to Campbellsville to practice. The Gender Equity Review Committee should make this a priority in the 2002 Corrective Action Plan.

Support Services	X	No deficiencies were noted. One cheerleading squad cheers for both boys' and girls' basketball games. The existence of several booster clubs, each with their own financial account outside of school funds, could establish a situation that could create inequities in expenditures for the various teams. The current approach enables individual booster clubs to expend money independently and without regard to the welfare of the total athletics program. It is imperative that careful discussion be initiated to insure that policies and procedures are developed to improve the situation. The design of these measures must incorporate administrative oversight of all expenditures.

### 5. Brief Summary/Analysis of The Corrective Action Plan (T-60)

The major focus on the 1999-2000 and 2000-2001 Corrective Action Plan is in the area of accommodation of interests and abilities. As this report reveals, the school has accomplished this goal in a satisfactory manner. It is recommended that further endeavors be concentrated in the area of locker rooms, practice and competitive facilities.

### 6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

No major deficiencies were found. However, it is imperative that the Gender Equity Review Committee focus efforts on improving the girls' softball field including the addition of an outfield fence as well as providing additional locker rooms and storage space.

### 7. Facility Recommendations or Concerns

It is recommended that the Gender Equity Review Committee work with the school officials and the board of education in finding the necessary funds to build tennis courts, provide a temporary fence for the girls' softball field, and add additional locker rooms and storage space.
