Accommodation of Interests and Abilities	X		The proper method of calculation required for tests of student opportunities was discussed and explained to the school officials. The school will correct the data on the 1999-2000 and 2000-2001 opportunities tests. The school is requested to include in their April 15, 2002, Corrective Action Plan (T-60), their updated plan for pursuing the volleyball interest indicated on the 200-2001 student survey. The school was alerted to the fact that all team forms are to be filled out by coaches and submitted with school data in the future.	
Equipment and Supplies	X		School personnel were requested to look at the feasibility of developing a written uniform rotation plan. The school visit indicated that a very high quality of equipment and supplies is provided to students in an equitable manner.	
Scheduling of Games and Practice Time	X		Prime time scheduling was discussed with the school personnel. It was explained and emphasized that there was a definite need to move towards more prime time games for girls. The visit indicated that there is a very conscious effort to share existing facilities in an equitable manner, and with the completion of current construction projects, students will have increased benefits.	
Travel and Per Diem Allowances	X		Both the self-audit and the school visit indicate parity in this area.	
Coaching	X		It was emphasized during the meeting that all coaching salaries are to be included on future summary sheets.	
Locker Rooms, Practice and Competitive Facilities	X		The school visit showed that Henderson County provides several large, well kept, and updated lockers and dressing facilities. Also, almost all game facilities are of high quality and those that are currently shared are used in an equitable manner. There does seem to be one area with a disparity which involves the current existence of an off-campus softball facility with concerns

5. Brief Summary/Analysis of The Corrective Action Plan Form (T-60)

The current Corrective Action Plan calls for construction of a practice facilities for girls' and boys' basketball, a softball field on the campus, new tennis courts, and sufficient storage areas for all teams. The school seemed to be making progress in all of these areas.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

Two significant areas that need improvement were discussed during the school visit. The first was the need to have correct and complete self-audit documents in the school's permanent Title XI File. The second was the development of a more defined plan for the construction of a new softball field, which would include a projected completion date.

7. Facility Recommendations or Concerns

The school visit to Henderson County showed numerous high quality athletic facilities for the students. Once the Corrective Action is completed in the softball area it would appear that the school would be approaching equivalence in the benefits portion of Title IX compliance.

(Locker Rooms, Practice, and Competitive Facilities) The school is requested to submit, on or before, January 15, 2002, completed Forms T-35 and T-36 for the 1999-2000 school year which show total expenditures made in each sport offered.

(Selection of Cheerleaders) On or before April 15, 2002, the school is requested to provide information to the KHSAA concerning the manner in which cheerleaders are selected for boys' and girls' teams. If cheerleaders are selected in such a way as to result in arguably better (i.e. "A" team vs. "B" team) cheerleaders performing at boys' events, the school shall also submit a plan under which cheerleaders of equal ability shall perform at an equal number of boys' and girls' games in comparable sport (i.e., boys' varsity and girls' varsity basketball game).

(Prime Time Contest/Girls' Basketball) On or before April 15, 2002, the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and/or Saturday nights) for its girls' varsity basketball team during the 2001/2002 season. To the extent that a fewer percentage of girls' games are played during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference.
