Students Accommodation of Interests and Abilities	X		According to information submitted by the school, Lexington Christian Academy appears to have met the standard for Test T-3. The standards for each of the three opportunities tests were discussed in the Gender Equity Committee Meeting. The school's Permanent Title IX file was in good order. The committee meeting minutes will be included in the Permanent Title IX file. The school had an athletic handbook, and a coach's handbook. School athletic policies are included in these handbooks. The first on site visit by the KHSAA occurred in 2003. Since that time the KHSAA has requested schools to produce a number of policies for Title IX equity and school documentation. The need for these written policies was discussed with the school
Equipment and Supplies	X		Title IX Coordinator, the Athletic Director, and the Gender Equity Committee. Review of the uniforms showed equivalence for the male and female team uniforms. The school has a written uniform purchase/replacement policy, but it is no longer being followed. The teams now order uniforms whenever they want them and have funds to purchase them. The Athletic department and the Gender Equity Committee need to review the old policy and restructure it so that it can be followed. This is an area that inequity can quickly appear. Equipment was in excellent condition and equitable.
Scheduling of Games and Practice Time	Х		The school was in compliance for the 2006- 2007 school year with 50% of girls basketball games played on prime dates. The basketball teams rotate weekly use between two gymnasiums. The softball and baseball teams rotate use of the indoor batting cages. There are two practice soccer fields as well as the new game field. The school has written schedules of all facilities and teams. A copy of this schedule should be kept in the Permanent Title IX file.

Travel and Per Diem Allowances	X	The school does not have a travel and per diem policy. At this time, the football team, and both boys and girls basketball teams use buses. They rent church buses. The other teams rely on parental transportation. The cost of the bus rental was prohibitive for the sports that did not have large gate revenues. This benefit was discussed in the Gender Equity Committee Meeting and with the Title IX Coordinator and Athletic Director. This benefit is another area that can become inequitable quickly. The Gender Equity Committee needs to prepare a policy that covers travel and per diem expenditures.
Coaching	X	The importance of having female coaches for female athletes was discussed as well as an equitable coaching salary schedule during the Gender Equity Committee Meeting. Having coaches with experience is a benefit which was also discussed.
Locker Rooms, Practice and Competitive Facilities		At the present time the school has 4 locker rooms. The two used for the basketball teams are very nice and equitable. Great lockers and restroom/shower facilities. The other two locker rooms were not in good repair. The one used by the football and baseball teams is large with numerous lockers. The restroom is outside of the locker room. There were no showers, or water fountain inside the locker room. The other locker room, used for softball and middle school football, was smaller with foot lockers only. There was a girls' restroom connected to the locker room. Two storage rooms which held football equipment were also connected to this locker room. Even though neither locker room is near completion, it is evident the boys' locker room will be superior if construction continues at the present level. Consideration for equal amenities for the female athletes should be addressed now before construction is completed. The outdoor facilities are excellent. The tennis courts, the softball field, the practice soccer fields, the practice football field, and the practice softball/baseball field are in outstanding condition and well maintained.

Locker Rooms, Practice and Competitive Facilities Cont'd		They are equitable. At this time there are no restrooms at any of the fields. Either indoor school restrooms or port-a-pots are used. There are no water fountains available at any venue. Both softball and baseball have portable bleachers, and open score tables with roofs. Indoor facilities include two gymnasiums, one large for competitions, and a smaller one mainly for practices. The cafeteria can also be used for practices, and another area nearby has two indoor batting cages for use by the softball and baseball teams. The storage areas outside are pods for most teams, and the indoor storage is adequate.
		There was only one office for a coach and that was for football. Additional offices for coaches would be beneficial. The school had a master usage schedule that included all practices and competitions in all
		facilities.
Medical and Training Facilities and Services	X	There is a trainer on site daily for practices and competitions. The training room is well equipped. The weight room has numerous stations that can be used by both female and male athletes. There were few light weight bars, plates, and dumbbells. The weight room schedule was not posted.
Publicity	X	The Gender Equity Committee should revisit the school's award policy and include banner displays. The school has schedule cards for all sports, and programs for football, and boys and girls basketball. They have announcements for athletic events and at least three pep rallies a year that include all sports. The trophy cases are small and include the most recent trophies the teams have earned. With the success of the school's athletic programs additional trophy display areas are warranted.
Support Services	X	Lexington Christian Academy has one cheerleading squad that cheers for football home and district away games, boys and girls basketball home and district away games, volleyball district home games and some away games. The pep band, dance team, mascot, etc. should have a schedule that shows equivalent support for both boys and girls

Cont'd		 Each athlete at Lexington Christian must pay a once a year athletic fee which is \$150. This money goes to the athletic department for general funding, such as; salaries for the athletic director and trainer, field maintenance, and equipment maintenance. Each athlete must also pay a participation fee for each sport they wish to participate for. The fee amount varies for each sport. This money goes into the specific sport account. As does the gate receipts for the individual sports. The coaches' salaries as well as facility construction, equipment, travel, etc. comes out of the individual sports accounts. The coach makes a budget, including fundraising needs, then takes purchase requests to Athletic Finance Coordinator who checks budget and has Athletic Director sign off on it. Any fundraising activity must be approved by the Athletic Director, CFO, and Headmaster. Close monitoring of spending is necessary to insure equity.

10. Comments

Since the first KHSAA school visit, Lexington Christian Academy has added a number of outdoor facilities. They are all in excellent condition. Outdoor restrooms and available water should be a priority when money is available, although present facilities are equitable. The indoor facilities are in good condition, and when the additional locker rooms are completed will be excellent. The school has enough acreage for expansion in the future.

It is apparent that school personnel, students, and community support Lexington Christian Academy's athletic endeavors. They seem willing and eager to help the school maintain and improve the athletic opportunities and benefits for all athletes. The school was prepared with documentation, access to facilities, and help from school personnel for the KHSAA on site Revisit. In practice the athletic department appears to be succeeding in managing an equitable athletic program. For continued long range success, documentation is needed as reflected in the requests for written policies.

Travel and Per Diem Allowances

To ensure equality, all means of travel and accommodations must be approved by the Athletic Director in advance at each sports preseason budget meeting. Per Diem allowances are not to exceed \$10 per meal per student-athlete for any team.
