Comments: ALL DATA ON THE RE-VISIT REPORT RELATING TO THIS TEST WAS INCORRECT. THEREFORE, ANNUAL REPORTS WERE USED FOR THIS EVALUATION. According to data and calculations submitted by the school, it is currently meeting the standard established in Test 1 for provision of athletic opportunities.

Comments: DATA ON THE RE-VISIT REPORT IN RELATION TO TEST 2 WAS INCORRECT. THEREFORE, ANNUAL REPORTS WERE USED FOR THIS EVALUATION. According to data and calculations submitted by the school, it has not met the standard established in Test 2 for provision of athletic opportunities during any of the past three school years and is not currently meeting that standard.

C). Was the Full and Effective Accommodations of Interest and Abilities Test (T-3) an area in which the school met Title IX Opportunities compliance? Yes ⊠ No □

Comments: DATA ON THE RE-VISIT REPORT RELATING TO TEST 3 WAS INCORRECT. THEREFORE, ANNUAL REPORTS WERE USED FOR THIS EVALUATION. The data, calculations, and responses submitted by the school indicates that the standard established in Test 3 for provision of athletic opportunities has been met during two of the past three school years. With the addition of a girl's volleyball program, the school is likely to be meeting that standard currently.

Accommodation of Interests and Abilities	X		According to data, calculations, and responses submitted by the school, it is currently meeting the standard established in Test 1 for provision of athletic opportunities. With the addition of the girl's volleyball program in 2009-10, it is also likely meeting the standard established in Test 3 at this time. The school currently offers all KHSAA sanctioned sports for girls at the varsity level and a total of 16 team opportunities for females and 15 for male athletes. KHSAA representatives reviewed the school's Title IX file. It was found to contain the original audit report from April 5, 2001, all the annual reports to KHSAA for the past five years, a board approved salary schedule for coaches, sample game schedules for all school sponsored sports, a school generated athletics policy manual, a written facilities usage schedule for the soccer practice and football fields, written guidelines for athletic awards and trophy and banner display, written designation of athletic storage space assigned each team, written minutes for Gender Equity Review Committee meetings held during the past three years, a written uniform review, rotation, and/or replacement plan, and written guidelines relating to the provision of travel and per diem. School officials were commended for the development and maintenance of a comprehensive Title IX file.
Equipment and Supplies	X		THE DATA SUBMITTED ON THE RE-VISIT REPORT IN RELATION TO THIS CATEGORY WAS INCORRECT. THEREFORE, ANNUAL REPORTS WERE USED FOR THIS EVALUATION. All uniforms inspected during the recent visit appeared to be of high quality and provided on an equitable basis. The April 5, 2001 audit report rated this area as satisfactory, but it was recommended that a uniform review, rotation, and/or replacement plan be developed and implemented. The recent visit showed that a plan was in place which is based on a three-year replacement cycle. According to the school's 2009-10

Equipment and Supplies continued		annual report, it was spending approximately \$181 per female athlete compared to approximately \$242 per male athlete for provision of equipment and supplies.
Scheduling of Games and Practice Time	X	According to the re-visit report, the number of competitive events scheduled for "like" sports shows parity over a two-year period. The visit revealed that the scheduling of all shared practice facilities was equitable. According to 2009-10 results posted on the KHSAA web site, the girl's basketball team played 66% (6/9) of their home games on prime dates. A review of posted game times indicated that prime time standards were also being met.
Travel and Per Diem Allowances	X	DATA SUBMITTED ON THE RE-VISIT REPORT IN REGARD TO THIS CATEGORY WAS INCORRECT. THEREFORE, ANNUAL REPORTS WERE USED IN THIS EVALUATION. According to data submitted on the 2009-10 annual report, the school was spending approximately \$122 per female athlete compared to approximately \$91 per male athlete for the provision of travel and per diem. The school's Title IX file contained written guidelines for the provision of per diem which appeared equitable. Interviews with student athletes and coaches also indicated parity in this area.
Coaching	X	According to the 2009-10 annual report, the total amounts expended for coaches' salaries for "like" sports is comparable for both genders. A review of the school district's extra service pay schedule for coaches appears to show equivalence. The current salary allotted for the assistant volleyball coach seems low when compared to other sports. (See KHSAA Recommended Action.) Although there are some differences in the numbers of coaches provided for "like" sports compared to the number of teams involved (i.e. girls and boys basketball, girls and boys soccer, volleyball), the numbers appear to be equitable in their totality. According to the re-visit report, 44% (4/9) of the girls head coaches are on-campus

Locker Rooms, Practice and Competitive Facilities	X	The April 15, 2001 audit report found this category to be equivalent and rated the locker rooms and competitive facilities as excellent. The recent visit showed athletic venues that were well maintained and appointed. Unlike most schools, the girls and boys basketball teams use separate gyms. Both teams have exclusive locker rooms that appear equitable. Interviews with the girls basketball coach suggested that the girls team and staff were well satisfied with the facilities provided. Female athletes for all other sports have access to a locker room on campus. Both the boys and girls soccer teams' games are played at the football stadium. A practice field is also available for soccer. The softball field is located in a city complex approximately 2.5 miles from the school. Bus transportation is provided for team members. The softball field does provide amenities somewhat superior to those at the on-campus baseball field. These amenities include a practice field adjacent to the game field. All teams seem to have equitable athletic equipment storage space. A large indoor athletic facility at the Jockey Building provides an indoor track and practice areas for several sports.

Medical and	X	The April 5, 2001 report rated this category as
Training Facilities and Services		satisfactory but did request that an equitable usage schedule be developed and posted for the two weight training rooms. The recent visit showed that the school still has two weight training rooms. Weight Room #1 is located adjacent to the football dressing room and appears to have equipment suitable for use by that team. Weight Room #2 located adjacent to the school building has a significant amount of equipment suitable for use by female athletes. There was a sign up sheet available for both facilities, but no usage schedule showing equal accessibility for female athletes was shown. (See KHSAA Recommended Action.) The school currently does not provide the services of an athletic trainer.
Publicity	X	According to the re-visit report, the school was spending approximately \$26 per male athlete compared to approximately \$19 per female athlete for the provision of publicity, promotions, awards, and recognition. The school has two cheerleading squads (Blue and White) at this time. Both squads cheer at all home and away football games. The squads divide equally the number of home boy's and girl's basketball games. The school's pep band performs at all home football and boy's and girl's basketball games. The school's Title IX file contained written guidelines for the equitable provision of awards and recognition.
Support Services	X	This category was deemed satisfactory on the April 5, 2001 audit report which stated that only one booster club existed at that time. The recent visit revealed that one booster club still is functioning. The club deposits all its funds into school-based accounts and all purchases with these monies must be approved by the school's principal. A summary of the school's total athletic spending for a two-year period indicates that in 2008-09, 63% of the expenditures were for male athletes who made up 55% of the participants while 37% was for female athletes who represented 45% of the participants. That resulted in total spending of

Support Services continued		 approximately \$851 per male athlete and \$619 per female athlete. This difference shows a distinct advantage for male athletes. In 2009- 10, both the percentage and per athlete spending were within acceptable parameters for a football playing school.

The school's most recent Corrective Action plans call for the following:

- increased local media coverage of female sports; and
  the addition of volleyball teams at the freshman, junior varsity, and varsity levels.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

No major deficiencies were designated as a result of the recent school visit.

Although not currently rendered as deficient, there are some *areas of concern* that should be addressed for the school to maintain a non-deficient status. These include the following.

- There is a need to document the provision of equitable access for female athletes to a weight training facility.
- A review of the salary stipend allotted for the position of assistant volleyball coach is recommended in an attempt to insure equity with other sports.
- 7. KHSAA Recommended Action in relation to new deficiencies

No new deficiencies were designated by the recent school visit.

The following areas of concern should be addressed by school officials in a timely manner.

(COACHING) On or before <u>April 15, 2011</u>, the school should submit to KHSAA a written review and/or justification of the current salary supplement allotted for the assistant volleyball coach. This documentation should be signed by the school Title IX coordinator, the district Title IX coordinator, and the school principal.

(MEDICAL AND TRAINING FACILITIES AND SERVICES) On or before <u>April 15, 2011</u>, the school is to submit to KHSAA a written usage schedule for Weight Room #2 that shows equal accessibility for female athletes. This schedule should be placed in the school's Title IX file and also be posted at the appropriate facility.

8. KHSAA Recommended Action in relation to reoccurring deficiencies

No deficiencies were designated on the April 5, 2001 audit report.
