Comments: The 2010-2011 Annual Report showed that the girls at Menifee County had more participants than boys. The report indicated that 55.3% of the participation was female. This percentage is well above the percentage of female population which indicates that Menifee County is passing Test 1.

B). Was the History and Continuing Practice of Program Expansion Test (T-2) an area in which the school met Title IX Opportunities compliance? Yes □ No ⊠

Comments: The 2010-2011 Annual Report indicates that the current female participants added in the last five years is at 9%. This percentage is far below the 25% needed to pass Test 2.

Comments: Menifee County may or may not be passing Test 3. Not enough documentation to determine if the Gender Equity Review Committee is checking the actual interest shown on the Student Interest Surveys.

Comments: For several years the student interest surveys have shown an interest in volleyball. The Gender Equity Review Committee has been looking into the situation however; there is no documentation as to verify whether or not the interest is real and genuine.

| Accommodation of Interests and Abilities | | X | During the original audit in 2003 the school was deficient in this area because of a lack of effort to determine if the interest shown in volleyball was real and genuine. Since that time the student interest surveys have shown a continued interest in volleyball and only after a change in administration does their appear to be an initiative to see that the sport of volleyball is added to the sports offerings at Menifee County. After discussions with the new Athletic Director a plan is in place to address this issue. It is highly recommended that the Gender Equity Review Committee meet and put together a Corrective Action Plan that will show a step by step process to bring the school back into compliance in this area. A copy of this corrective action plan is to be included with the April 15, 2012 Annual Report. |
| Equipment and Supplies | X | | When comparing the uniforms of the various sports offered it was determined that all were of excellent quality and quantity. A 5 year uniform rotation plan is currently on file, but the Athletic Director did inform us that coaches were asking for a 3 year rotation. The Gender Equity Review Committee has plans to review and update the Uniform Rotation Plan and send a copy to the KHSAA with the April 15, 2012 Annual Report. Spending in the area of Equipment and Supplies is currently in the parameters of equality, but the Gender Equity Review Committee needs to monitor this spending. |
| Scheduling of Games and Practice Time | X | | Menifee County is currently in compliance with Prime Date scheduling with 57.1% of the girls games home games scheduled on prime dates. This past fall the boy's golf team played 17 matches compared to only 12 for the girl's golf team. The Gender Equity Review Committee needs to look at the schedules of all like sports to make sure they are getting the same equal opportunities. |

| Coaching | X | For the sports being offered by Menifee County there appears to be equity in quality of coaching in regard to number of coaches per sport and opportunities offered in each sport. A copy of the coaching salaries was present in the school's Title IX folder. Only two coaches are located on campus while others are located in other school buildings or work outside the school environment. |
| Locker Rooms, Practice and Competitive Facilities | X | At the present time only two dressing rooms are available to the athletes. The boys dressing room and girls dressing room are equal and are assigned to all the various sport teams. The schedule for the sharing of the gymnasium for girls and boys is kept in the schools Title IX file as well as being posted on the school's web page. Baseball and Softball play off campus at Menifee County Park and they have a contract to insure that the high school teams have the first right to scheduling of both softball and baseball games. It is recommended that the Gender Equity Review Committee travel to the site to observe the condition of both facilities and then to put together a plan that will keep these facilities safe and equitable for both teams. The soccer teams practice and play at nice soccer complex behind a local elementary school This facility is located approximately 10 miles from the high school campus. Both golf teams play at Carrington Greens Golf Course. The cross country teams practice on a very small course and all meets are away. The track and |

| | | field team has a very unique 300 Meter rubberized 3 lane track with venues for most of the field events. All track meets are scheduled away from home |

| Medical and Training Facilities and Services | Х | Athletic physicals are provided by local doctors in June, but many of the athletes choose to go to family doctors. No athletic training is provided for any of the student athletes at Menifee County. |
| | | There is no weight training room at this time but there are potential plans to include one in the new addition. Some free weights and universal equipment are in the corners of the two dressing room and it appears that boys and girls have equal access to the limited equipment. The Gender Equity Review Committee needs to start putting plans in place to make sure a new weight room is properly equipped for safety and female friendly with lighter weights and other accessories. |

The only storage space for various teams is the shower rooms in the two dressing rooms that have been converted into a storage area. Consideration should be given in the renovation for more athletic storage space. |
| | | The school has oversight of the Booster Clubs and they do have signed agreements. Menifee County is a non-football playing school with a large number of young female |
