Diem Allowances		travel is done by parent, coach, and/or school bus. There was no written evidence of a travel and/or per diem (food/housing) guideline. Auditors recommend that the policy must be applicable to all sports in order to insure equity.

		Interviews with administration also indicated that transportation is provided after school for those students going to softball, baseball, football, and weight room for practices and contests.
Coaching	X	According to the data submitted, 60% of the girls head coaches are employed on-campus while 67% of the boys head coaches are oncampus employees. Auditors recommend that an in depth review of this benefit be explored in order to insure equity among all sports. This should include, but not limited to, overall parity in coaching salaries, number of coaching positions and sports levels offered as well as evidence of equivalence in the ratio of coach to student access.

Locker Rooms, Practice and Competitive Facilities	X	The February 15, 2001 audit report indicated a slight advantage to the boys in regard to locker room space and no lights on the softball field. The recent visit showed that there are 2 locker rooms for boys and 2 locker rooms for girls and lights on the softball field. All available locker rooms appear to be equitable and with the same amenities. The current facilities appear to be very good. There are no lights on the soccer field which may limit opportunities for junior varsity play due to darkness setting in. There was no written evidence of a locker room assignment list and only partial written evidence for equitable use of practice and competitive facilities for all girls and boys sports. (see KHSAA recommendation 5.)

Medical and Training Facilities and Services	X	The February 15, 2001 audit report indicated a deficiency in this area due to lack of trainer services. Currently, the school has a contract with UK Sports Medicine where an Athletic Trainer comes to the school on Tuesdays at 4:30 pm to service athletes, as well as offering a drop-in service for athletes to the Athletic Clinic on a daily and weekend basis. The school has 1 weight room, located adjacent to the school and in close proximity to practice and competitive facilities. The weight room is used by both females and males and written evidence of a posted schedule showed equitable use by both genders. The weight room is an ideal model of organization, accessibility for all students, and is very well equipped to meet the physical needs of females and males. Interviews with administration indicated that athletic physicals are provided by area physicians at a reduced cost to the students. Opportunities for physicals are scheduled twice a year.
Publicity	X	According to the re-visit report, the school currently has one cheerleading squad that cheers at all home and away football games and all home girls and boys' basketball games. The pep band performs at all home contests for football, girls and boys basketball. It appears that the financial data submitted on the Title IX Re-Visit form was not valid for this area. For the purposes of this review, data from the 2010 Annual Report will be used for evaluation. The audit team recommends that an in depth review of the data for the 08-09 and 09-10 years be explored to validate the assurance of equity in this area in regard to the overall sports program. (see KHSAA recommendation 1.)

		Interviews with students and coaches indicated that team recognition takes place at the end of each team's season with banquets, school and team awards. There was no written evidence of an awards recognition guideline. (see KHSAA recommendation 6.)
Support Services	X	There are 2 boosters clubs, football and girl's soccer, that have bank accounts outside of the school. There was evidence of signed booster agreements. Interviews with administrators and coaches indicated that approval for expenditures by booster clubs are only required by booster members. It was emphasized to school administrators that the monitoring and oversight of all expenditures is necessary to insure equity. (see KHSAA recommendation 7.) Coaches interviewed were well aware of the process and procedure for approval and purchasing. It appears that office space was available for girl's basketball, boys basketball, and football only. (see KHSAA recommendation 8.) Interviews with students and coaches indicated that some teams collect 'fees' from students. Compliance and equity is important in regard to what and how the 'fee' is used by the team. (see KHSAA recommendation 9.)

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

There are no observed deficiencies noted in the overall girls and boys programs.

7. KHSAA Recommended Action in relation to new deficiencies

Although there are no deficiencies, the following recommendations should be addressed by the school in order to insure consistent and equitable benefits:

- 1. The school is to do an in depth review of the financial expenditures in the areas of equipment/supplies, travel/per diem, and awards for the school years, 2008-2009 and 2009-2010. This information should be reviewed by the Gender Equity Committee and evaluated based on overall expenditures, percentage of expenditures for each gender, and expenditures per athlete in order to validate the assurance of equity for the overall sports program.
- Submit to the KHSAA, no later than May 16, 2011, written evidence of practice and/or game time schedule use for those facilities that are shared that shows equity of use between genders.
- 3. Submit to the KHSAA, no later than May 16, 2011, written evidence of travel and per/diem (food/housing) guideline that would insure equity for all sports.
- 4. Submit to the KHSAA, no later than May 16, 2011, a review and/or explanation of the amount of various stipends given for head coach and assistant positions, specific, but not limited to, volleyball, girl's soccer, boy's soccer, football and basketball.
- 5. Submit to the KHSAA, no later than May 16, 2011, written evidence of locker room assignment for all sports, and evidence of usage schedule for those practice and competitive facilities that are shared.
- 6. Submit to the KHSAA, no later than May 16, 2011, written evidence of an awards recognition and banner display guideline that insures equity for all sports.

- 7. Submit to the KHSAA, no later than May 16, 2011, written evidence of booster club agreement that includes process and procedure for expenditures that meet the Financial Redbook Guidelines with administrative oversight.
- 8. Submit to the KHSAA, no later than May 16, 2011, written evidence of office space assignment for all sports.
- 9. Submit to the KHSAA, no later than May 16, 2011, a listing of teams that collect fees from students, the dollar amount of the fee, and what the student receives for that fee.
- 10. Attendance to a Title IX Workshop in 2011. The schedule and information for registration will be sent out by the KHSAA in early August. A copy of the attendance certificate should be sent to the KHSAA following the workshop.
