The school needs to set a more realistic date for the addition of girls' volleyball. The addition of volleyball would help the school to move towards compliance with one or more of the opportunities tests. It is recommended that a participation opportunity for girls be added such as volleyball prior to the addition of football.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

There is a lack of a certified trainer for some sports. The spending policies for boys and girls programs need to be reviewed and evaluated.
