A). Was the Substantial Proportionality Test (T-1) an area in which the school met Title IX Opportunities compliance? Yes  No

Comments: Upon review of the prior three years' annual reports, auditors determined that it appeared the school had not been reporting their calculations of the double and triple count of participants correctly. According to the data submitted on the 2004-2005 annual report, it appeared the school met the standard for Test One. The data submitted for the annual reports for 2005-2007 indicated that it did not appear the standard was met for Test One for both years.

B). Was the History and Continuing Practice of Program Expansion Test (T-2) an area in which the school met Title IX Opportunities compliance?

Comments:

Upon review of the annual reports for the previous three years it is was clear to auditors that the school is not reporting the calculations correctly for this component to be measured.

Beginning with the 2004-2005 report the calculations were not correct in Column 5 (Percent of Total Participation by Sex Added in the Last 5 years). The 2005-2006 report indicated that the school actually had one fewer team than it had the prior year. The data from 2005-06 indicated that of the 31 female participants, 20 had been added since the beginning of the 2001-2002 school year. When reviewing this data with the Gender Equity Committee school officials stated that this data could not have been accurate. The 2006-2007 annual report data indicated the school offered one more sport than the previous year. The data indicated that of the 43 participants, 33 had been added since the beginning of the 2001-2002 school years. Once again school officials indicated that this could not have been accurate.

Auditors explained to school personnel how to accurately double and triple count athletes and explained how participants should be accurately counted for the number of participants added.

3. Is the school's most recent Student Interest Survey accurate in relation to the assessment of Interests & Abilities?

Comments:

In the student interest survey given in 2005-2006, the total return rate was 29% of the student body of Shawnee High School. Auditors found another student interest survey in the school file for that same time period. That survey indicated a 82% return rate. It is not clear whether the survey had been redone or inaccurate results submitted the first time by the school. The Status report submission sent to the school for that year stated that the school should examine the method by which students were surveyed, indicating they had submitted a survey with a 29% return rate. School personnel could not determine which survey was correct. If the survey was redone and resubmitted, there is no evidence that school used the data from the second survey to determine whether there was sufficient interest to form another viable team. The second survey showed that there could possibly be interest in a variety of sports offerings for girls and boys. The school had no documentation that supported it had investigated the possibility of adding additional sports based on these survey results.

Accommodation of Interests and Abilities		<b>X</b>	<p>Based on the results of the data submitted, and interviews of school officials, it is the opinion of the auditors that the school has not been correctly submitting the data required to determine if the school is meeting the standard for Test One and Test Two. In addition, the school has not properly surveyed students to ascertain whether there is viable interest to begin other sports programs. The 2004-2005 re-visit audit report noted that the greatest deficiency in the overall boys' athletic program and girls' was the lack of participation. The school had been asked to research why the participation of female athletes lagged behind that of the males at Shawnee High School by the auditors who reviewed their yearly reports. Subsequent annual reports did not indicate this as a priority on the schools corrective action plan.</p> <p>It should be noted that the school has had a frequent turnover in those persons whose responsibility it is to complete these reports. The school did send its new athletic director to attend training so that reports could be completed more accurately. Auditors did find evidence from the minutes of a prior meeting of the Gender Equity Review Committee conducted this school year showing that this issue was being addressed by the committee. The committee is in the process of researching ways in which they can promote participation.</p>
Equipment and Supplies	<b>X</b>		<p>The few uniforms viewed during the re-visit indicated equivalence but all were not available. The school has a written uniform rotation policy, but it was clear to auditors based on interviews with coaches, and school personnel that the policy is not followed. (See KHSAA recommended Action)</p> <p>There is storage space available for equipment by all sports at the school. There is limited equipment for all sports. A volleyball team was added this past year, but did not have adequate equipment to play home matches. School officials were in the process of completing a thorough inventory of athletic</p>

Equipment and Supplies Cont'd.			uniforms. Auditors suggested that an inventory of equipment would also help school officials determine if there were other inequities. Coaches indicated there were equipment needs which hindered the ability to attract student participation.
Scheduling of Games and Practice Time	X		All shared athletic facilities appeared to be used equally. The school's 2007-2008 schedules indicated the school met its prime date requirement.  The school did not have a schedule for the use of its weight facility. It appears students have equal access to the facility, based on the interviews with coaches, students, and school personnel. (See KHSAA recommendation)
Travel and Per Diem Allowances	X		The school does not have a written Travel and Per-Diem Policy. Currently meals are not provided by the school for athletic contests. The school does not provide for overnight travel and the school does not pay for cost associated with trips.  Auditors did recommend that the school have guidelines in place in the event that the circumstances changed in regard to travel.  (See KHSAA recommendation)
Coaching	X		Shawnee High School has several female coaches who are not employed on campus. School officials indicated that securing coaches for male and female sports teams who taught in the building had been difficult. It appeared that even though the girls' coaches were not all employed on campus, student athletes did have access to them. These coaches were provided with on campus office space.

Locker Rooms, Practice and Competitive Facilities	X	<p>The 2004-2005 revisit audit indicated that there were inequities in size and amenities of locker rooms for boys' and girls' basketball. While touring the facilities, auditors did find evidence that this problem would be resolved. The school is in the process of upgrading a locker room for girls' basketball that will be equivalent to the boys' basketball locker room.</p> <p>Student athletes interviewed expressed concerns that the gymnasium needed some repairs, citing a leaking roof, etc. that would deter students from participating in sports which would use that facility. Coaches and school officials expressed the need to upgrade the track facility, once again indicating that a better facility could perhaps entice more athletes to participate.</p>
Medical and Training Facilities and Services	X	<p>The school does not employ a full time trainer and there is no medical training room on campus. There was no posted weight room schedule and the weight facility is in need of some general maintenance so that student athletes and coaches will want to utilize this facility.</p> <p>(See KHSAA Recommended Action)</p>
Publicity	X	<p>This was an area of concern in the previous revisit audit. Student athletes interviewed felt that they had little support in the community. The school does not have athletic programs and there are only a few publicity items used that promote the schools athletic programs. The Gender Equity Committee was encouraged to find ways to recognize the student athletes at Shawnee High School and to solicit more community support and involvement.</p> <p>The school was asked to submit a policy for awards, pictures, and banners in the 2004 revisit audit. There is no evidence that these policies have been developed. (See KHSAA Recommendation)</p>

5. Brief Summary/Analysis of the Corrective Action Plan (Form T-60)

The Corrective Action Plans written by Shawnee High School have resulted in the following completed actions:

- Renovation of girls' basketball locker room
- Addition of girls volleyball and softball to increase participation

NOTE: Many items written on the corrective action plans had not been completed.

6. Observed Deficiencies in Overall Girls and Boys Athletics

Shawnee High School has some unique challenges facing its athletic programs. For a school with an enrollment of 450 to 500 students, it has a limited number of athletic participants in both boys' and girls' programs. School officials indicated that it's very difficult to get students to participate due to the various socio-economic concerns of its student population. With facilities that are in need of maintenance and repair, the lack of quality equipment, and the lack of publicity and support for its student athletes, it will be difficult to recruit more participants. These are, however, areas that can and should be addressed by the Gender Equity Committee.

Some of these items had been recommended on the past Corrective Action Plans, but there was no evidence found that there had been steps taken to find possible solutions to these problems. The addition of parents and students to the committee was recommended. Another recommendation was to hold these meetings at a time when all parties could attend.

It is impossible to determine whether there is equity in spending due to the inaccurate reporting of expenditures for the past three years. The bookkeeper of Shawnee High School was in attendance at the Gender Equity Committee meeting held during the visit. She indicated that the funds reported could not be accurate and that she had not been consulted in the completion of this information. The current athletic director, bookkeeper, and principal all indicated to auditors that as a result of the information given by auditors during the meeting, they had a clearer understanding of how expenditures should be reported. The bookkeeper told auditors that she would work closely with the Athletic Director and Principal in completing the reports for the April 15, 2008 annual report.

7. KHSAA recommendation action in relation to new deficiencies.

Continue to work closely with the KHSAA to ensure that the annual audit reports are completed in an accurate manner. The school has already sent its Athletic Director to training; however, in the event that once again there is a turnover in the person responsible for completing these reports, the school should make sure that person attends the KHSAA sponsored training for Title IX Compliance.

The following actions are recommended to be taken by school officials.

1. Submit to the KSHAA, no later than **June 1, 2008**, a written policy for travel and per-diem.
2. Post a weight room schedule and make copies available to all coaches and to the KHSAA by **June 1, 2008**.
3. Develop a written athletic award policy so that it is inclusive for all types of awards (including banners) and recognition given by the school. Submit to the KHSAA by June 1<sup>st</sup>.
4. Revise and develop a new uniform rotation policy based on the current inventories and needs of sports teams. Submit such policy to the KHSAA by June 1<sup>st</sup>, 2008.
5. Submit minutes of Gender Equity Committee meetings to the KHSAA for the next two years with the annual report forms due on April 15th.

6. Add parents to the Gender Equity Review Committee and hold meetings at times that are most convenient for parent involvement.







School officials indicated that securing coaches for male and female sports teams who taught in the building had been difficult. It appeared that even though the girls' coaches were not all employed on campus, student athletes did have access to them. These coaches were provided with on campus office space.

Comments: Upon review of the prior three years' annual reports, auditors determined that it appeared the school had not been reporting their calculations of the double and triple count of participants correctly. According to the data submitted on the 2004-2005 annual report, it appeared the school met the standard for Test One. The data submitted for the annual reports for 2005-2007 indicated that it did not appear the standard was met for Test One for both years.

B). Was the History and Continuing Practice of Program Expansion Test (T-2) an area in which the school met Title IX Opportunities compliance? Yes  No

Comments:

Upon review of the annual reports for the previous three years it is was clear to auditors that the school is not reporting the calculations correctly for this component to be measured.


Beginning with the 2004-2005 report the calculations were not correct in Column 5 (Percent of Total Participation by Sex Added in the Last 5 years). The 2005-2006 report indicated that the school actually had one fewer team than it had the prior year. The data from 2005-06 indicated that of the 31 female participants, 20 had been added since the beginning of the 2001-2002 school year. When reviewing this data with the Gender Equity Committee school officials stated that this data could not have been accurate. The 2006-2007 annual report data indicated the school offered one more sport than the previous year. The data indicated that of the 43 participants, 33 had been added since the beginning of the 2001-2002 school years. Once again school officials indicated that this could not have been accurate.

Auditors explained to school personnel how to accurately double and triple count athletes and explained how participants should be accurately counted for the number of participants added.

The AD will advise the golf coach to hold a meeting. The AD is also contacting other schools in regards to having an ESL soccer team for next year. Still currently trying to find a coach.*

## Title IX Meeting Minutes February 27, 2008

Members present: Mernia Hill, Toska Adams, Sheniqua Murry, Shirley Gray, and Tonda Wickliffe

Meeting was called to order by Toska Adams @9:15 am.

Toska pasted out the Title IX Committee Members folders as well as an agenda, and student's participation sheet.

Toska reviewed the Gender Equity Review Committee Members sheet written by Larry Boucher. She also pointed out the web pages where more information could be obtained.

Next she read the Impact of Title IX on Athletic Participation she so the group would understand the percentage of athlete that play both nationally and in Kentucky.

Next she passed out a sheet that showed by sport how many students Shawnee has participating in sports. Shawnee has 299 male students and 273 female students. 82 boys have participated in sports this year, and 62 female students. The ratio of students in sports at Shawnee is Boys 3.64 and girls 4.26. The ratio of coaches to athletes is Boys 5.85 and Girls 7.11. Dr. Hill said she new we had a problem with participation, but this was the first time she had actually seen numbers to support the information. Dr. Hill had already requested that Toska write a survey to give out to the students to find out why they are not participating in after school activities. Dr. Hill is looking into having a bus run late in the day for students who stay after school for after school activities.

Next Toska went over the Title IX Overview and the Step for Continuing Title IX Compliance.

Toska went over the list that is listed on Major Components of Title IX.

In their folders were the Athletic Booster Club Agreement and Accounting Procedures for Kentucky School Activity Funds. Toska then went over in great detail the Prime Time Rule. The final sheet the committee went over was the Tip Sheet.

General discussion about female athletic followed next. For 2008-2009 Volleyball uniforms will be purchased as well as a net system. Volleyball will also use the Big Gym for practice. The locker room for Volleyball will be the locker room that is currently being reinvaded. For Cross Country we need to put in a proposal to have the track widened to 9 lanes. While it will be hard to have done for Cross Country Practice, we may be able to have completed for Track. We decided to ask for this as our next Title IX project.

For Basketball, it was agreed that the girl's team would ride the team bus to every event. When the boys and girls play at the same place, both teams will ride together.

For Softball, we need a field here at Shawnee. We currently play all our home games at Central. The committee decided to put a softball field as second on the list.

Discussion was had about getting more kids involved. Toska told the committee about the questionnaire that will be handed out at the middle school.

The meeting adjourned at 10:20.

6. Observed Deficiencies in Overall Girls and Boys Athletics

Shawnee High School has some unique challenges facing its athletic programs. For a school with an enrollment of 450 to 500 students, it has a limited number of athletic participants in both boys' and girls' programs. School officials indicated that it's very difficult to get students to participate due to the various socio-economic concerns of its student population. With facilities that are in need of maintenance and repair, the lack of quality equipment, and the lack of publicity and support for its student athletes, it will be difficult to recruit more participants. These are, however, areas that can and should be addressed by the Gender Equity Committee.

Some of these items had been recommended on the past Corrective Action Plans, but there was no evidence found that there had been steps taken to find possible solutions to these problems. The addition of parents and students to the committee was recommended. Another recommendation was to hold these meetings at a time when all parties could attend.

It is impossible to determine whether there is equity in spending due to the inaccurate reporting of expenditures for the past three years. The bookkeeper of Shawnee High School was in attendance at the Gender Equity Committee meeting held during the visit. She indicated that the funds reported could not be accurate and that she had not been consulted in the completion of this information. The current athletic director, bookkeeper, and principal all indicated to auditors that as a result of the information given by auditors during the meeting, they had a clearer understanding of how expenditures should be reported. The bookkeeper told auditors that she would work closely with the Athletic Director and Principal in completing the reports for the April 15, 2008 annual report.

7. KHSAA recommendation action in relation to new deficiencies.

Continue to work closely with the KHSAA to ensure that the annual audit reports are completed in an accurate manner. The school has already sent its Athletic Director to training; however, in the event that once again there is a turnover in the person responsible for completing these reports, the school should make sure that person attends the KHSAA sponsored training for Title IX Compliance.

The following actions are recommended to be taken by school officials.

1. Submit to the KSHAA, no later than **June 1, 2008**, a written policy for travel and per-diem.
2. Post a weight room schedule and make copies available to all coaches and to the KHSAA by **June 1, 2008**.
3. Develop a written athletic award policy so that it is inclusive for all types of awards (including banners) and recognition given by the school. Submit to the KHSAA by June 1<sup>st</sup>.
4. Revise and develop a new uniform rotation policy based on the current inventories and needs of sports teams. Submit such policy to the KHSAA by June 1<sup>st</sup>, 2008.
5. Submit minutes of Gender Equity Committee meetings to the KHSAA for the next two years with the annual report forms due on April 15th.

6. Add parents to the Gender Equity Review Committee and hold meetings at times that are most convenient for parent involvement.

Students and Coaches will be allowed up to \$6.00 per person food allowance. The coach must submit to the AD a list of students and coaches that will take the trip, at least 1 week in advance of the trip. The AD will fill out an invoice and request a check from the book keeper. The check will be made out to the coach and given to the coach. It is up to the coach to cash the check. The coach must keep all receipts for the food purchased. These receipts and any change must be returned to the AD within 2 working days. If there is more then one trip planned in a week, the coach will not receive the 2<sup>nd</sup> check until the change and receipts from the first amount is turned in. If in advance the coach can arrange a place to eat, the check can be made out to the business. Again, a receipt must be turned in within 2 working days. If a tax exempt form is needed, that must be requested at the time of the check request. Any money spent over this amount can be paid out of fund raising money. If no fund raising money is available, it is up to the coach to be sure the students or coaches supply the additional funds.

**FOOD ALLOWANCE FOR TRIPS 90 MILES AND OVER (ONE WAY)**

Students and Coaches will be allowed up to \$12.00 per person food allowance. The coach must submit to the AD a list of students and coaches that will take the trip, at least 1 week in advance of the trip. The AD will fill out an invoice and request a check from the book keeper. The check will be made out to the coach and given to the coach. It is up to the coach to cash the check. The coach must keep all receipts for the food purchased. These receipts and any change must be returned to the AD within 2 working days. If there is more then one trip planned in a week, the coach will not receive the 2<sup>nd</sup> check until the change and receipts from the first amount is turned in. If in advance the coach can arrange a place to eat, the check can be made out to the business. Again, a receipt must be turned in within 2 working days. If a tax exempt form is needed, that must be requested at the time of the check request. Any money spent over this amount can be paid out of fund raising money. If no fund raising money is available, it is up to the coach to be sure the students or coaches supply the additional funds.

### **FOOD ALLOWANCE FOR OVERNIGHT TRIPS**

Students and Coaches will be allowed up to \$15.00 per person food allowance. The coach must submit to the AD a list of students and coaches that will take the trip, at least 1 week in advance of the trip. The AD will fill out an invoice and request a check from the book keeper. The check will be made out to the coach and given to the coach. It is up to the coach to cash the check. The coach must keep all receipts for the food purchased. These receipts and any change must be returned to the AD within 2 working days. If in advance the coach can arrange a place to eat, the check can be made out to the business. Again, a receipt must be turned in within 2 working days. If a tax exempt form is needed, that must be requested at the time of the check request. Any money spent over this amount can be paid out of fund raising money. If no fund raising money is available, it is up to the coach to be sure the students or coaches supply the additional funds.

### **OVERNIGHT TRIP EXPENSES (HOTELS, ENTERTAINMENT, ETC)**

All funds for overnight trips (except for food per-diem), must be raised by the coach and team. These funds can be paid by the students and/or coaches, or through fund raising. School budget money does not allow for these types of expenses.

### **TRAVEL REINBURSEMENT TRIPS OVER 30 MILES (ONE WAY) WITH BUS**

If a team is traveling over 30 miles (one way) by bus, one coach may drive his or her car. The coach must obtain the travel reimbursement form from the AD prior to the trip. The school will reimburse the coach the current JCPS per mile amount. The reimbursement form is to be completed monthly, and must be turned into the AD the last day of the month for reimbursement. Forms turned in late, will not be paid (these amounts have to be reported to the board monthly). The coach must have on file the car insurance form to be reimbursed.

### **TRAVEL REINBURSEMENT TRIPS UNDER 30 MILES (ONE WAY)**

If a small team of 8 students or less is traveling under 30 miles (one way) by car, up to two coaches may drive his or her car. The coach(es) must obtain the travel reimbursement form from the AD prior to the trip. The school will reimburse the coach(es) the current JCPS per mile amount. The reimbursement form is to be completed monthly, and must be turned into the AD the last day of the month for reimbursement. Forms turned in late, will not be paid (these amounts have to be reported to the board monthly). The coach(es) must have on file the car insurance form to be reimbursed. Trips made by teams via car must be pre-approved by the AD.
