At the present time Simon Kenton is meeting the standard established in Test 1. This is a test that compares the percentage of participation with the percentage of enrollment. The two percentages should be within 3% of each other.

Comments: Simon Kenton has offered the majority of the sanctioned KHSAA sporting opportunities from the beginning of the Title IX Program in 1999. Now that they have been offering all the sports and different levels of each they will need to continue to look at adding the new opportunities when the Student Interest Surveys indicate the need.

Comments: Simon Kenton has been very good at doing the Student Interest Surveys and following up to see if the interest shown is real and genuine. Documentation submitted indicates that the school is currently meeting the standard established in Test 3 for provision of athletic opportunities.

Comments: According to the documentation on the T-63 form in the 2011-2012 annual report, the school received an 83% completion rate on the most recent student athletic interest survey.

Accommodation of Interests and Abilities	Х	Simon Kenton High School has been surveying the student body properly. The student interest has indicated the school has successfully added the female and male sports as interest dictates.
Equipment and Supplies	X	Simon Kenton has had two previous Title IX school visits. The first in 2003 and the second in 2007 and this area was satisfactory both times. A Uniform Rotation Plan has been put in place by the Gender Equity Committee. The interviews showed that both coaches and student athletes know about the Uniform Rotation Plan and when they can expect new uniforms. The uniforms are of excellent quality and quantity.
Scheduling of Games and Practice Time	Х	This is an area that was satisfactory during the first two audits. There appears to be great corporation with the coaches in like sports and throughout the Simon Kenton Athletic Department. Practice schedules for shared facilities are in the Title IX file.
Travel and Per Diem Allowances	X	The first audit in 2003 deemed this benefit category to be satisfactory. The Gender Equity Committee was asked to develop a Travel and Per-Diem Policy that would cover all aspects of travel. In 2007 the school was again listed as satisfactory and the Travel and Per-Diem Policy was in place. At the time of this audit a very good Travel and Per-Diem policy is in place and in the schools' Title IX file.
Coaching	Х	Simon Kenton was satisfactory in this area at the time of the first audit in 2003. In 2007 the school was again satisfactory. Currently the school's athletic director is responsible for evaluating all head coaches. A written instrument which is consistent for all in the evaluation process.
Locker Rooms, Practice and Competitive Facilities	Х	The issue of Locker Rooms has changed since the last audit with the addition of the new field house. At the time of the first audit there were some issues with the baseball and softball fields. At the time of the second audit some plans had been drawn up and

		construction had begun on improvements to several venues. With the construction now complete at the softball field the only glaring difference is that of the scoreboard.
Medical and Training Facilities and Services	X	The first two audits showed the school to be satisfactory in this area. The 3002 school visit report noted the need to provide a weight training room that was accessible for females and contained equipment that was appropriate for female use. Since the 2007 Audit a major facilities improvement has taken place that included a new weight room in the Field House. A beautiful fully equipped training facility is now in place. Two massive rooms are set aside for weight training. When the Gender Equity Committee tours the facilities they need to looks at ways to make the area more female friendly, smaller belts, stretch bands, posters of male and females lifting posted, universal equipment, etc. A very nice Training Room is just off the weight rooms as well as an indoor practice area used by many of the sports. A usage schedule of the weight rooms and the indoor practice area should be posted at the facilities well as the hours and contact information for the trainer that is assigned to the school on a daily basis.
Publicity	X	The school was satisfactory in both of the previous audits. At the time of this audit the awards and banner policy is in place. This policy needs to be reviewed and expanded to address lettering and bars as well as athletic banquets. The school is doing a tremendous job of recognizing team and individual accomplishments.
Support Services	X	A cheerleading squad performs at all football games and all home boys and girls basketball games and appears to be equal. It appears that the school is doing a very good job with administrative oversight of athletic spending. The school's Title IX file should contain a written description of the requirements and stipulations pertaining to the athletic participation fee.
