Comments: St. Francis has passed the T-1 Test in the past but female participation is down slightly to 40%. The current female population is 47%. To be in compliant in this area the two percentages must be within 3% of each other.

Comments: At the present time St. Francis is doing a good job of offering opportunities for female student athletes. This is an area that will be tough to stay in compliance with as the female population varies from year to year. So many of the girls play multiple sports and new students have new athletic interests which affects sports offerings at St. Francis.

Comments: The school is in compliance in regard to Test 3.

Comments: St. Francis is a school with an enrollment of roughly 130 students and it is about an even number of boys and girls. The school does an excellent job in trying to meet the changing interests of the student body. With so many of the student athletes doing multiple sports it is tough to add new sports without affecting the ones already in progress.

Equipment and Supplies	X		The school was satisfactory in this area in 2003 when the school had their first Title IX Audit. The uniform are of very high quality and all the various sports offering had equal numbers. At the time of the first audit it was recommended that a Uniform Rotation Plan be put into place. One was present in the schools Title IX File but it is highly recommended that that the Gender Equity Review Committee take a look at the Rotation that is in place as there is no indication as to which year any sports team will receive new uniforms. A written policy in this area will help ensure that the present uniforms stay of excellent quality for the student athletes.
Scheduling of Games and Practice Time	Х		St. Francis was satisfactory during the time of the original audit and the current schedule meets all the KHSAA requirements for Prime Date scheduling. This is an area where the Gender Equity Review Committee must be aware every year as to the scheduling of not only basketball but all like sports. Practice schedules are in place for the like sports that must share facilities and things look good in this area. With the two gymnasiums now being used specific scheduling must be done to ensure equity for boys and girls.
Travel and Per Diem Allowances	X		At the time of the last audit in 2003 it was recommended that a Travel and Per-Diem Policy be developed. The school does have a policy that needs to be expanded. It is highly recommended that the Gender Equity Review Committee take a close look at the current policy and update it to cover all aspects of travel • School board policies in regard to travel • Site base policies in regard to travel • Method of travel to competitions • Method of travel to off campus practice • Travel distances

Coaching	X	The quality of coaches for all the sports offerings appears to be equal. A mixture of experience and youth in the coaching ranks makes it a good experience for all the young athletes. Some differences appear in coaching salaries that deal with extended days and years experience. The Gender Equity Review Committee needs to address the issue of differences in coaches salaries and make sure that the School Policy addresses the differences in each.
Locker Rooms, Practice and Competitive Facilities	X	There are no locker rooms at the St. Francis School. The school uses the Stephens Family Community Life Center for boys and girls basketball and they do have class rooms that they can use for dressing as well as small dressing rooms that they use as well. There are no athletic facilities on the campus as every venue they use is off campus and all appear to be equal.
Medical and Training Facilities and Services	X	During the original audit the school was asked to make the Weight Room more female friendly. This issue has been addressed and the school has a very nice weight room where all the boys and girls can receive some excellent training. The room has very good lighting and excellent training equipment. The student athletes have the opportunity to receive free athletic physicals at a regular scheduled yearly examination for all athletes.
Publicity	X	The school has some policies in place that address some areas of an Awards and Banners. The Gender Equity Review Committee needs to look at the current policy and make sure that it includes all aspects of Awards Letters, etc. for various sports Banquets for each sports and awards that will be
