Accommodation of Interests and Abilities	X		When the last survey is observed it appears that the school may not be in compliance, however when you tour Walton-Verona and feel the excitement of the students, the staff and the community you can tell that the new Sports Complex has the entire community ready to add sports that will improve what is already a sound Athletic Program.
Equipment and Supplies			A Uniform Replacement Policy is in place and the current selections of uniforms are both attractive and of high quality. The Gender Equity Committee needs to keep involved in yearly looking at and updating this policy if needed. At the time of this audit it appears that all of the teams have the equipment they need to perform. At the time of the last audit, January of 2002, there was a real shortage of storage for the various sports teams but with the Field House at the new Sports Complex this issue has been addressed.
Scheduling of Games and Practice Time	X		Walton-Verona has a practice rotation for the gymnasium in basketball and there appears to be no conflict. Prime Time scheduling is in good shape as the girls are playing 55% of there home games this year on prime dates. The Gender Equity Committee is reminded that checking this Prime Date Schedule is a task that must be reviewed yearly. The new sports complex has two practice soccer fields which eliminated the sharing of fields and practice time.
Travel and Per Diem Allowances	Х		The steps are in place for a Travel and Per Diem Policy but it needs to be completed. It is highly recommended that the Gender Equity Committee look at the current School Board Policy in regard to travel and add to it so that the new Travel and Per Diem Policy would include all areas of travel (housing, meals, etc.).
Coaching	Х		The quality of coaching for boys and girls is comparable and having a lady involved in each of the female sports is excellent. The pay scales are comparable to those of coaches at surrounding schools in the area.

Locker Rooms, Practice and Competitive Facilities	X	With the new field house having a large boys and girls dressing room the two dressing rooms in the gymnasium have received a tremendous break. The dressing rooms are equal for boys and girls. The new sports complex has a baseball field and a softball fields that are equal. It has two practice soccer field that are equal. It has five new tennis courts. A practice football field and a very nice football, soccer and track stadium. A new eight lane track that has a couple of field event issues. A new cross-country course has be laid out on the campus of the new Sports Complex. No lighting on any of the venues. The gymnasium is well kept and in good shape. The Gender Equity Committee needs to tour the facilities annually to assure that things stay comparable in all the areas that make up this section.
Medical and Training Facilities and Services	Х	Athletic Trainer is an aide in the school and is on campus for all home athletic events. The weight room is well maintained and has many weights and machines that are more than adequate for young ladies to use.
Publicity	X	The school has a banners and awards policy in place and the Gender Equity Committee needs to meet yearly and review and/or update to make sure that the total package is being equitable. Equal sports banquets are being provided for both boys and girls. The Public Address system at the school is used daily to promote not only the game times but the performances of the individuals involved.
Support Services	X	During the first audit the school was deficient in this area with two cheerleader squads with the boys receiving the top squad. Walton-Verona now has three levels of cheerleading (Varsity, Junior Varsity and Freshman) and they cheer for the same number of boys/girls games at each of the levels. The Gender Equity Committee needs to review this situation yearly. It is recommended that the Gender Equity Committee add a Booster Member to there committee so that this group can have a better understanding of Title IX and what roll the Boosters can play in the total program at Walton-Verona.

6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

At this time there are no deficiencies in the overall programs offered. Some areas need some attention and the Gender Equity Committee needs to continue to work together as a team to monitor all the components of Title IX to assure that the school is going in the right direction.

- The Gender Equity Committee needs to develop a Travel and Per-Diem Policy that covers all the aspects of teams traveling. A partial policy is in place that needs a new look to help Walton-Verona stay in compliance in this area. A copy of this new policy should be included with the **April 15, 2008** yearly report.
- The Gender Equity Committee needs to look every Spring at the make up of the committee to assure that a total overview of the Title IX Programs are being reviewed. It is recommended that a Booster member be added to this committee. All gender equity policies should be reviewed and/or updated at this overview meeting.
