For the school years of 2003-2004 and 2004-2005, it appears that Warren East High School has met the standard for compliance in the area of History and Continuing Practice of Program Expansion. The percentage of female participants added to the athletic program in the last five years exceeded the target of 25%; 28% for 2003-2004 and 27% for 2004-2005.

Full and Effective Accommodation of Interest and Abilities is likely an area of compliance for Warren East High School. Basketball, cross country, golf, soccer, softball, tennis, track, volleyball and a school district swimming team are offered for a female enrollment of approximately 400 students.

Accommodation of Interests and Abilities	X		As noted previously, the accommodation of interest and abilities is rated as satisfactory. Currently there are a total of fifteen teams at the varsity, junior varsity and freshman levels offered for female participants.	
Equipment and Supplies	X		A written plan for the purchase of uniforms of a six-year cycle is included in the school's Title IX documents. The participants of all teams are very well attired.	
Scheduling of Games and Practice Time	X		Facilities are shared equitably between girls' teams and boys' teams. For the 2005-2006 girls' basketball season, five of eleven home games (46%) are slated for a prime date. School personnel are encouraged to annually allow girls opportunities to play at least 40% of their home games on Friday, Saturday, or Sunday every season.	
Travel and Per Diem Allowances	X		Travel opportunities are provided for both male and female teams to tournaments.	
Coaching	X		A copy of the coaching supplements is kept in the school's Title IX file and pay for coaches of male and female teams is comparable. Adult females fill many of the coaching slots, for either head or assistant coach, for the girls' teams.	

Locker Rooms, Practice and Competitive Facilities	X	The facilities at Warren East High School are well maintained and are comparable for both genders. Since the original Title IX visit in January 2001, improvements were made to the athletic locker room used by the volleyball, girls' soccer and softball teams. The basketball locker rooms for girls' basketball and boys' basketball are equitable and well appointed. A locker room for girls' track and cross country has been added and adjacent to this area is a weight room that is used by track, cross country and soccer. The baseball field and softball field are similarly appointed and both teams use the concession stand & restrooms. An indoor hitting facility, constructed with booster and school funds, is equitably shared by both genders. The soccer field now has lights, concession stand and access to water. The floor in the gymnasium has been refinished. The Gender Equity Review Committee needs to develop a written policy that covers the display of awards, pictures, honors and trophies and submit a copy of that policy to the KHSAA by April 15, 2006. Overall, the locker room, practice and competitive facilities located at Warren East are in excellent condition and well equipped.
Medical and Training Facilities and Services	X	Training services are provided on a contract basis. Male and female teams equitably share the weight room
Publicity	X	There is one cheerleading squad and the group is assigned to athletic events for both boys' and girls' teams. Also, there is a pep band and dance teams that support the basketball teams. Seasonal scheduled cards and media guides are printed. It is noted that the basketball guides are reflective of a great sense of team pride.

Support Services	X	The booster groups associated with athletics at Warren East High School are active and very supportive of their respective teams. Well-defined procedures regarding the conduct of the booster clubs are on file with the school's Title IX documents. It appears that the groups are appropriately monitored and that there is administrative oversight to insure that fund raising and expenditures occur on an equitable

#### 10. Comments

Recently the Title IX documents were organized and expanded to provide a more comprehensive presentation reflective of the athletic program at Warren East High School. The Title IX file now includes locker room and storage assignments, weight room and other facilities use information, booster club procedures, criteria for awards and recognition, uniform rotation policy, coaching supplements, team schedules, copies of forms for student participation in athletics and minutes of the Gender Equity Review Committee meeting conducted on November 17, 2005. The Gender Equity Review Committee is active and includes three student representatives.

During the interview segment of the Title IX Revisit held on November 30, 2005, comments made by team members and coaches indicate there is a great deal of pride in the athletic program at Warren East High School. It is the opinion of those interviewed that the components of opportunities and benefits comprising Title IX are successfully implemented. Observations by the KHSAA Audit Team support the views expressed during the Revisit. Students and school personnel were complimentary of the efforts of the Athletic Director who is now in the second year of holding the position. School personnel and the community continue to support an equitable and positive athletic experience for all students attending Warren East High School.
