The following school personnel will become members of the Board of Control effective July 1, 1981. Mr. Eldon E. Davidson, Principal of Monticello Independent Schools, representing Section 6; and Mr. Robert L. Rogers, Principal of Ballard Memorial High School, representing Section 1.

Eldon E. Davidson was born at Carrie, Kentucky on April 26, 1923. He graduated from Hindman High School and is a Navy veteran of World War II. He graduated from Morehead University in 1950 and received his master's degree there in 1958. He did additional study at Murray University and Eastern University before receiving Rank I at Western Kentucky University.

Mr. Davidson did his first teaching at Wheelwright High School and taught at Cordia High School and Hindman High School before going to Jenkins High School as principal in 1961. In 1965 he was hired as principal of Monticello High School where he is still employed.

At present, Mr. Davidson is a member of the Board of Directors of the Kentucky Association of Secondary School Principals and is president of the Monticello Lion's Club.

Mr. Davidson is married to the former Betty Sue Ritchie and they have three children — Karen March, John Walter and Richie Lando.

Robert L. (Bob) Rogers, native of Hopkinsville, Kentucky; BS Bethel College, McKenzie, Tennessee, MA Austin Peay State University, Clarksville, Tennessee; Rank I Murray State University, Murray, Kentucky; Teacher and Coach Louisville Male High, 1966-67; Teacher and Coach Earlinton High School, 1967-69; Teacher and Coach Henderson City High School, 1969-71; Principal and Coach Earlinton High School, 1971-73; Assistant Principal Christian County High School, 1974-76; Principal Webster County High School, 1976-80; Principal Ballard County High School, 1980 to present; Member KASA, KASSP, NASSP.

Mr. Rogers is married to the former Gayle Renshaw of Crofton, Kentucky, and they have two children, Jeffrey age fourteen and Angela age twelve.

Officials and Coaches Organizations Established

The National Federation Council acted January 6 in New Orleans to establish national professional organizations for high school coaches and officials. Separate organizations for coaches and officials will be operative beginning with the 1981-82 school year and be named the

National Federation Interscholastic Coaches Association (NFICA) and National Federation Interscholastic Officials Association (NFIOA).

An ad hoc committee was appointed by the National Federation's Executive Committee to prepare recommendations for the initial organization of these two associations. Under the chairmanship of Herman L. "Bubba" Scott, executive director of the Alabama High School Athletic Association as well as the Alabama High School Coaches Association, the ad hoc committee submitted several recommendations which have subsequently been refined and approved for immediate implementation by the Executive Committee.

State Associations Involvement Significant

A fundamental principle underlying the establishment and continuity of the NFICA and the NFIOA is the direct administrative and cooperative involvement of state associations. Such participation by state associations should be a basic benefit to the high school coaching and officiating professions which cannot be realized by membership in any other professional organization. Although membership in each association will be on an individual basis, it will permit an individual to be part of a national organization which is an integral part of, rather than extraneous to, the national and state bodies actually having the responsibility and authority for the promulgation of playing rules and the administration of high school sports in the United States. The unmatched advantage accruing to individual coaches and officials because of this integral relationship will be the opportunity for professional growth while being represented through their own national professional organizations in providing meaningful input in a variety of ways to programs affecting them and administered by high school organizational sports authorities.

Purposes and Objectives Outlined

The NFICA and NFIOA will share common purposes and objectives in that basically the organizations will provide for professional growth of the individuals in their respective professions; provide services and enhance the image of interscholastic coaches and officials; provide for cooperation and development of prestige of their respective professions through the efforts and coordination of state high school associations; provide an effective system of communications in each state between individual sports officials and coaches, local and regional associations, state organizations and the National Federation; and advance and preserve the educational nature of interscholastic athletics for boys and girls in the curricula of schools.

Organizational Structure

Both the NFICA and NFIOA will be governed by their own separate board of directors made up of eight individuals, one from each of the eight geographical sections of the United States corresponding to the eight National Federation sections. Initially, the boards of directors will be nominated by state associations in those eight sections and selected by the National Federation Executive Committee. Special committees of active high school sports coaches and officials are to be selected by the NFICA and NFIOA boards to function in different areas such as membership, member services, publications, individual sports, awards and recognition, and other committees determined by the respective boards.

From the Commissioner's Office

Minutes of the Board Meeting

The Board of Control of the Kentucky High School Athletic Association met at the K.H.S.A.A. office on Thursday, April 16, 1981. The meeting was called to order by President Zeb Blankenship at 2:00 P.M. with Board members Charles D. Black, John Brock, Whaylon Coleman, Robie Harper, Alvis Johnson, Walter Pickett, Barney Thweatt and Fairce O. Woods; Commissioner Tom Mills, Brigid L. DeVries, Louis Stout and Billy V. Wise present. Conley Manning was present representing the State Department of Education. The invocation was given by Zeb Blankenship.

Whaylon Coleman moved, seconded by Alvis Johnson, that the minutes of the March meeting be approved. The motion carried unanimously.

Mr. Mills read the correspondence on the eligibility appeal case of Elizabeth Riggs who had been ruled ineligible under the provisions of By-Law 6, Section 1, Transfer Rule. After a lengthy discussion John Brock moved, seconded by Walter Pickett, that By-Law 6, Section 1, be waived and that she become immediately eligible at Male High School for athletic competition. The motion passed with a vote of 5-1-1.

Executive Assistant Billy V. Wise reported the attendance at the 1981 Boys' State Basketball Tournament as 112,856 with ticket sales of \$525,549.50. The estimated expenditures are \$128,186.23.

The Girls' State Basketball Tournament had an attendance of 25,592 and ticket sales of \$103,554.50 with expenditures of approximately \$47,759.50.

Mr. Mills read letters from Mr. Minter of the Lexington Center inviting the basketball tournament to Rupp Arena with rental fees quoted for the next three years. After a lengthy discussion Charles Black moved, seconded by John Brock, that based upon the financial success of the 1981 tournament, Rupp Arena be the designated site of the

GAME GUY AWARD

The Game Guy Trophy is annually awarded to a high school athlete in the State of Kentucky who has overcome a physical handicap and participated in high school athletics. Warren Phillips was the unanimous choice of the K.H.S.A.A. for the 1981 award.

Warren was born without a left hand as his arm runs only to the wrist. He is a senior with a 3.8 grade point average, member of the National Honor Society and was a three year varsity letter winner. Warren has started at defensive end for the past two years. He played a key role in Southern High School's victory over St. Xavier this past football season.

Warren was chosen as Mr. Trojan this year, which is the highest award that a student can receive at Southern High School.

Ath. Dir. Jim Watkins, Southern High School, states in his letter of recommendation that he feels that Warren has overcome a severe handicap and has insured his future due to hard work and dedication.

Boys' State Basketball Tournament for the years 1982 and 1983. The motion passed by a vote of 7-2.

After a discussion on the site for the girls' basketball tournament, Walter Pickett moved, seconded by Alvis Johnson, that the site for the Girls' State Basketball Tournament for the years 1982 and 1983 be Eastern Kentucky University, Richmond. The motion passed by a vote of 7-2.

Upon a motion by Whaylon Coleman, seconded by Fairce Woods and a unanimous vote of the Board the following changes in the 1981-82 basketball district alignment were approved:

Evangel High School from District 21 to District 24, Region 7

Ninth & O High School from District 22 to District 25

Kentucky Country Day School from District 26 to District 28

Lawrence County H.S. from District 57, Region 15, to District 64, Region 16

President Zeb Blankenship presented the Staff Committee report. He stated that it was the recommendation of the Committee that each member of the K.H.S.A.A. staff be granted a 9% increase in salary for the coming year. Barney Thweatt moved, seconded by Alvis Johnson, that the recommendation of the Staff Committee be accepted. The motion passed unanimously.

J. B. MANSFIELD AWARD

The J. B. Mansfield Award for girls was won by Laura Say of Marshall County High School, Benton, Kentucky. The annual award inaugurated by the Courier-Journal and Times is presented to the player in the K.H.S.A.A. Girls' State Basketball Tournament who excels in four areas: basketball ability, academic accomplishments, sportsmanship, and citizenship. The selection was made by a committee of school personnel from throughout the state.

TED SANFORD AWARD

To foster the ideals exemplified by Ted Sanford, former Commissioner of the Kentucky High School Athletic Association, the Courier-Journal and Times inaugurated the Ted Sanford Award to be given annually to a player in the K.H.S.A.A. Boys' State Basketball Tournament who excels in four areas: basketball ability, academic accomplishments, sportsmanship, and citizenship. This year a committee composed of school personnel from throughout the state selected Allen Feldhaus of Mason County High School, Maysville, Kentucky.

Mr. Mills presented a recommendation submitted by Board member J. D. Minnehan that based upon the increase in gate receipts from the 1981 Boys' and Girls' State Basketball Tournaments, the Board grant to the participating schools an additional \$200.00 for each game they played in the tournament. This, he explained, would help defray some of the expenses incurred by the participating schools. Robie Harper moved, seconded by Whaylon Coleman, that the recommendation be approved. The motion passed unanimously.

Mr. Mills presented a request from Prin. John Branson, Mason County High School, that By-Law 32 be waived to permit one of his students to participate in an all-star game prior to the closing of the school year. Following a discussion of the request, Charles Black moved, seconded by Walter Pickett, that the request be denied. The motion passed unanimously.

Fairce Woods moved, seconded by John Brock, that Zeb Blankenship and J. D. Minnehan be named Delegate and Alternate respectively to the forthcoming Annual Meeting of the National Federation. The motion passed unanimously.

Brigid DeVries reported on a survey suggested by

members of the Track Committee concerning the feasibility of continuing with the regionals and sectionals in the track program. After a discussion Barney Thweatt moved, seconded by John Brock, that the suggested survey be tabled. The motion carried unanimously.

Billy V. Wise reported on a request for an increase in game fees for varsity basketball officials. The suggested increases were (1) raise the fee from \$25.00 to \$30.00 and leave the mileage allowance the same or (2) increase mileage from 15¢ to 20¢ and leave the fee the same. Fairce Woods moved, seconded by Charles Black, that this request be tabled. The motion passed unanimously.

Fairce Woods moved, seconded by Charles Black, that the next meeting of the Board of Control be at Kenlake State Park, Aurora, Kentucky, July 24, 1981, at 9:00 A.M. The motion carried unanimously.

Fairce Woods moved, seconded by Walter Pickett, that all bills of the Association for the period beginning March 1, 1981, and ending March 31, 1981, be allowed. The motion carried unanimously.

There being no further business, Fairce Woods moved, seconded by Walter Pickett, that the meeting be adjourned. The motion carried unanimously.

1981 MOST VALUABLE PLAYER AWARDS

The Most Valuable Player Award is presented annually by the Lexington Herald. The recipient is determined by a vote of the coaches of the sixteen participating schools and a panel of sports reporters.

The Most Valuable Player Award for the 1981 Boys'

State Basketball Tournament was presented to Troy McKinley, Simon Kenton High School.

The Most Valuable Player Award for the 1981 Girls' State Basketball Tournament was presented to Lori Hines, Pulaski County High School.

1980-81 ANNUAL REPORT (Presented to Delegate Assembly)

Three hundred fourteen schools joined the Association for the 1980-81 school year. Twelve of these schools enroll girls only and ten have only boys. In 1979-80 there were 315 schools, in 1978-79 there were 315, in 1977-78 there were 313.

There were 202 schools involved in football. Classes A, AA, AAA and AAAA championship games were played at the Fairgrounds, Louisville. Attendance was approximately 11,500 and gross receipts were \$42,844.80. Expenses involved in conducting the state football playoffs were \$27,581.95. Interest and attendance at the regional and semi-final games continued to increase resulting in greater revenue for the schools involved.

In Cross Country 221 boys' teams entered twenty-two regional meets. One hundred fifty girls' teams entered all three classes in seventeen regions. The expenses incurred in sponsoring this sport were \$10,836.58 and the receipts were \$2,000.00. Classes A, AA and AAA were held in Lexington at the Kentucky Horse Park.

The Wrestling program is going forward at a rapid pace. There were sixty-eight schools in the eight regions with the winner and runner-up in each weight class advancing to the finals. The championship tournament was held at Atherton High School with receipts for the meet of \$8,019.50 and expenditures of approximately \$8,341.18.

In Swimming thirty-four girls' teams and thirty-five boys' teams competed for the championships. The meets were held at Eastern Kentucky University, Richmond, on February 27-28. The receipts were \$815.00 and the expenses were \$6,881.19.

There were nineteen schools with boys' Gymnastics teams and twenty-two with girls. There were two girls' regional meets held at Henry Clay High School and

Kentucky Country Day School, but there was not sufficient number of boy's teams to justify a regional. The state meets were held at Eastern Kentucky University, Richmond, on February 21. The receipts were \$534.00 and the expenses were \$2,444.26.

The approximate gross receipts from the boys' and girls' district basketball tournament were \$481,080.35 while the regional tournaments took in \$368,643.92, for a total of \$849,724.27. Attendance at the Boys' State Tournament was approximately 112,856 as compared to 85,360 for last year. The gross receipts this year for the tournament is estimated at \$525,549.50, with expenditures of approximately \$128,186.23.

Attendance at the Girls' State Basketball Tournament was 25,592. The gross receipts amounted to \$103,554.50 with expenditures of approximately \$47,759.50. A complete report will appear in the audit.

There were thirteen co-ed teams competing in the State Rifle Marksmanship Meet in Louisville. Expenses incurred were approximately \$550.00.

Approximately eighteen teams competed in the State Fencing Meet on April 4, 1981, at Atherton High School, Louisville.

The number of schools competing in Volleyball was sixty-four. The K.H.S.A.A. sanctioned tournament was held at Memorial Coliseum, Lexington, on October 24-25, 1980. Expenses incurred were \$8,005.95 with receipts of \$3,360.00.

In the other sports that are to follow 274 baseball teams will compete in fifty-nine districts and sixteen regions; 240 girls' and 233 boys' track teams will compete in twenty-four regions each; 159 girls' golf teams and 207 boys' teams will play in nineteen regions; 194 girls' tennis

teams and 189 boys' teams will play in eleven regions. State championship meets will be held in baseball at Fort Knox; Classes A, AA and AAA track at the University of Kentucky, Lexington; girls' golf at Elizabethtown Country Club, Elizabethtown; boys' golf at Anderson Golf Course, Fort Knox; tennis at the University of Kentucky, Lexington.

Registering with the Officials' Division of the Association are 1469 basketball officials, 730 football officials, 663 baseball officials, 66 wrestling, 35 volleyball, and 78 soccer officials. This is the first year for registering track officials and at this time we have 13 paid registrations; some are still incomplete. Assistant Commissioner Billy V. Wise conducted twelve clinics in football and sixteen in basketball for officials and coaches. Assistant Commissioner Louis Stout conducted twelve baseball clinics for officials and coaches throughout the state.

Five hundred sixty-seven football officials took the National Federation examination for advanced ratings and we now have 201 Approved officials and 339 Certified officials. Seven hundred thirty-two basketball officials took the test for higher rating and we have 316 Approved and 463 Certified basketball officials. One hundred sixty-six baseball officials took the test for higher rating and we now have 147 Approved and 92 Certified baseball officials. Ten wrestling officials took the test for higher rating and we now have 10 Approved and 6 Certified wrestling officials. Seven volleyball officials took the test for higher rating and all seven became Approved. Since this is only our second year of registration in volleyball, we have no Certified officials. There is no test for higher rating given at

this time for soccer officials.

The Board of Control, the Assistant Commissioners and I are grateful for the cooperation the superintendents, principals, athletic directors and coaches have given us in running the program for the Association.

Minutes of Annual Meeting

The Sixty-fifth Annual Meeting of the Kentucky High School Athletic Association was held at the office of the K.H.S.A.A., Lexington, on Friday morning, April 17, 1981. The invocation was given by Conley Manning.

President Zeb Blankenship called the meeting to order at 11:00 a.m. and asked Assistant Commissioner Billy V. Wise to call the roll. Fifty-seven elected delegates or alternates answered the roll call.

Commissioner Tom Mills then presented a report on the activities of the Association during the 1980-81 school year. W.P. Wheeler moved, seconded by Marshall Patterson, that the report be accepted. The motion carried unanimously. (The Commissioner's report is printed elsewhere in this issue of the "Athlete.")

President Blankenship stated that presentation of proposals was the next order of business.

Jim Pursitull moved, seconded by Denzil Halbert, that Proposal I be tabled. Proposal I reads as follows:

Superintendent Reed Conder, Marshall County Schools, proposed that Article IV, Section 2 (a), Representative, be changed to read as follows: "Each local Board of Education or the governing body of a private or parochial member school shall appoint one (1) representative for each member school within the school district or under their control to represent that school in the Association. Each school's representative shall have a weighted vote based on the average daily attendance in that school when his vote is cast in an election for membership to the Board of Control, for an election of a representative to the Delegate Assembly or all other matters including surveys or polls of the Representatives, that determine action or policy of the Association. The weight of the representative vote shall be calculated on the basis of one vote for each 100 students in average daily attendance or major portion thereof at that school. Only certified personnel employed by the local district, private or parochial school are eligible for appointment."

The motion carried by a majority vote.

Walter Pickett moved, seconded by Denval Barriger that Proposal II be adopted. Proposal II reads as follows:

Principal Walter Pickett, Valley High School, proposes that Article V, Representation, be changed to read as follows: "In the Annual Meeting of the Association the delegates shall consist of one representative from each tournament district of the state. The secretary of the Kentucky Coaches Association, the president of the Kentucky Girls' Sports Association and the president of the Kentucky High School Athletic Directors' Association shall be voting members of the Delegate Assembly. The representatives shall be the delegates to the next Annual Meeting immediately following their election, and shall there transact all business of the Annual Meeting. None but these delegates shall have the right to vote in the Annual Meeting. There shall be no vote by proxy."

The motion carried by a vote of 47-10.

W.P. Wheeler moved, seconded by Timothy Barrow, that Proposal III be adopted. Proposal III reads as follows:

The Board of Control of the K.H.S.A.A. proposed that By-Law 6, Section 1, Transfer Rule, be changed to read as follows: "Any student who represents a secondary school in a first team game in any sport after enrolling in the ninth grade and who changes schools shall be ineligible for thirty-six school weeks. If there is a corresponding change in the residence of the parents, divorce or death of one or both of the parents, the Commissioner may waive the penalty in any case where there is evident injustice."

The motion carried by a vote of 54-0.

Prin. A.K. Draut moved, seconded by Prin. Thomas McCarthy, that Proposal IV be adopted. Proposal IV reads as follows:

The Board of Control of the K.H.S.A.A. proposed that By-Law 32 be changed to read as follows: "A student who has represented a member school as a first team player in football or basketball shall not compete in an all-star or post-season game during the remainder of that academic school year unless it is sanctioned by the Board of Control. The penalty for violation shall be loss of eligibility in all sports for the remainder of that academic school year. A student who has been a first team player in football or basketball and has eligibility remaining in these sports shall not take part in an all-star or post-season game during the remainder of that academic year unless it is sanctioned by the Board of Control. The penalty shall be loss of eligibility for one year."

The motion carried by a vote of 42-14.

There being no further business, the meeting was adjourned by President Zeb Blankenship.

Services, Benefits and Recognition To Be Unmatched

An informational brochure listing all the details of professional services, individual member benefits, and awards and recognition programs will be made available in the near future to individual coaches and officials through state associations. Through the efforts and administration of the National Federation, the athletic administrators of the nation have been organized and provided services and benefits since 1977. Now there will be three separate national professional associations, one each for high school athletic administrators, sports officials and coaches. It is anticipated that these three organizations will enjoy many of the same services, benefits and awards recognition programs as well as other programs which are specifically designed for each group.

Professional services will include approximately ten issues per year of a monthly tabloid, **National Inter-scholastic Official** and **National Interscholastic Coach**, publications specifically prepared for each respective professional organization. Also, there will be clinics and regional conferences, films, audio and video tapes as well as instructional transparencies concerning officiating and coaching mechanics and techniques on National Federation sports rules. There will be opportunity to provide input into the development of national Federation sports rules through special committees and to obtain interpretations of playing rules from the only organization which promulgates the rules and has authority to provide official interpretations thereof. Reciprocity between states for the benefit of officials will be developed.

Individual benefits will include unmatched insurance programs including medical protection, accidental death and dismemberment protection, and individual liability insurance along with special term life and hospital helper insurance for members and their families. Also included among the benefits will be a nationwide relocation service through a full service real estate company, discount privileges on a variety of items including but not limited to car purchasing, car and truck rental, officiating and coaching equipment and uniforms, and travel and motel accommodations.

Award and recognition programs will include a national program to recognize outstanding coaches and officials in all sports, the development of a National High School Hall of Fame to include recognition of outstanding coaches and officials, and a special section in the **National High School Sports Record Book**, a National Federation publication, recognizing outstanding high school coaches and officials.

Various Memberships Available

Both the NFICA and NFIOA will include a regular membership category exclusively for active sports coaches and officials; an associate membership to anyone interested in high school sports; a patron membership available to institutions, organizations corporations and others interested in supporting high school coaching and officiating; and an honorary membership to be specifically granted by vote of the boards of directors of the NFICA and NFIOA to those individuals who have made exceptional contributions to high school sports coaching and officiating.
