Dear Athletic Directors & Coaches,

It was our privilege to host the 1st Region Baseball Tournament at Graves County High School this past week. The weather certainly made the week fluid, and I believe we saw some of the bite of the weather in our gate receipts; but, the play seemed to occur without incident, and I believe we had a very successful tournament. Though we could not provide the Brooks Stadium "aura", we hope that we were able to provide other amenities that made the tournament an enjoyable one. We certainly welcome your input on ways in which we can improve the tournament for you and your schools.

As you look at the financial report, you will notice a sharp decline in gate receipts this year (down \$2900 from last year & down \$4000 from 06). We certainly believe that losing the Memorial Day crowd, the rain throughout the day on Tuesday (having to change starting times, reschedule, etc.), first round games on a Wednesday night, and the consistent incorrect starting times in certain parts of the media all contributed to some of that.

We hope that we were good stewards of your financial trust. Umpire expenses were \$100 more than approved at the meeting, because I issued a \$25 mileage check for each official who had to come back and finish the game on Wednesday afternoon. We also had to pay for the regional champion trophy, even though we were told by the KHSAA that it would be provided free of charge. In all, however, we were able to cut over \$3500 in expenses from the '07 tournament. Even with the reduced revenue, the net profit was greater than the '07 tournament. We also deducted our allowance from the net profit rather than the gross receipts as had been done in '07.

Again, it was our pleasure to host the event, and we hope that you will want to come back to our facility in the future. Please contact me if I can be of further assistance for you.
