4. Music

- Can be CD or Ipod
- Make sure your music time is no more than 1.30 and overall routine 2.30.

5. Expensives

- Host School will be paid 15% after all expensives and also allowed to sell T-shirts.
- Host School will manage Concessions.
- Profit will be divided among participating schools after all expenses are paid and 15% to host school.
- Lafayette and Bryan Station offered to host the Region next year.

- Regional Manager will be paid \$100 as set by KHSAA and mileage.
- Judges will be paid mileage this year even if over the allotted number driving.
