

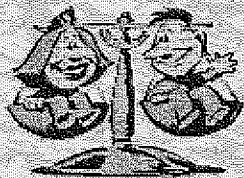

D.	✓	Other Recommendation and Comments. <ul style="list-style-type: none"> It is recommended that students be placed on the school's Gender Equity Review Committee, and that they be active members of the Committee. The enrollment on Form T-63 (519) is not the same on Form T-1 (294). The auditor is not clear on what enrollment is correct. School personnel need to check to significant difference in the figures and make the necessary corrections. The school's ability to pass Test 1 depends on accurate information regarding enrollment. The number of participants should be the same on Forms T-1, T-2 & T-4. The survey shows significant interest in volleyball. This interest was not noted on Form T-3, question #3. It appears, according to information provided, that the school is not in compliance with any of the three-prong test.
