These forms must be redone and resubmitted by July 15, 2003. • The big difference in head baseball/head softball salaries that may require some corrective action. We recommend that the school's Gender Equity Review Committee give a close look at this inequity. The KHSAA will continue to monitor this situation through 2003-2004.
