### **Budget Information on Facilities Improvements**

The Woodford County Board of Education pays for all facility improvements on a needs basis. Every year they pay thousands of dollars to maintain the softball, baseball, football, and soccer fields. This maintenance is in the form for grass seed, mowing, aerating, etc. The Board also pays for facility improvements on a needs basis. These items include things such as sealing the basketball floor and track and building storage areas at the sports facilities. All of these items are improved when needed. We may have large expenses one year and very few the next. Lastly, our board pays a rental fee for the exclusive use of the swimming pool at Fallings Springs for swim practices and meets.

## **Budget Explanation on Travel Expenditures**

The reason the girl's basketball travel expenditures where well over the budgeted amount was due to the fact that they played in the girls state basketball tournament last year. They traveled to Bowling Green lost in the first game and remained for the whole tournament which drove up their travel expenditures. The boys and girls swimming program also had expenditures well over their budgeted amount because they had to travel by bus to all of their practices as well as meets. We had no swimming complex in Versailles until this school. Next years title ix report will reflect less cost for travel in our swimming program. The last sport spending well over their budgeted amount for travel was the wrestling program. They compete in a major tournament yearly in Tennessee. Last year they chartered a bus to the trip, which cost much more then a school bus. Consequently, their costs were up. This year the wrestling program took a school bus, which will reduce costs for next years report.

# **Budget Explanation for Awards Expenditures**

A trend noticed when examining the awards expenditures was our total expenditures where much greater then our budgeted amount throughout the athletic program. The explanation for this is our coaches budgeted for their awards banquets and did not consider purchasing of trophies for district, regional, or WCI tournaments. In the final expenditures tournament trophies where included. We have hosted several district, regional, and sectional tournaments in the last few years.

## **Budget Explanation for Equipment Expenditures**

The reason for the baseball equipment expenditures being well over budget was the fact that they purchased \$3,000 worth of uniforms last year. It was the first time they have purchased uniforms in several years. It was also their turn on the purchase plan. The reason the girls soccer program had equipment expenditures well over budget was the fact that they purchased two sets of uniforms for \$9,000. It was also their turn on the purchase plan.

1. Create Trophy Cases for all Sports outside Gym and Cafeteria – The trophy cases have been built, painted and stocked with team trophies from all sports offered at Woodford County High School. Every program has equal space within the cases.

2. Uniform Purchase Rotation Policies – All programs have submitted in writing a rotation plan for purchasing uniforms. For example, the boys and girls basketball teams will never purchase during the same year and they will purchase one item at a time. For instance, the girls will only purchase one set of uniforms and then the boys the next year will only purchase one set. Then the girls will purchase warm-ups followed by the boys purchasing warm-ups the next year.

3. Field and Athletic Facility Coordinator – We are still hoping to hire a Coordinator or a District AD that would serve the same purpose for the 2003-2004 school year. The only item standing in the way is the budget shortfall from the state.
