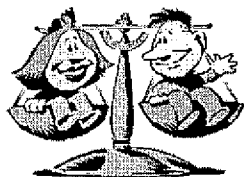

For a sport not currently offered, is there sufficient interest, based on your most recent Student Interest Survey, to form a viable interscholastic team based on student responses from the interscholastic survey? If yes, what sport?

Although 39 students participated in the intramural co-ed flag football season, 11 of them were girls. Of the remaining boys, many of them are already involved in a fall sport and would not be able to commit to both. There would not be sufficient interest to support an interscholastic football team.
