E.	X	Other Recommendation and Comments: According to data and information submitted, the school is meeting the standard established in Test 3 for provision of athletic opportunities. The most recent student athletic interest survey seems to support the responses given on Test 3. The school offers all sanctioned sports for girls at the varsity level and 19 total athletic teams for girls and the same number for boys. In the area of benefits, current athletic spending appears <i>not</i> to be within acceptable parameters. (i.e. \$862 per male athlete and \$724 per female athlete). This spending should be closely monitored by school officials to insure that the imbalance does not continue over a two-year period.
