E	X	 Other Recommendation and Comments: At the present time the school is passing all 3 tests but the Athletic Advisory Committee needs to keep an eye on things to assure that the school is passing at least one test per-year. The total number of athletes participating is down slightly so efforts may need to be put in place to get more of the student athletes involved. Since the school offers all KHSAA sports except Wrestling it is not likely that the school will pass the T-2 test much longer. The Athletic Advisory Committee (Gender Equity Committee) is required to meet at least three times a year. It is highly recommended that the committee meet at least once during each of the sports seasons (Fall/Winter/Spring) so that coaches and/or others concerned can have some input with Title IX concerns in their respective areas. Many schools find that it is necessary to meet more than

E. cont'd	three times per year. • The Athletic Advisory Committee needs to meet and discuss a situation before the start of the new school year. In all the boys sports that offer more than one level of competition (Varsity/Junior Varsity/Freshman) there is more than one coach involved to cover each of the various levels. This is very much a potential RED FLAG area when two of the girls sports (Soccer and Volleyball) have only
	one coach who is coaching two different levels of competition. This issue needs to be addressed as quickly as possible and the potential RED FLAG concern corrected before the start of the 2010-2011 school year. • The Athletic Advisory Committee needs to stay on top of the Award Policy issues as was addressed in your Corrective Action Plan. The current yearly report indicates that all sports but Track and Tennis received funds for awards from boosters. It is noted that Track and Tennis did receive funds from the school but nothing from the boosters. Is this normal school policy? • Copies of the new Awards Policy and the Uniform Rotation Plan are to be sent to the KHSAA when they are finalized by the new Athletic Advisory Committee. • The minutes of the Athletic Advisory Committee are excellent if continued, the school will have compiled an excellent history of what they are trying to do with the total running of the Berea High School Athletic Department. It appears that you have everybody on the committee and everything in general running in the right directions. Keep up the good work. • The Athletic Advisory Committee needs to take a serious look at the overall expenditures between boys and girls athletics. With the figures given in this report the school is pending \$563.58 per male athlete and \$438.52 per female athlete. This is a difference of \$125.06 per-athlete. When you are a football playing school these figures will never be equal but when the difference in spending per male athlete compared to per female athlete is more than \$100.00 per athlete a potential red goes up. It is highly recommend that you keep an eye on this and do everything possible to eliminate this potential for a Red Flag.

- 3) Calculate the percentage of total enrollment that is female. (Divide Row 1, Column 1 by Row 3, Column 1 and place in Row 1, Column 2.) Calculate the percentage of total enrollment that is male. Athletic Advisory (Gender Equality Review Committee) Meeting Minutes

Date: December 8, 2009

Attendees:

KHSAA members—Gordon Bocock and Reba Woodall BCHS members—Debbie Coleman (AD), Jackie Burnside, Donna Lovell, Lori Zastrow, Rachel Wilder, Jeremy Hamilton, Jerry Bingham, Casey Poynter, and Charlotte Isaacs

Minutes:

- All attendees completed Kentucky high School Athletic Association Title IX Audit Visit sheet for file; Debbie Coleman completed information as HS Title IX Coordinator and Donna Lovell completed information as District Title IX Coordinator.
- Mr. Bocock informed attendees why the meeting was being held (Parent awareness and rights were presented)
- KHSAA and Title IX history was presented by Mr. Bocock:
 - 1. 1972-title IX was created, giving girls equal rights
 - 2. 1996-KHSAA created a program to compare girls' and boys' athletics; to complete a comparison, KHSAA developed a 3 step phase:
 - Step 1—maintain self audit
 - Step 2—testing system (T1, T2, T3) in which Berea has pasted in the past T1-test for small schools

T2-test for schools adding programs to agenda (building programs—grown within past 5 years)

T3-Big schools which offers all sports offered by KHSAA

- 1. Step 3-membership visitation program
 - Berea's last audit was Oct. 2000 in which Berea was found to have 2 deficiencies:
 - 1. Locker room space for girls
 - 2. Medical training facilities

Today's Audit Findings (12/08/2009):

- 1. Opportunities:
 - Committee is composed of equal boy and girl representation
 - Three meetings per year are recommended to the Debbie Coleman, AD (1 Fall, 1 Winter, and 1 Spring); however, more than three meetings per year may be needed because of Mrs.
 Coleman being a new AD
 - Meeting prior to the Title IX report due date is a recommended choice
 - Minutes must be kept at all meetings and sent in by April 15th every year
 - Berea passed the T1 test this audit (Berea has passed this test for the past 3 years); Berea is required to be within a 3% difference between enrollment (49.1%) to participation (48.7%)[form T1—2008 to 2009 Title IX report]
 - Berea passed T2
 - Because this is a student survey year, Berea must see if students needs/desires match the sports offered at this school. As a school we must document all information collected while

making legitimate and logically sound attempts to collect said data. Committee must maintain cop0ies of all meeting invitations.

2. Areas of Concern

 Equipment and supplies—auditors did NOT see all equipment due to rain/time on site visit 12/08/09. However, uniforms appeared to be comparable, medium quality uniforms for all sports. This is acceptable.

Basketball—both boys' and girls' were of comparable quality; both had home and away versions

Soccer—girls' uniforms were deemed better due to extra warm up offered Track—both boys' and girls' were of comparable quality

Volleyball—only had one uniform; this is a concern of the auditing committee.

3. Auditor Recommendations

Uniforms

- Volleyball needs to have another set of uniforms—one for home and one for away
- Policy—uniform policy needs to be signed and dated to make official. It is in book, but not in the minutes or signed. This is for protection for both coaches and the AD. When signing this policy, Berea needs to be specific pertaining to wear and tear and concerning sports that may need uniform replacement more frequently than others.
- Overall, this audit was deemed satisfactory.

Schedules

- 56.4 % of Fri/Sat/Sun games on the schedule are assigned to girls' sports, which is a higher percentage since last audit. In 2000, Berea was asked to have at least 40% of their primetime games offered to girls' sports.
- The auditors suggest that a schedule with information on how each sport functions is added to the Title IX folder. This schedule must be in writing. This item has been added to the Corrective Action Plan (CAP)

<u>Travel</u>

- Travel was commensurate between sexes, and was deemed satisfactory during the 2000 audit.
- Findings: both the golf teams and football teams have their meals paid for by either the teams or boosters, which raises some concern.
- Auditor suggestions:
 - 1. Adding a policy to clarify how much money can/cannot be spent by team to pay for meal. If a per diem (meal money) is going to be permitted, the money spent per child must be in balance for both boys' and girls' sports.
 - 2. A policy should be set that details the amount of money to be spent on each child per game/season; this includes monitoring the booster spending
 - **Warning: ALL spending must be scrutinized because an imbalance can occur if one child has a per diem and another does not. Booster spending must be monitored to ensure honest reporting of expenditures.

Coaching

The 2000 audit resulted in having all coaching staff on school campus during school hours.

- Currently, 4 of the 9 coaches are females; however, two of these female coaches are not on campus during the school day
- Auditors suggest that a female should be involved with every sport that has a female athlete.
- Overall, the number of coaches of like sports (basketball/basketball, baseball/softball) are comparatively similar
- Problem area: volleyball only has one coach but runs both a varsity and a jv team. Therefore, the auditors recommended hiring another coach to assist with the girls.
- Auditors recommend that there should be one coach for every team (JV/varisity) for all sports
- The 2008-2009 Title IX report had a problem. The number of teams did not match the number of coaches. (Form T2 and Form T4 did not match)

Locker Rooms

- The 2000 audit found a deficiency in this area due to lack of lockers and storage for girls' sports.
- Today, Berea has 5 locker rooms, but all teams are not assigned to locker room and given
 equal storage and space for equipment, which should be written in the Title IX policy.
- Auditors recommendations:
 - 1. Each locker room receives a minor upgrade with paint and graphics.
 - 2. Committee complete a walk through to assess need
- Problem Area: Storage in the Gray Conkin Gym in minimal and currently presents a safety hazard due to the electronic equipment present.
- 2009 audit found NO deficiencies with the locker rooms.

Medical

- A deficiency exists in 2000 Title IX audit. Recommendations were made for all high risk sports
 to have a trainer present at events, a need for a training room existed (only one), and a weight
 room schedule should be posted at all times.
- 2009 audit—there is still NO schedule posted for the weight room and a trainer comes to the school only once a week with no one knowing where to find him/her.
- Recommendations made by auditors:
 - 1. Berea must have a trainer schedule posted (when and where)
 - 2. Soccer is a contact sport and needs a trainer to be present (NOT just football)
 - 3. Trainer needs a centralized location to see student athletes.
 - 4. School needs trainer to cover liability issues
 - 5. 2 sets of washers and dryers should be on campus for use by teams. However, it was mentioned that no team uses the washer and dryer currently on campus. The football team uses Mr. Hills FMD class to wash uniforms.
 - The weight is NOT female friendly. Females need lighter weight bars and properly fitting weight belts. Weight room also needs a set of light weight plates for females.

Publicity

- Cheerleaders are equitable; they cheer for football games, boys' and girls' basketball games.
- Dance team is also equitable across boys' and girls' games; as well as the PEP band
- The scheduling of boys' and girls' games looks good.
- Award money was spent on all sports should be better monitored (baseball received awards while softball did not)

- All coaches need to provide awards for all sports
- Committee should put an awards policy into place. The written policy should outline mandates for banquets, awards, and etc.
- There was NO REAL deficiency here; nonetheless, on e could arise if proper procedures are not followed.

Support Services

- Spending was acceptable in previous years. Berea is permitted to have a \$100 spending difference between boys and girls due to the football team. Previously, Berea was within \$50.
- Currently, there is a \$162 difference, with more spent on boys than girls.
- The problem appears to be the booster club spending. Berea MUST monitor booster club spending.
- Recommendations from the auditors were provided to the administration.

In conclusion, the auditors suggest that the committee review all policies. All policies should be signed and in writing. ***None of Berea's policies were signed and dated. If Berea is unsure of what policies to incorporate, borrow from other schools.

MUST CORRECT:

- Weight room needs to be updated
- Address a dressing room policy for both home and away teams
- Control boosters—suggest that ALL spending brought in-house.

AAC determined needs:

- AAC should look at budget rules to determine how money can or should be spent (Can students keep BOE purchased products—tshirts, warm-ups, etc)
- AAC should consider a 2 year rotation for outside sports (football, soccer, baseball); possibly purchasing ½ of the uniforms every 2 years. Question remains: will stock uniform still exist?
- AAC recommends purchasing stock uniforms only
- NOTE: AAC are unsure of how to assess need at this time!!!

Overall AAC impressions:

- Track and field has a major need with only 4 complete uniform sets, all different from each other.

 Mrs. Coleman explained that each child can be dressed in a track uniform for approximately \$28-30 each. All agreed this in first priority.
- Suggested that all coaches order 3-5 more uniforms per team than need requires
- All teams need both an away and a home uniform. Teams with only one uniform are priority number two.
- Outdoor sports need uniforms sooner than indoor sports
- · Clarify what school funds can be used to purchase
- Accountability for parents—formally invoice parents for lost or damaged uniforms?
- Athletics need a central storage facility for uniforms to be checked in and out. When checked back
 into the facility, either all of the uniforms should be present or money to compensate for the missing
 pieces
- Consider possibly narrowing the purchasing to 4-5 distributors to buy uniforms and buy in volume to save money.

AAC Guided Questions:

- If you had to say right now who is in the most need (based on those who have a uniform representation here today), which team(s) would you identify?
 - 1. Track with 6 votes, citing lack of uniforms
 - 2. Teams with only one uniform with 5 votes, citing Title IX audit recommendation
 - 3. Girls' MS Basketball Team with 1 vote, citing oldest uniform available
- The board is increasing the athletic budget by \$10,000. How does the committee purpose that the money be spent?
 - A. Distributed evenly to each team (0 votes)
 - B. Pool for uniform and use residual to distribute to every team evenly (4 votes)
 - C. Other (3 votes)
 - 1. Develop and allocation formula—allocate based on participation and need
 - 2. Consider common costs to consolidate money (example—weight room)
 - 3. Use to up-grade facilities

- Budget Meeting Packet was distributed prior to today's meeting with add-ins (December minutes and the volleyball inventory)
- Refer to complete Title IX audit; some red flags, but NO deficiencies
- Refer to locker room assignments (see changes/assignments on locker room assignments)
 - Locker need decoration
 - Possibly converting Brandle Davis' old office into a storage facility
 - Concern about soccer cleats on the Gary Conkin gym floor if locker room assigned in this location
 - Conflict between MS boys' soccer and MS football
 - Cheer needed to be added to the list of locker room assignments
- Request for agreement on the locker room assignments. Bruce Fraley agreed (1st), Jackie Burnside agreed (2nd); non committee nays.
- Locker room assignment will be taken to the Site Based Decision Making (SBDM)Council to approve as an official policy. Policy to take affect for the 2010-2011 year and last through the 2015-2016 year.
- Suggested by Jackie Burnside that the art club could paint a mural on the locker room walls
- Coach Jerry Bingham requests new carpet and lockers
- Committee could be looking at a 4500 sq. ft. building (\$70,000) to build an external locker room for athletes.
- Refer to spending report (Forms T71 and T72). There is a severe discrepancy between girls' and boys' basketball
- AAC agrees that a form should be filled out by each coach every year. Athletic Director refers AAC
 members to Form F-SA-15A and F-SA-15B (Annual Financial Report Summary). This form provides an
 excellent way of determining how much money is spent and made within a fiscal year.
- AAC recommends that ALL coaches are strongly requested to fill out two F-SA-15A/B (one for the BOE money and another for their sport's activity fund) by June 30; but, ALL coaches will be required to provide the F-SA-15A/B for the 2010-2011 seasons. A fiscal year begins on July 1 and ends on June 30.
 - Debbie Holbrook—access to BOE money and Purchase Orders (PO)
 - Ginger Cottrell or Kathy Ridge—access to activity funds and Pos
- Expenses are for high school only
- All coaches will receive a ledger to maintain throughout the year as a running document
- Refer to 2009-2010 Budget Allocation Report
 - General budget
 - -Big ticket items used by multiple sports, such as weight room
 - -Coaches' KHSAA memberships
 - -Medical kits with restock items
 - -Volleyball money (\$600.00)
 - -Association fees (11th region, Bluegrass Conference, etc.)
 - -New uniforms (1/2 cross Country, swim suit warm-ups, track and field, MS softball)

- Uniform costs depend upon the sport and number participating. Most teams can outfit their team for \$1500 to \$2000 per uniform.
- Board of Education approved an uniform rotation policy in 2005-2006, but it cannot be found in the books
- Next year's Athletic fund budget is increasing by \$10,000. Keep in mind that Berea spends \$2000 on line paint for soccer and football and has to pay for referees for all sports
- Before AAC can determine how to allocate this increase in the athletic fund, we must develop an uniform rotation policy
- Mrs. Coleman recommends that the bulk of the money can be used for the uniforms, while the rest
 would be placed in the general fund for future allocation. However, Mrs. Coleman is open to
 suggestions.
- Bruce Fraley suggests using a budget request form (officially designed)
- Uniform purchased during 2009-2010: ½ of the cross country uniforms, track and field team, and MS softball
- The athletic director request that the members of the AAC look at the possible uniform drafts that can be made. Keep in mind that the uniform rotation policy will cover the years through 2015-2016. The AAC only has \$10,000 to work with; however, no more than \$8000 should be allocated to pay for uniforms with a fiscal year.
- Each member is to work up a possible rough draft of the rotation policy and email to each other. This is to be completed by April 7th.
- AAC needs to be drafted and ready to take before the Board of Education OR the SBDM by the third Monday in May. Needs to be added to the agenda in April
- All emails have been submitted to the AAC secretary, which will be emailed to all AAC members.

The next AAC meeting will be emailed to each AAC member at a later date.
