- 4) Ask coaches to confirm the names of those individuals who are on the team as of the first **date of regular season competition**, and cross out the names of those who were cut from the team or quit the team prior to the first regular season competitive event. In order to determine the total number of athletics participants, an individual should be counted each time he or she participates on a team.
