

Replacement Jersey Policy

Determination of whether or not a jersey needs to be replaced shall be determined by the coaching staff after consultation with the Athletic Director. The expense of jersey replacement will be paid from the specific sport's school activity fund or booster organization affiliated with the specific program. Furthermore, the expense of the jersey replacement must recorded on the uniform allocations report by the Athletic Director.

Booster organizations and coaches cannot replace jerseys or uniform related apparel without the consent of the Athletic Director in order to ensure gender-equity is being met.

In addition, if Booster organizations or coaches wish to use jerseys or uniform related apparel as a gift at end of season events, the organization or coach must buy the jersey or apparel and NOT use the original jersey or apparel. The school district will not absorb the cost or approve the reimbursement of jerseys that were used for gifts or rewards for the student athletes.

This policy does not pertain to initial uniform purchases which must be approved by the Superintendent and Principal.
