Dear Mr. McKnight:

This letter is a follow-up on our visit to Breathitt County High School on October 19, 2005. It represents our analysis and findings and an outline of improvements necessary to bring the school into greater compliance with Title IX standards.

First of all, we commend you for the progress that has been made towards meeting these standards since our initial visit in 2001-2002. It is encouraging to see the strong support and active participation of your school's Gender Equity Review Committee. We appreciated the opportunity to meet with them during our visit. The general positive attitude and cooperative spirit displayed regarding gender equity is a compliment to both the school and community backers.

- I. Regarding the issue of volleyball and the location and quality of the practice and playing facilities, the following steps should be taken:
  - A. Equip the school's major basketball arena with a modern, up-to-date net system and schedule the use of the arena for the volleyball program. Use of the middle school's floor when the arena's heat index is a factor is certainly acceptable.
  - B. Locate a storage area for volleyball equipment and uniforms in the space adjacent to the volleyball/softball locker room in the main arena.
  - C. Refurbish the volleyball/softball locker room, using the quality of lockers, toilet stalls and showering facilities available for boys' basketball as a guide. Embellishment of the locker room should include: logos, paint the room using the school's colors, personalized locker designations (if desired by the coach), mottos or other inspirational/motivational slogans, and carpeting.

    NOTE: The quality of the girls' physical education locker room substantially exceeds that of the girls' locker room facilities in the main arena. If this is the same situation for the boys, then there would be no inequity involved.
  - D. Provide a space for the coach to confer with players and plan practices and match strategies. Equipment for use in planning, i.e. charts, bulletin boards, audio-visual components, chalk boards, is to be provided, in line with what is provided coaches of male sports.

Based on our understanding at the October 19<sup>th</sup> meeting, it is the intent of your school to accomplish all of the above suggestions we discussed and now documented in this letter. All of these improvements should be listed on Form T-60, Corrective Action Plan, as a part of your school's April 15, 2005-2006 Annual Title IX Report Submission, and all action taken for completion by **July 1, 2006**.

- II. Other policies in areas of your athletic program are needed for guidance in better assuring gender equity. Attention should be given to seeking input from coaches and the Gender Equity Review Committee in generating policy.

  Areas that must be covered are:
  - A. recognition and awards
  - B. meal service
  - C. uniform purchase rotation

A written copy of the above established policies should be forwarded to the KHSAA no later than **March 1**, **2006**.

III. The question of inequitable budgetary expenditures over a period of time has been addressed. In terms of the amount of money spent per athlete, in the past three (3) years, the disparity between males and female has been over \$100.00:

1. 2002-2003

\$214

2. 2003-2004

\$139

3. 2004-2005

\$171

While earlier budgetary variances and deficiencies we cited in our feedback to you were mathematically incorrect, it should be noted that a more acceptable target to seek would be under \$100. With facility improvements for volleyball the gap should narrow to some degree.

In addition, it should be noted that information was requested from school personnel regarding budget expenditures on an attachment to the 2004-2005 Annual Title IX Report. This has not been provided. Please review the "KHSAA Title IX Re-Visit Final Audit Report" for details and provide the information by **March 1, 2006.** 

IV. The school's permanent Title IX file is to be organized and the school's official Master Copy located in the principal's office. Organization of the file should include minutes of the Gender Equity Review Committee meetings, all reports and documentation related to Title IX compliance efforts, as well as any questions or complaints posed regarding gender equity. Previous resource materials we have provided you contain a more comprehensive listing of the required contents. For your information, the KHSAA maintains a complete Master File in our office of all submitted reports, correspondence and communication with your school and your efforts to comply with Title IX. Should you wish copies of that material please contact me (LBoucher@khsaa.org), or my assistant Fay Isaacs (fisaacs@khsaa.org), and we will provide you with material at 10 cents per copied page. Depending on the possible size of your Title IX Master File, it would generally not exceed approximately \$50.00 total cost.

We were particularly pleased to learn of the immediate plans you have for Title IX compliance, especially in the sport of Volleyball. Students in Mrs. Moore's Science classes have been preparing for their "Mission to Mars." In a unit on living organisms, students had an opportunity to utilize the greenhouse by planting a flower seed of their choice.

The band is very busy preparing to participate in the Heritage Parade and for their annual Christmas tour and concert. They have also begun a Jazz band.


ROTC is currently completing a unit on survival skills by building survival equipment. They used this equipment during a camping outing at Buckhorn Lake in September.

LBJ Elementary School has several new and exciting programs currently being implemented. These programs increase learning and achievement for our students.

First our new Attendance Incentive Program will help us reach our overall school wide goal of 95% or better attendance for the entire year. A drawing will be held for 2 student bicycles (one boy and one girl) every nine weeks. To be included in the drawing students must have not missed any days during the 9 week time period and have 2 or less tardies. There will also be an incentive for having good attendance all year for students who have 97% attendance (missing no more than 3 total days throughout the year with 3 tardies counting as an entire day). These rewards will help us reach the best attendance record ever!

Another innovative program, *Minds in Motion*, is a program designed to improve reading and learning through the use of *Balance Integration*, *Automaticity of reading and math skills*, and *Critical Vision Assessments*. Students and staff are training to complete the maze course, and students enjoying themselves while learning!

Shirley English, a new English program designed to improve students' language and writing abilities, is being implemented in 3<sup>rd</sup> through 6<sup>th</sup> grades, as well as *Rhymes in Times*, a new hands-on math program that helps students in 3<sup>rd</sup>-6<sup>th</sup> grades with their multiplication facts.

- Scholastic Book Fair will be held October 3-6<sup>th</sup> in the Library. Wednesday, October 5<sup>th</sup> the Book Fair will be open before school from 7:30-8:30 for parents to shop.

Ms. Peggy Washington will be here for a site visit October 6, 2005 to evaluate the DOP program and go through a day in the life of a DOP coordinator. Finally, I would like to take this opportunity to thank all parents, teachers, principals, and administration for their continued support of our Leadership Academy in conjunction with the Dropout Prevention Program here in Breathitt County.

Dear Mr. McKnight:

Approximately six times each year, the Kentucky High School Athletic Association appears before the Kentucky Board of Education. One aspect of those visits is a required update on the status of the KHSAA's efforts to accomplish gender equity in our member schools athletic programs.

At our most recent appearance, there was dissatisfaction expressed by the KBE over the Title IX accomplishments of Breathitt County High School. They were most concerned about: (1) the cramped and overlapping usage of athletic facilities for girl's athletic programs; (2) the lack of established policies for the purpose of monitoring standards and compliance; and (3) the significant and ongoing disparity in the amount of annual funding provided for boy's athletics as compared to funding for girl's athletics.

In an effort to assist your school toward compliance goals. I wish to set a date for a personal visit to your school, a tour of all of your athletic facilities and a discussion of goals and objectives with your school's Gender Equity Committee. I will be in your area on Wednesday, October 19, 2005 and would like to meet on that day. I want to tour the facilities at approximately 1:30 p.m. Following that tour I want to meet with your Gender Equity Committee at approximately 3:30 p.m. Those Committee members present at the meeting should include two parents, a female basketball player, a Breathitt County Board of Education member, a female volleyball player, the Athletic Director, the head volleyball and boys' basketball coaches, and any other members you chose to invite. If these members are not present, we will reschedule the portion of our visit with the Gender Equity Committee. Every effort should be made to ensure their attendance. Hopefully, the visit should conclude no later than 5:00 p.m. or earlier.

We are now in our seventh year of Title IX compliance efforts. I urge you to consider the seriousness of the fact that Title IX deficiencies are still a concern at Breathitt County High School. Please, let's work together to immediately eliminate all of these issues for your outstanding school and put these issues to rest. Anything less will result in unwanted penalties levied against your football program.
