ACCOMMODATIONS OF INTEREST AND ABILITIES NOTE: The December 13, 2007 Title IX school visit report rated the accommodations of student interest and abilities *Satisfactory* based on data showing the standards established by all three opportunities tests were being met. The October 1, 2013 school visit report also rated this category *Satisfactory*. At that time, it appeared that the standard established by Test 3 was being met. A review of the annual Title IX reports for the past two years gives a strong indication that the standard established by Test 1 is currently being met. The T-1 form in the 2018-19 annual report shows that the percentage of participation for females was 52.7% and the percentage of enrollment for females was 50.4% It was documented on the internal summary for the last two annual reports that the indicated interest in swimming should be pursued for validity in order to meet the standard established by Test 3. Documentation of this process should be listed on the T-3 form in the annual Title IX report. The T-63 form in the 2017-18 annual Title IX report showed that a 96.7% completion rate was received on the most recent student athletic interest survey. During the September 17, 2019 school visit, the Title IX file was examined. It contained the two most recent Title IX annual reports, a board-approved extra service pay schedule for coaches, a listing of the current members of the Gender Equity Review Committee, sample game schedules for all school sponsored teams except boys and girls track (these schedules were provided by the athletic director during the visit), a school-generated athletic handbook for athletes, a usage schedule for the gym showing use by volleyball and middle school basketball only (see *Scheduling of Games and Practice Times* and *KHSAA Recommended Action*), a written regulation regarding the provision of letters and bars (see *Publicity* and *KHSAA Recommended Action*), minutes for one 9/4/19 GERC meeting (see *KHSAA Recommended Action* under *Accommodation of Student Interests and Abilities*), a uniform review, rotation, and/or replacement plan (see *Equipment and Supplies*), some statements addressing student transportation and per diem (see *Travel and Per Diem* and *KHSAA Recommended Action*). School officials and the GERC were strongly encouraged to work toward the development and implementation of guidelines and regulations addressing the equitable provision of opportunities and benefits for student athletes.

BENEFITS REVIEW- EQUIPMENT AND SUPPLIES: Both the 2007 and 2013 Title IX school visit reports rated this benefit category *Satisfactory*. All the uniforms inspected during the most recent visit were of high quality and appeared to be provided in equitable quantities. The school's Title IX file contains a uniform review, rotation and/or replacement plan showing that all teams, except bass fishing, were on a four-year cycle of replacement. Interviews with coaches and student athletes indicated the plan was being followed. UPON RECEIPT OF THIS REPORT, THE SPORT OF BASS FISHING IS TO BE ADDED TO THE UNIFORM REPLACEMENT PLAN. This plan should reflect that these uniforms are replaced annually. According to the 2017-18 and 2018-19 annual Title IX reports, the school was spending approximately \$67 per female athlete and \$46.50 per male athlete for equipment and supplies.

BENEFITS REVIEW- SCHEDULING OF GAMES AND PRACTICE TIMES The 2007 and 2013 Title IX school visit reports rated this benefit category *Satisfactory*. Information gathered during the most recent visit revealed that the number of competitive events scheduled for "like" sports was comparable except there was a slight disparity between softball and baseball. (See *KHSAA Recommended Action*.) The only shared practice facility which has separate practice times per gender is the gymnasium. At the time of the most recent visit, the athletic director was unable to produce a practice schedule showing use of the gym by both boys and girls basketball. (See *KHSAA Recommended Action*.) The scheduling of competitive events during the most opportune playing times on an equitable basis was discussed with school officials who were encouraged to make this endeavor a priority.

BENEFITS REVIEW- TRAVEL AND PER DIEM: The last two previous Title IX school visit reports rated this benefit category *Satisfactory*. At the time of the most recent visit, the school did not make available any updated regulations addressing the equitable provision of the mode of transportation, or the provision of meals and lodging for student athletes. The interviews with coaches and student athletes did not indicate that any consistent guidelines were being followed within this benefit category. The 2017-18 and 2018-19 annual Title IX school visit reports indicate that the school was spending approximately \$33 per female athlete and \$29 per male athlete for travel and per diem. The school is commended for showing equity in regards to spending in this benefit category, but the fact that it appears there are no equitable regulations being followed, this category is deemed to be **deficient**. (See *KHSAA Recommended Action*.)

BENEFITS REVIEW- COACHING: The 2007 and 2013 Title IX school visit reports rated this benefit category *Satisfactory*. According to the school's athletic director and assistant principal, no one at the school is currently responsible for evaluating coaches of athletic teams. A review of the district's extra service pay schedule indicated parity in the amount of compensation as well as the number of compensated positions for "like" sports. The T-35 form in the 2018-19 annual report shows that the total amounts spent for coaching salaries for teams of "like sports" was comparable. Information gathered during the most recent visit revealed that the coaching ratio for females is 7.2 athletes per coach, and for male participants it is 8.2 athletes per coach. Data provided by the athletic director indicated that 20% (1/5) of the head coaches of girls teams and 25 % (1/4) of the head coaches of boys teams are on-campus employees.

BENEFITS REVIEW- LOCKER ROOMS, PRACTICE AND COMPETITIVE FACILITIES: The 2007 and 2013 Title IX school visit reports rated this benefit category *Satisfactory*. The 2013 report mentioned the need for more athletic equipment storage space especially for the volleyball team. The school has a small but well-appointed and maintained gym that serves as a practice and competition venue for boys and girls basketball and volleyball. The softball and baseball fields are both located on the school campus and appear to offer comparable amenities. The school does not have a track or cross country course suitable for competition. The coaches of these sports have been very creative in using the available practice areas for these sports. All track and cross country matches are away events. The athletic director did not provide a listing of the locker room space and equipment storage space as requested by KHSAA. The tour of facilities revealed that some dressing areas were available for all teams and these areas seemed to have equitable amenities. However, interviews during the visit did not confirm that all student athletes or coaches knew about these dressing areas. (See *KHSAA Recommended Action*.) Athletic equipment storage space appeared to be in short supply at the school. School officials were reminded that available space should be shared by all school sponsored teams. (See *KHSAA Recommended Action*.)

BENEFITS REVIEW- MEDICAL AND TRAINING FACILITIES AND SERVICES: The 2007 and 2013 Title IX school visit reports rated this benefit category *Satisfactory*. The tour of facilities during the most recent visit showed that the school has a large, well-appointed and equipped weight training room on the school campus. This facility has numerous training options that would be suitable for use by female athletes. There was no usage schedule showing equitable access for females in the Title IX file or posted at the facility. Interviews with coaches and a student athlete did not offer evidence that equitable access was provided. (See *KHSAA Recommended Action*.) The services of an athletic trainer are not provided at the school. Student athletes are responsible for getting their own physical examinations.

BENEFITS REVIEW- PUBLICITY: Both the most recent Title IX school visit reports rated this benefit category *Satisfactory*. The school currently has one varsity cheerleading squad that is assigned to cheer at all home and post season games for both the boys' and girls' basketball teams. The band plays at an equal number of home games for boys and girls basketball as monitored by the principal for the provision of parity. During the school visit, the athletic director stated that there was a school board policy prohibiting the posting of banners for athletic recognition. The A.D. also stated no athletic awards were given except for letters and bars for which there is a written regulation. It was also noted that teams had post season banquets, but there were no written regulations for parity in regard to this benefit. Interviews with coaches and a student athlete indicated that awards were provided for several teams, and to their knowledge, no teams were given letters and bars. To further complicate this situation, the school's T-35 form in the 2018-19 annual Title IX report shows no spending for awards and recognition by any school sponsored team. Because of the lack of written regulations for the provision of parity in this benefit category and the possibility of inaccurate reporting of expenditures, this category is designated to be currently **deficient**. BENEFITS REVIEW- SUPPORT SERVICES: The 2007 and 2013 Title IX school visit reports rated this benefit category *Satisfactory*. The 2013 report documented that total athletic spending slightly favored male athletes. The school currently has two coaching offices. One office is used exclusively by girls' basketball and the other is used exclusively by boys' basketball. According to the school's athletic director and the assistant principal, no booster clubs exist at this time to support any athletic teams. A review of athletic expenditures for the past two years shows the school averaged spending \$250 per male athlete and \$230 per female athlete for total support. This spending appears to be within generally accepted parameters for the provision of parity for a non-football playing school. IT SHOULD AGAIN BE NOTED THAT THIS SPENDING ANALYSIS INCLUDES NO SPENDING FOR AWARDS.

School officials were strongly encouraged to allow the Gender Equity Review Committee to function as an integral part of the implementation of Title IX in athletics.

It is also strongly recommended that the person(s) responsible for completing Title IX reports attend a KHSAA sponsored Title IX workshop.

No one from the community attended the Public Comments session. The meeting was adjourned at 3:50 pm EDT.

Athletic Travel

Policy : The Burgin High School Athletic Department shall maintain an equitable policy to provide guidelines and procedures for travel and per diem of student athletes.

1. The Athletic Department will not purchase meals during regular season travel for student-athletes.
2. In the event that a team or individuals in individual sports qualifies for the state tournament in their sport, the athletic department will provide one meal during their participation in the tournament. Meal money will allow for \$15 per player and coaches for the tournament.
3. Student athletes shall ride school provided buses to and from all scheduled athletic events. School provided buses will be equitable allocated to both boys and girls sports. If the team travel involves less than 5 student-athletes, the coaches may take a school mini-van in place of a school bus. An exception to this policy allows a coach to release the student-athlete to their parent or guardian. Student-athletes may obtain prior approval to ride with an adult other than their parent or guardian only if approval is granted in advance by the coach and is in writing and signed by parent or guardian.
4. Boys and girls teams shall be given equitable travel opportunities for regular season tournaments, out of region, and out of state events. All overnight and out of state events must be approved by the Athletic Director and the Burgin Board of Education. To insure equity in regards to lodging the Athletic Director is required to approve all bookings of hotel rooms for student-athlete travel at the school. Lodging for athletic travel is required to have 3 or 4 students per room.
5. Student-athletes with extenuating circumstances may request approval for alternate travel arraignments through the Athletic Director or Principal.

Locker room space for all athletic teams:

- Baseball - Boys locker room off the gym.
- Boys Varsity Basketball- Boys locker room off the gym.
- Girls Varsity Basketball- Girls locker room off the gym.
- MS Boys Basketball- Boys locker room off the gym
- MS Girls Basketball- Girls locker room off the gym.
- Boys Cross Country - Boys Locker room off the gym.
- Girls Cross Country- Girls locker room off the gym.
- Softball- Girls locker room off the gym.
- Boys Track- Boys Locker room off the gym.
- Girls Track- Girls Locker room off the gym.
- Volleyball- Girls locker room off the gym.

Athletic Equipment Storage for all athletic teams:

- Baseball- Large field equipment storage in the building at the west end of the parking lot.
- Practice equipment in the storage building between the baseball field and softball field.
- Softball- Large field equipment storage in the building at the west end of the parking lot. Practice equipment in the storage building between the baseball field and softball field.
- Boys Varsity Basketball- Storage closet in the Boys locker room off the gym.
- Girls Varsity Basketball- Storage closet in the Girls locker room off the gym.
- MS Boys Basketball- Storage closet in the Boys locker room off the gym.
- MS Girls Basketball- Storage closet in the Girls locker room off the gym.
- Boys Cross Country- Large field equipment storage in the building at the west end of the parking lot. Uniform storage is in the closet in the AD's room.
- Girls Cross Country- Large field equipment storage in the building at the west end of the parking lot. Uniform storage is in the closet in the AD's room.
- Boys Track- Large field equipment storage in the building at the west end of the parking lot.
- Girls track- Large field equipment storage in the building at the west end of the parking lot.
- Volleyball- Storage is in the Athletic Directors closet in his room.

Post Season Awards and Banquets

Policy: The Burgin High School Athletic Department shall maintain an equitable policy to provide guidelines and procedures for Post Season Awards and Banquets.

1. Post season Awards Banquet will be paid for from each team account. If food is provided a limit of \$10 per player on the end of season roster may be spent to purchase food for the event.
2. Each team will pay for their post season awards from their team accounts. Teams may give 1 award for each 6 players on their roster. The cost of all awards should be limited to \$5 per student-athlete on the final team roster. Senior awards should be limited to \$35 apiece.

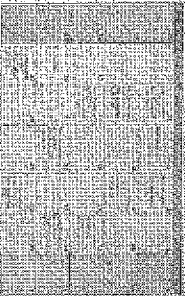
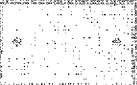


Figure 1, 2020
