Mr. Bilberry,

As part of our fall Title IX audit, we received the following KHSAA recommended actions.

On or before February 15, 2016, the school is to submit to KHSAA equitable written guidelines for the provision of postseason awards and banquets. These guidelines are to include administrative oversight in relation to this benefit category.

On or before February 15, 2016, the school is to submit to KHSAA a written expansion of the current guidelines for this benefit category which addresses the equitable provision of meals and lodging for student athletes.

These two items are addressed in our attached SBDM policy, which has been passed by our SBDM council and approved by our board. Please advise if our actions fulfill the KHSAA recommended actions above.

Function (school operational policies)

Policy Number: 8.02

Policy Topic: Equity practices in athletic programs

Policy Statement

All Crittenden County High School interscholastic and intramural athletic and sport activity competition shall be in compliance with the constitution, bylaws, and competition rules of the Kentucky High School Athletic Association (KHSAA) and Title IX requirements. Particular attention shall be paid to the following to ensure equity among male and female athletic programs at Crittenden County High School:

1. Transportation and per diem allowances for meals and lodging shall be equitable between female and male athletic programs. Purchase orders and invoices shall be submitted to the principal for approval and verified by the athletic director as equitable.
2. Expenditures for post-season awards and banquets shall also be financially equitable between male and female sports. Purchase orders and invoices shall be submitted to the principal for approval and verified by the athletic director as equitable before coaches commit to spending funds. An annual written report detailing expenditures for post-season awards and banquets shall be prepared by the athletic director as part of Title IX reporting requirements. Such report shall be reviewed by the AD and the principal to ensure compliance of this policy.

For all of the items above, it shall be the responsibility of the athletic director to oversee program equity, and the AD shall review expenditures with the principal to ensure compliance with this policy for the purpose of Title IX reporting.
