Thanks for submitting the requested documents to the KHSAA. I am sending you this email to remind you to send documents of the procedure that will be followed as a result of the student survey.

In the area of Accommodation of Interests and Abilities, the student interest survey procedure was deficient as observed at our Title IX visit on December 17, 2013. I saw in your annual report submitted April 30, that recent survey results were very good and you have corrected that part of the deficiency. I encourage you to check again the interest shown in three sports, archery, bass fishing, and LaCrosse and follow up with the three step approach in determining if these interests are genuine. Document the steps of meetings (students and parents), and feasibility. If the school board has said no to any of these sports, please document that as well.

Please submit your plans as soon as possible as to when the follow-up procedures will be conducted. Hopefully, you can have student interest meetings this spring before school closing and if needed, parent meetings early this summer or early next fall.
