

**Up for Approval by the East Jessamine SBDM on 02/27/14**  
**Equitable Support Groups (Pep Band) (02/27/14)**

The East Jessamine High School SBDM requires the EJHS PEP Band to perform at boys' and girls' athletic events on an equitable basis.

It is the EJHS SBDM expectation that the EJHS Pep Band will:

- Perform at all home varsity football games.
- Perform at equitable number of home boys' and girls' varsity basketball games and all boys' and girls' varsity post-season basketball games.

The Athletic Director, with input from the band director, is responsible for creation of the athletics event pep band schedule. This schedule will be published on each corresponding football, girls' basketball and boys' basketball schedules. These schedules will be distributed to all coaches and filed into the Title IX master file each year.

**Equitable Support Groups (Dance Team) (02/27/14)**

The East Jessamine High School SBDM requires the EJHS Dance Team to perform at boys' and girls' athletic events on an equitable basis.

It is the EJHS SBDM expectation that EJHS Dance Team will:

- Perform at all home varsity football games.
- Perform at equitable number of home boys' and girls' varsity basketball games.

The Athletic Director, with input from the dance team coach, is responsible for creation of the athletics event dance team schedule. This schedule will be published on each corresponding football, girls' basketball and boys' basketball schedules. These schedules will be distributed to all coaches and filed into the Title IX master file each year.

**Equitable Support Groups (Colt Mascot) (02/27/14)**

The East Jessamine High School SBDM requires the EJHS Jaguar Mascot to perform at boys' and girls' athletic events on an equitable basis.

It is the EJHS SBDM expectation that the EJHS Jaguar Mascot will:

- Perform at all home varsity football games.
- Perform at equitable number of home boys' and girls' varsity basketball games and all boys' and girls' varsity post-season basketball games.

The Athletic Director, with input from the Jaguar Mascot, is responsible for creation of the athletics event pep band schedule. This schedule will be published on each corresponding football, girls' basketball and boys' basketball schedules. These schedules will be distributed to all coaches and filed into the Title IX master file each year.

**SECTION B - EXECUTIVE COMMITTEE:** The Executive Committee shall consist of the booster officers and chairpersons. The Executive Committee shall meet as needed and has the authority to make decisions on behalf of the boosters.

## **ARTICLE VIII - FINANCES**

**SECTION A - BUDGET PREPARATION:** The Executive Committee in cooperation with the head coach shall prepare a budget at the beginning of each year to be approved by the boosters using the Budget Entry Sheet (attached hereto as Attachment 1). A monthly Income/Expense Report shall be submitted to the Athletic Director during the sports' active season (Attachment 2). The Executive Committee shall be responsible for the administration and execution of the budget upon approval of the budget by the EJHS/WJHS Boosters.

**SECTION B - DISBURSEMENTS:** The President, Vice-President and Treasurer are authorized to sign checks. Any checks in amounts exceeding \$250.00 must require signatures of two officers.  
\*Booster Club must set this up at your bank.

**SECTION C—PURCHASING PROCEDURES:** For purchases involving the use of funds from the Jessamine County School system, the procedures implemented by the Jessamine County Board of Education shall be followed. For purchases involving the use of booster funds which exceed \$100.00, the coaches and booster members shall be required to complete the Purchase Request form (attached hereto as Exhibit 3) that has been approved by the Jessamine County Board of Education. This form shall be submitted to at least two (2) booster club officers for approval prior to purchasing. If any purchases are made outside the proper procedures, the booster club and/or the Athletic Department reserves the right to refuse payment.

## **ARTICLE IX- AMENDMENTS**

These By-laws may not be amended unless prior approval from the Jessamine County Board of Education is granted.

## **ARTICLE X - DISSOLUTION**

The EJHS/WJHS Boosters may be dissolved by majority vote of members at a scheduled or special meeting attended by the appropriate Athletic Director. In the event the organization is dissolved, all money left in the booster account after satisfying the organization's debts shall be transferred to the EJHS/WJHS athletic activity account at East/West Jessamine High School and earmarked in a school account for the specific team.
