All Simpson County Schools athletic teams will use Simpson County School busses to travel to games, matches and events. Teams may request the use a charter bus for away games outside the area in which the team normally competes. The usse of certificated common carrier service shall be authorized by the Board on a case-by-case basis, and the reasons to justify such use shall be cited in Board minutes.

Overnight trips must be preapproved by the Simpson County Board of Education.

Athletic teams taking overnight trips are restricted to \$125 per night for lodging for in state trips, and \$250 for out of state trips with 4 student athletes per room.

Meals may be provided for student athletes are not to exceed \$10 per person. Each team may request one regular season and one post season exception to this policy.

Simpson County Schools Awards and recognitions policy

Each team will have a banquet at the end of the year to honor and recognize the accomplishments of the players for the season. At the banquet each team will award letters based on the criteria established for their sport. The team shall include food and awards for the event as part of the budget that will be submitted to the Principal and Athletic Director.

Any team that earns a district championship, region championship, semi-state or sectional championship or a runner up for anything beyond the district level will be recognized on signs displayed in the high school gym. The teams may also display these accomplishments at their own venue.

The leading scorer for boys and girls basketball will have banners hung in the high school gym.

All trophies awarded by the KHSAA will be displayed in the trophy cases in the lobby of the high school gym. Trophies for regional championships and beyond will remain in the trophy case indefinitely. Trophies for district runner up, district championships and regional runner up will remain in the trophy cases for 5 years. After 5 years these trophies will be given to the teams to display in their own locker room or other appropriate location. All trophies awarded in seasons in which a team wins a state championship or state runner up will remain together in the trophy case.
