ACCOMMODATIONS OF INTEREST AND ABILITIES NOTES: The October 26, 2005 Title IX school visit report rated the accommodation of student interest and abilities Satisfactory. At that time, the information provided indicated the school was meeting the standard established by both Tests 1 and 2 for the provision of athletic opportunities. The report recommended that the indicated interest in soccer be pursued for validity. The 2013 school visit report again rated this area Satisfactory based on data showing that the standard of Test 1 was being met. Again, school officials were encouraged to pursue the interests shown on the student athletic interest survey. A review of the annual Title IX reports for the past two years indicates that the standard established by Test 3 is being met. The T-3 form in the 2017-18 annual report addresses the geographic infeasibility of adding swimming as a sport. The T-3 and T-63 forms in the 2018-19 annual report made it likely that Test 3 continues to be met. The T-63 form in the 2017-18 annual Title IX report shows that an 88.1% completion rate was received on the most recent student athletic interest survey. During the most recent visit, the school's Title IX file was examined. It was found to contain the three previous Title IX school visit reports, annual Title IX reports for the past two years, a board-approved extra service pay schedule for coaches, a listing of the current members of the Gender Equity Review Committee, current game schedules for all varsity teams, game programs containing rosters only for all school teams, a school-generated athletic handbook for students, a school-generated handbook for coaches, facility usage schedules for all shared athletic venues, guidelines addressing equitable recognition of student athletes (see Publicity and KHSAA Recommended Action), written designation of the locker rooms and athletic equipment storage space assigned each team, minutes for all Gender Equity Review Committee meetings held during the past three years, a uniform review, rotation, and/or replacement plan, and some regulations addressing equitable provision of meals and lodging for student athletes when participating in post season tournaments. (See Travel and Per Diem Allowances and KHSAA Recommended Action.) School officials were commended for the development and maintenance of comprehensive regulations addressing the equitable provision of opportunities and benefits for student athletes.

BENEFITS REVIEW- EQUIPMENT AND SUPPLIES: The 2005 Title IX school visit report rated this benefit category *Satisfactory*. The 2013 report rated this category *Deficient* stating that there appeared to be disparity in the quality of uniforms for girls' basketball compared to boys' basketball. There were also differences noted in the quantity of uniforms supplied for softball compared to baseball. The school did not seem to be following any plan for the review and replacement of uniforms. All of the uniforms and equipment seen during the most recent school visit appeared to be of mid-to-high quality and supplied in equitable quantities. The Title IX file contained a uniform review, rotation, and replacement plan showing a full cycle of equitable replacement for all varsity teams. Interviews with student athletes and coaches confirmed knowledge of and adherence to the current uniform replacement plan. The 2017-18 and 2018-19 annual Title IX reports show that the school was spending approximately \$97 per female athlete and \$42 per male athlete for equipment and supplies.

BENEFITS REVIEW- SCHEDULING OF GAMES AND PRACTICE TIMES: Both the 2005 and 2013 Title IX school visit reports rated this benefit category *Satisfactory*. Information gathered during the most recent school visit revealed that the number of competitive events scheduled for teams of "like" sports was comparable. Facility usage schedules showing equitable access for both genders were available for the gym and weight training room. Interviews with coaches and student athletes gave strong indication that these schedules were being followed. Scheduling competitive events during opportune playing times on an equitable basis was discussed with school officials who were commended for the provision of equity in this endeavor.

BENEFITS REVIEW- TRAVEL AND PER DIEM: The 2005 Title IX school visit report rated this benefit category *Satisfactory.* The 2013 report rated this area *Deficient.* This deficiency was based on the school not having written regulations for this benefit as requested by the 2005 visit report. In addition, neither the total nor per athlete spending could be calculated for this benefit category because the amounts submitted by the school on the T-35 form were inaccurate. A review of the Title IX file during the most recent school visit showed that the school had regulations addressing the equitable provision of meals and lodging for students participating in post season tournaments and competitions. School officials did not think that regulations were needed for the regular season because school teams had not taken an overnight trip since the 1990's. The need for regulations addressing parity in travel and per diem was discussed with school administrators and the Gender Equity Review Committee. (See *KHSAA Recommended Action.*) The 2017-18 and 2018-19 annual Title IX reports show that approximately \$51 per female and \$43 per male athlete was spent for travel and per diem.

BENEFITS REVIEW- COACHING: The 2005 and 2013 Title IX school visit reports rated this benefit category *Satisfactory.* It was learned during the most recent school visit that the principal and athletic director are responsible for the evaluation of all head coaches, and a written instrument is being used for documentation of this process. A copy of this instrument was in the Title IX file. A review of the district's extra service pay schedule for coaches indicated parity. The T-35 form in the 2018-19 annual Title IX report shows that the total amounts spent for coaching salaries for teams of "like" sports was comparable. Information gathered during this visit revealed that the coaching ratio for females is 6.5 participants per coach and for males it is 7.9 participants per coach. Data provided by the athletic director indicated that 60% (3/5) of the head coaches of girls teams and 50% (3/6) of the head coaches of boys teams are on-campus employees.

BENEFITS REVIEW- LOCKER ROOMS, PRACTICE AND COMPETITIVE FACILITIES: The 2005 school visit report rated this benefit category *Deficient* citing a disparity in the access to *exclusive* locker room space. The 2013 report rated this category *Satisfactory* stating that the 2005 disparity appeared to have been addressed by the construction of a "small but very well-appointed girl's basketball (only) dressing room in the gym. The tour of facilities during the most recent school visit showed that the indoor and outdoor facilities offered comparable amenities for both genders. There were a couple of slight differences in the baseball and softball facilities. The baseball field has enclosed block dugouts and softball has chain link dugouts enclosed with tarp. There also appears to be some drainage issues at the softball field that do not exist at the baseball field. These two areas (dugouts and drainage) should be addressed in the school's Title IX improvement plan (T-60 form). The school has three dressing areas in the gym that serve all school teams. There is a limited amount of storage space, but the available areas seem to be assigned equitably with the size of the team and proximity to the competitive facility being priorities.

BENEFITS REVIEW- MEDICAL AND TRAINING FACILITIES AND SERVICES: Both the 2005 and 2013 Title IX school visit reports rated this benefit category *Satisfactory*. The most recent school visit revealed that the school has a large, very well maintained and equipped weight training room. A usage schedule showing equitable access was in the Title IX file and posted at the facility. Interviews with coaches and student athletes confirmed that this venue was widely used and provided equitable access. This facility has numerous training options that are suitable for female athletes. Athletic trainer services are not available for either gender. The Hickman Family Clinic offers free athletic physical exams each year during July.

BENEFITS REVIEW- PUBLICITY: The 2005 and 2013 Title IX school visit reports rated this benefit category Satisfactory. The 2013 report requested that regulations in this area be expanded to include the posting of banners for athletic recognition in the gym. It also requested that these regulations include the specific per athlete formula used to distribute funds for athletic awards. The school currently has one varsity cheerleading squad that is assigned to cheer at all home and away football and boys and girls basketball games. The Title IX file contained excellent written guidelines calling for parity in regard to posting of banners for athletic recognition and the provision of letters and bars, and awards. These guidelines also address post season banquets. UPON RECEIPT OF THIS TEPORT, THESE GUIDELINES FOR BANQUETS SHOULD BE MADE MORE SPECIFIC IN REGARD TO THE LOCATIONS AND PROVISION OF FOOD AT THESE EVENTS. The Publicity section of the Title IX file indicates the existence of an Athletic Hall of Fame. The step by step process for nomination is detailed, but there is no description of the committee which actually chooses those to be inducted. (See KHSAA Recommended Action.) The 2017-18 and 2018-19 Title IX annual reports show that \$3.75 per female athlete and \$4.80 per male athlete was spent for awards.

BENEFITS REVIEW- SUPPORT SERVICES: The 2005 Title IX school visit rated this benefit category *Deficient* based on the fact that the Gender Equity Review Committee was not functioning. The 2013 school visit report rated this area *Satisfactory* but requested that school officials "monitor closely" the accuracy of expenditures submitted as well as the equitable expenditure of athletic funds. The tour of facilities during the most recent visit revealed that there are no coaching offices at the school currently. The school has one athletic booster club that serves all high school teams. This club houses its funds off the school campus. A policy is in place that no coach can request any booster purchase unless they have written approval from the principal and athletic director. A copy of the form used to request this approval is part of the Title IX file. A review of athletic spending for the past two years shows that in both 2017-18 and 2018-19 the percentage and per athlete spending favored female participants. Although not part of the current Title IX evaluation, as per request, the school was asked for a copy of its Athletic Facility Emergency Medical Plan (KRS 160.445). The plan provided during the most recent visit was comprehensive. IT WAS REQUESTED THAT THE DETAILED STEPS TO BE TAKEN AT THE SPECIFIC ATHLETIC VENUES BE EMPHASIZED.

The athletic director identified the locations of three Automated External Defibrillators that are available at the school. There is one permanent AED on the west wall of the gym lobby. The second one is adjacent to the cafeteria doors. There is a portable AED on the wall of the principal's office.

No one from the community attended the Public Comments session. The school's athletic director was commended for the thorough preparation for the school visit. The meeting was adjourned at 4:20 EDT.

19-20 KHSAA Title IX Re-Visit Field Report:

The GERC reviewed and discussed the information in the 19-20 Title IX Re-Visit Field Report noting areas of improvement that could be added to our Title IX Improvement Plan. It was noted that there were no deficiencies as a result of the Title IX visit, but Julie Jackson would send information to Mr. Gary Lawson/KHSAA concerning other actions listed on the report on or before December 4, 2019.

Travei & Per Diem:

The GERC discussed our Athletic Travel and Per Diem information and added information concerning transportation for the regular season in regards to overnight trips, modes of transportation, and how meals would be covered for athletes.

Awards, Recognitions, & Banner Displays:

The GERC reviewed our guidelines for Athletic Banquets so that it would be more specific in regards to location and provision of food for the Fall and Spring Banquets.

Hall of Fame Committee:

Our Hall of Fame Nomination Form and procedures were reviewed. The GERC added the following to serve as the Hall of Fame Committee: FCHS Principal, FC Athletic Director, Head Coach of a Female Team, Head Coach of a Male Team, and a FC Booster Club Officer.

Emergency Action | The Emergency Action Plan was reviewed and information pertaining to each Athletic Venue was added.

 Managers that regularly attend practices and competitions will receive the athletic award that the members of the team he/she is serving as manager will receive.

Coaches will determine which end-of-season awards are given and methods whereby recipients are elected. Athletes must attend the awards program to be eligible to receive their athletic awards. Otherwise, athletes must be excused by their coach or athletic director.

Best All Around Pilot:

Each year, coaches can nominate a female and/or a male athlete who will be presented with the All Around Pilot Award at the Spring Athletic Banquet. This award is sponsored by the Fulton County Athletic Booster Club. Coaches rate their nominee on the following: work ethic, ability to overcome failure, positive energy, handling of risks/responsibilities, and sportsmanship. The Principal rates the nominee on the following: school attendance, grades, and school discipline. The award is given to a Senior Male Athlete and a Senior Female Athlete each year.



Fulton County Schools Awards, Recognitions, & Banner Displays

Banquets & Awards

Fulton County High School holds two sports banquets. One is held in the Fall and one is held in the Spring. The Fall Banquet recognizes the following sports: Cross Country, Golf, Football, and Volleyball. The Spring Banquet recognizes the following sports: Baseball, Basketball, Cheerleading, and Softball.

Each individual athlete is recognized. The Coaches are allotted \$6.00 per athlete to give out statistical awards or awards for each member of the team. Specific formula for individual awards: \$6.00 per player times the number of players per team. Example: 15 players \times \$6.00 = \$90.00 for awards.

Each sports banquet is hosted by our Fulton County Booster Club. All athletes will be provided a free meal. Additional tickets will be sold to parents and other attendees. Each banquet will be held on campus utilizing one of the school's cafeterias or gymnasiums. A catered meal will be provided for both the Fall and Spring Sports Banquet.

Banners

District, Regional, and State Banners are hung in the gymnasium. Banners are purchased by the FCHS Athletic Activity Account. We currently have banners representing Basketball (Boys & Girls), Cheerleading, Football, Weightlifting, Baseball, Softball, Track, and Cross Country. Anyone recognized for All-State Honors will receive a plaque and one will also be displayed in the trophy case on display. All KHSAA trophies will also be displayed in the trophy case.

The Fulton County Booster Club purchases each year Senior Athlete Banners for all sports that are hung in the gym.

We are currently in the process of putting up a banner for basketball players who are in the 1,000 Point Club.

Athletic Recognitions

Varsity Letters are awarded to:

- An athlete who has had participation in one half of the varsity quarters, matches, meets, or innings for the season.
- Any senior that has participation in at least two preceding high school years in that sport.
- Injured athletes that would have accomplished either of the first two requirements.
- Coaches' discretion, i.e. to an athlete that made a significant contribution on the varsity program but doesn't meet the first three requirements. (Ex. Reserve athlete that improves and moves up to varsity at the end of the season, late transfer, etc.)

Winter Sports: FCHS Boys and Girls have conducted tryouts for Basketball and have started practicing for the upcoming game on December 3, 2019. We currently have 11 girls and 23 boys playing basketball.

Fulton County High School Athletic Hall of Fame

Membership Guidelines

The Fulton County High School Athletics Hall of Fame is open to former FCHS student-athletes and coachs who have distinguished themselves in the athletics' arena.

STUDENT-ATHLETES

- 1. Student-athletes may be nominated based on their Fulton County High School athletic acheivements.
- 2. A stong consideration will be given to those student-athletes who graduated from Fulton County High School.
- 3. Student-athletes will be eligible for consideration following graduation or after the ommpletion of their playing career.
- 4. The student-athlete must have been a letter winner for at least two years.
- 5. Student-athletes nominated must have demonstrated outstanding performance and achievements and brought exceptional distinction to the individual and/or Fulton County High School during their playing career OR after they have exited from the Fulton County High School in the athletics arena.
- 6. Student-athletes will be eligible for induction 5 years after the completion of their playing career at Fulton County High School.

NOTE: Speicial circumstances may require special consideration for induction.

COACHES AND ATHLETIC ADMINSTRATORS

Current or former Fulton County Coaches or Athletic Administrators may be nominated for their outstanding contribution to Fulton County Athletics based on a career as a coach or administrator that has brought exceptional distinction to the individual and the Athletic Department during their active employment at and/or following employment at Fulton County Schools.

Number of years of service and other considerations will be at the discretion of the Hall of Fame Committee. They do not have to be an active coach or administrator at the time they are selected for induction.

INDUCTION INFORMATION

Any person can make nominations. To nominate an individual, please submit an FCHS Athletic Hall of Fame Nomination Form. A blank form has been attached. Copies may also be obtained from the Athletic Director, Julie Jackson. A committee consisting of the following will meet each year to determine selection into the Hall of Fame: FCHS Principal, FC Athletic Director, Head Coach of a Female Team, Head Coach of a Male Team, and FC Booster Club Officer.

Fulton County Schools Athletic Travel and Per Diem Allowances

Travel:

Each sport is responsible for conducting two fundraisers each year to help cover transportation costs. Teams should be transported by board owned school buses or vehicles. Coaches are to enforce the transportation rules outlined in the Student/Parent Handbook. Coaches will arrange for bus travel through the district Transportation Director. Bus requests should be filled out for ALL Athletic contests and submitted prior to the start of the season. Cancellations or changes in contest dates, times, or locations should be communicated to the Athletic Director and Transportation Director in a timely manner. Plan for and request to the Principal/Superintendent by email any necessary early releases from school/class for students to participate in a contest.

During the regular season, each sport can make an overnight trip as long as it is approved by the Board of Education at one of their monthly board meetings. Each sport is responsible for paying for overnight trips. Expenses such as rooms and meal money will come out of the individual team's account. Rooms should cost between \$50.00-\$125.00 with 3-4 players or managers staying in them. Hotels should not have outside doors but should have inside corridor entrances. Meals will either be paid for out of the team's account or paid for by each individual.

FC Board of Education will pay the expenses of any team who makes it to a state tournament. A request must be made in advance with costs to the BOE before a monthly board meeting.

Per Diem

Meals are not provided for regular season games by the district. One meal per sport per regular season game will be provided by the Fulton County Booster Club. All other meals during the season will be the students' responsibility. Any meal costs that occur during post-season play will be picked up by the Fulton County Board of Education but must be approved beforehand. Meal allowances are as follows: Breakfast=\$6.50, Lunch=\$8.50, and Dinner=\$10.00.

Hotel expenses for tournament play-offs or state tournaments will be covered by the Board of Education. Rooms should cost between \$50.00-\$125.00 with 3-4 players or managers staying in them. Hotels should not have outside doors but should have inside corridor entrances.
