

## Athletic Hall Of Fame

The Gallatin County School District Athletic Hall of Fame was launched to honor and preserve the legacy of those who have excelled in the past and to inspire our youth to achieve greatness of their own in the future. The hall of fame gives special recognition to outstanding former student-athletes, coaches and supporters for their athletic achievements and/or contributions to the athletic programs that have had a profound positive impact on the Gallatin County School District.

Supporting the hall of fame is a managing committee comprised of volunteers with an interest in Gallatin County School District Athletics. Members of the managing committee are as follows:

To qualify for induction, nominees must meet the following eligibility criteria:

- The time period since receiving his/her diploma from the Gallatin County School District has been at least five years.
- Eligible athletes must have earned at least one varsity letter while attending the Gallatin County School District.
- Moral character, good citizenship, and academic performance during high school and post high school years shall be a consideration.
- Although athletic achievement while attending the Gallatin County School District is of prime importance, outstanding accomplishments after leaving the Gallatin County School District will also be considered.

**Applications for the GCHS Hall of Fame must be submitted to the high school principal prior to November 30 of each year for consideration. Nominations will then be considered by the committee members to determine induction into the Hall of Fame.**

Hall of Fame criteria, eligibility, and nomination form information are available on the Gallatin County School District Website.

## **GCHS Athletic Travel Policy**

Trips exceeding 75 miles in one way distance will need the approval of the principal and athletic director. Overnight trips and trips out of state must have the approval of the principal, and athletic director as well as the approval of the local board of education. In cases of participation outside of the state of Kentucky, the head coach is required to make sure that the event, if needed, is sanctioned, as required by the KHSAA. Transportation costs and other finances associated with the transportation of the team to stay overnight will be the responsibility of the team.

Any mode of transportation to be used for school athletic events other than district-owned school buses, must receive prior approval of the school's administration and the Gallatin County Board of Education, as required by school board policy.

Travel policies for post-season or the All "A" Classic State Tournament will be as follows:

Only the team participating will stay overnight. A decision as to how many nights will be determined by the schedule of the event in which they are participating along with the approval of the superintendent, principal and athletic directors. All other participants such as band and cheerleading will be provided transportation on the day of event by the Gallatin County School District.

## **GCHS**

### **Athletic Per Diem Policy**

Per diem allowances for athletic participants **staying overnight** during **post-season or the All "A" Classic State Tournament** play, meals and motel expenses shall be provided by the GCHS Athletics Department.

Per diem allowances for nightly/daily athletic events will be provided by the athlete.

## Uniform Purchase Plan

### Old Plan

- 07 Boys baseball (25), Girls Softball (25), Basketball Practice Gear (boys and girls) (25) boys basketball warm ups (if money allows)
- 08 Girls Basketball (25), home and away, football (60) away, volleyball (20)
- 09 Boys Basketball (25) home and away, football (60) home, football practice gear (40)
- 10 Girls Basketball Warm ups (16), Middle School Football (40), soccer (30) MS Cheerleaders (25)
- 11 Cross Country (30) boys and girls, Middle School Basketball (26) 2 teams, MS Volleyball (25), HS cheerleaders (18)
- 12 boys baseball, girls softball, basketball practice gear, boys warm ups
- 13 girls basketball, football away, volleyball
- 14 boys basketball, football home, ms cheerleaders

Athletic department pays for these uniforms on the basis of fundraising efforts. Teams may be bumped down a year if funds are not available.

The uniform purchase plan above was not acceptable to the KHSAA Title IX Committee. They felt as though we needed to purchase uniforms on a 4 year rotation plan. We will adjust the schedule as follows:

### New Plan

2013-14	girls basketball, boys basketball, football home, volleyball	25K
2014-15	cheerleaders, ms cheerleaders, cross country, ms football	18k
2015-16	baseball, softball, soccer boys and girls	17k
2016-17	football away, volleyball ms, basketball ms boys and girls	22K

Golf and tennis will continue to receive a polo shirt per player on a yearly basis. Approximately \$500 per sport or \$2,000 per year total expenditure. Note there is no allotment for warmups or practice gear. Each sport will need to buy their own. It is possible that we may grant a purchase of practice gear in the two lower financial commitment years.

All teams are expected to have workers at the speedway, which is the athletic fundraiser to purchase uniforms. If a program does not participate, they may forfeit their year in the rotation.
