## *Travel and Per Diem Policy*

Any athlete that needs to be transported from the new high school to the middle school, where athletic events are occurring, will be provided equitable transportation from one school to the other. This will be arranged by the Director of Transportation from the school system and arranged with the athletic director and coaches.

Garrard County administration will ensure that all teams and booster clubs are equitable in the pregame and postgame meals for athletes. The Garrard County administration will check to make sure that all athletes are being treated equitably as best as the team/boosters club can afford.

## *Athletic Policy*

### *Recognition and Accomplishment*

1. Giant Photos:
  - a. Teams must earn at least a regional championship to have a giant photo hung on the walls of the school.
  - b. The principal or athletic director will determine the exact location where the photos will be hung. If an agreeable location can't be located the most current regional championship or better photos will be hung in the school lobby and the least current hung in the halls. The principal or athletic director will determine the exact location of the photos.
  - c. As space becomes limited photos will be removed by the following formula. State championship photos will remain and regional championship photos will be removed by the date of the championship earned. With the first photo removed being the oldest. If there are multiple photos from the same school year they will all be removed.
2. Banners and Signs:
  - a. To have a banner or sign hung to acknowledge a team they must have earned at least a district or conference championship.
  - b. Sign and banners will be hung at the competition venue. (Ex. Volleyball in the gym or soccer at the soccer field.)
  - c. If space becomes an issue they will be removed following the same formula as the giant photos.
3. Trophy Case:
  - a. All athletic teams will be given space to display earned trophies.
  - b. Coaches will give state, then regional and finally district trophies priority to be displayed.
  - c. When space is available other non-KHSAA sponsored trophies can be displayed with the head coach making those decisions.
  - d. When space becomes an issue the formula for removal will be used as with the giant photos, banners and signs.
4. Disposal of out dated awards:
  - a. When out dated awards are removed teams have the option of displaying them in the individual sport locker room. When two or more teams share the same locker room each team will be awarded equal space to display their most current out dated awards.
  - b. Before any awards are disposed Garrard County High School will advertise in our local newspaper their disposal so alumni can claim them.

- The meeting began at 3:15pm in the conference room.
- The meeting started with welcoming and introductions of the committee members.
- Review and purpose of the committee was discussed.
- The committee discussed and approved the minutes from the last gender equity review committee of 2011-2012.
- The committee discussed the corrective action plan. The committee discussed the attempts to field a girl's golf team. A girl's golf coach was hired and received some interest from prospective student athletes. As practice was set to begin, the student athletes decided not to play. PA announcements were conducted, prospects were recruited inside the building, and the local newspaper advertised for participation. Our coach was approached 1 week before the season was to be completed by numerous student athletes desiring to participate. Our coach got the information from the student athletes and will be on the team for the next school year. The committee discussed keeping the girl's golf team on the corrective action plan for the next school year.
- The committee shared the following information/concerns: Girls and boys basketball boosters equally shared the concessions for the football games this year. The boosters worked together every home game and will split the profit 50/50 instead of being assigned specific games; Soccer concessions were worked the same way. Girls and boys

boosters equally shared the concession instead of providing different concessions for their own games; Girls and boys soccer held a joint banquet/reception following their respected seasons; The committee discussed the move of bringing all booster club accounts in house. The transition began as of July 2012 and has been successful with little to no complaints; The committee discussed the onset of publicizing our contest through ihigh.com. We experimented with a broadcast on Oct. 5, 2012 during a football game. The plan will be to broadcast 5 girls basketball and 5 boys basketball games during the winter sports season and to broadcast 5 softball and 5 baseball games during the spring sports season; The committee discussed the dire need to work on the football and baseball bleachers. The bleachers have become a safety concern; The committee discussed the dire need to renovate the baseball field to ensure the field meets the proper specifications to host the 2014 district baseball tournament; The committee expressed concerns over the state of our outside scoreboards.

- The committee discussed the student interest survey. The committee discussed the possibility of adding bass fishing for the 2013-2014 school year.
- The committee reviewed the athletic expenditures for the prior school year.
