Extra-Curricular Bus Guidelines

The Grayson County School District provides transportation to and from all extra-curricular activities. The Transportation Department at the Board of Education requires and approved adult with no more than 30 students per bus. On special occasions the Superintendent provides a charter bus to an event with a maximum capacity of 80 students.

Extra-Curricular Hotel Guidelines

The Grayson County School District approves of overnight trips for our extra-curricular teams when needed. The guidelines for such overnight trips provide for rooms with no more than four students per room. The cost of the hotel will not exceed \$130.00 per night. The hotel should provide free breakfast during the duration of the stay.

School-Related Student Trips**DRIVERS/VEHICLES**

All District-owned vehicles shall be driven by an adult duly qualified and licensed to operate the vehicle. Drivers of school vehicles and operation of District-owned passenger vehicles transporting students shall be in compliance with requirements specified in applicable statutes and administrative regulations.¹

SUPERVISION

A certified or classified staff member must accompany students on all school-sponsored or school-endorsed trips. For athletic trips, a nonfaculty coach or a nonfaculty assistant may accompany students as provided in statute. Persons designated to accompany students shall be at least twenty-one (21) years old.²

INSURANCE

Only Board insured vehicles or appropriately certificated common carriers shall be used for transporting students.³

CERTIFICATED COMMON CARRIERS

Use of certificated common carrier service shall be authorized by the Board on a case-by-case basis, and the reasons to justify such use shall be cited in Board minutes.³

MEDICATION

Administration of medication to students during field trips shall comply with applicable law, regulation and medication administration training developed by the Kentucky Department of Education.

When students will be travelling outside the state, the Superintendent's designee shall do the following:

1. Determine applicable legal requirements concerning delegation of student medication responsibilities in states through which students will be travelling; and
2. Assign staff to accompany students on the field trip to address student medication needs.

PARENTS' APPROVAL

Parents are to be informed of the nature of the trip, the approximate departure and return times, means of transportation, and any other relevant information. Parents must give written approval for students to participate in school-sponsored trips.

School-Related Student Trips

OVERNIGHT AND OUT-OF STATE TRIPS

The Board shall approve all overnight, out-of-state and out -of-country school trips.

OTHER TRIPS

The Superintendent or the Superintendent's designee shall approve all other school-related trips and shall regularly inform the Board of all such approval.

COUNCIL APPROVAL

The School Council shall adopt a policy as required by statute to determine student participation in extracurricular programs. The policy shall address academic qualifications and attendance requirements, program evaluation, and supervision.

REQUESTS FOR FUNDS

Should any student, group of students, or extracurricular program desire Board funds for an extracurricular school-related activity or trip, the individual, individuals, or groups shall first apply to the School Council. The School Council shall determine if the activity or trip is in compliance with the extracurricular guidelines adopted by the School Council and shall determine if the request should be approved based upon academic qualifications, attendance requirements, program evaluation, and supervision.

The Council shall certify that any request for funds promotes an existing extracurricular or school activity and that the request meets the following criteria:

1. The student, students, or group making the request is deserving of the trip by virtue of its achievements;
2. The accomplishment of other students in the school and District have been considered;
3. Fairness to other nonrequesting students of the school and District is considered; and
4. The cost of participation to the school or District is weighed against the benefits to the school or District as a whole.

Once the Council has approved the school-related trip or extracurricular activity, it shall file a written request with the Board if funds for the trip or activity are required. The request shall include the following:

1. A description of the activity;
2. The name(s) of the participants;
3. The benefits of the trip or activity to the participants, the school, and/or District;
4. A justification for the expenditure of Board funds; and
5. The amount of Board funding required.

No expenditure of Board funds for extracurricular activities or trips shall be approved until the above requirements have been met and until the written recommendation of the School Council has been filed with the Board.
