For this meeting, Mr. Lawson, who had just completed his Title IX Re-Visit, went into detail about the Title IX Report Audit and explained what each of the three parts of it represented and how the school performed. The overall consensus was positive, and the school received a satisfactory rating.

Mr. Lawson explained that according to the report, HCHS had passed 2 of the 3 parts and was on the right track in his eyes. He stated that for the past 2 reports, we were spending \$91 per male athlete and \$108 per female athlete for equipment and supplies. In 2016 through 2018, the report identified that the school spent \$54/male and \$50/female for travel and per diem. Mr. Lawson also pointed out that for the two year period that athletic expenditures favored males over females by \$51/athlete.

One area of concern that Mr. Lawson pointed out to the committee was a need for public restroom facilities at the baseball-softball complex.

The floor was opened up for questions. No questions or concerns were brought up and the meeting was adjourned, and we prepared for the Public Comments session.
