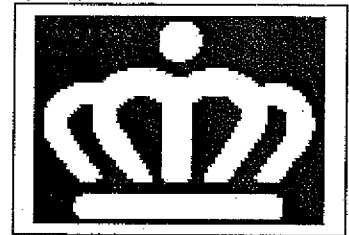

(MEDICAL AND TRAINING FACILITIES AND SERVICES) On or before May 10, 2011, the school is to submit to KHSAA a written usage schedule for Weight Room #2 that shows equal accessibility for female athletes. This schedule should be placed in the school's Title IX file and also be posted at the appropriate facility.

Mason Co. High school is fortunate to have two separate and very differently equipped weight rooms available for its athletes.

Weight room # 1, located at the Football/Soccer Complex, is equipped with heavier, mostly free weights, and is designated as the Boys weight room.

Weight room # 2, located in the auxiliary building just behind the high school, is equipped with lighter, mostly universal type machines, and is designated at the Girls weight room and is designated for use as the girls weight room during the school year from 3:30-6:30 each day and from 9:00am to 1:00pm in the summer months.

All teams are aware of this designation of each weight room.

Sign up schedules for teams wishing to reserve either, including cheerleaders, are located in the office of the Athletic Director and in each facility.

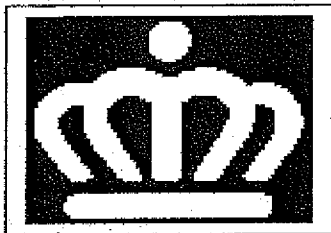

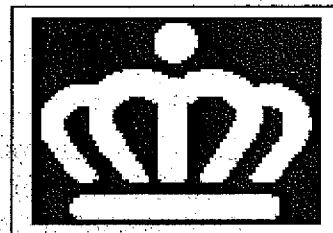

(COACHING) On or before May 10, 2011, the school should submit to KHSAA a written review and/or justification of the current salary supplement allotted for the assistant volleyball coach. This documentation should be signed by the school Title IX coordinator, the district Title IX coordinator, and the school principal.

The position of assistant volleyball coach was added late this year in mid-August 2010. This school year, 2010-2011 was our first year of Varsity Volleyball after fielding a freshman squad in 2008-2009 and a JV squad in 2009-2010. We were not even certain as this season began we would have enough interest to have a Varsity squad so we did not create a position of JV volleyball coach because of lack of numbers.

Varsity practice began in July but as school started in August we began to see a small increase in numbers and decided to search for a assistant to help. We announced the position through our school email receiving no responses as we began our schedule.

About two weeks into the season and no responses to our search, our Varsity coach approached us with the idea that her husband, who had previously helped coach a couple of other sports and met all requirements had volunteered to help her at GAMES ONLY that his job would prevent him from ever attending practice-he wanted no money. With the season already begun, we felt the need to accept this idea with hopes of finding a full-time assistant for 2011-2012. The part-time-late starting salary of \$300 for 2010-2011 was later agreed to between both parties.

Due to the newness of this program, coaching stipends and allotted positions will be evaluated at the end of each year determined by the growth and expansion of the program. We are presently searching for a full time Volleyball assistant
