If you didn't receive a letter it was probably determined you didn't need a reminder based on a review of your 2003-04 schedules. We reviewed each school. It looks to me like you are currently doing great. I say that with a bit of reservation because of your mention of the nine girls games swinging "away" next year. When looking at this, I'm sure a school will also look at whether the boys' home prime time games fluctuate in comparable fashion in this two year cycle. If boys' games swing away next year and the girls and boys home prime time schedules end up being comparable for 2004-05 (whatever the percentage) then you do not have a problem. They must be comparable (but in no case may girls be less than 40% each year if boys are more than 40% each year) to be Title IX compliant.
