Thanks for the conference call on Friday concerning our Volleyball Team and the use of gyms. Hopefully from our phone conversation you understand that the issue has been addressed.

Shannon and I agree with you on several points, mostly the fairness of the Volleyball Student/Athletes. We do not agree that this is a Title IX issue. Site Based Decision Making Law states that the building Principal determines the use of space in the educational facility. We have two excellent facilities that can be used for Volleyball; both gyms have the same amenities. If this were a title IX issue would Morehead St. not be required to play in Johnson Arena, or the University of Kentucky required to play in Rupp Arena, for their Volleyball games

Therefore that being stated, we wanted you to understand our position, that we have two excellent gymnasiums and feel both are conducive to use for Volleyball. We have included the schedule and location of each game.

We will continue to monitor all of our school activities to make sure we are complying with the intent of the Title IX Law.
