School personnel should look at the Bermuda grass issue very closely at this time because of the following:

- 1. The February 21, 2001 original school visit report, written by Dr. Fran Edwards, states that the "advantage in locker rooms, practice and competitive facilities is given to boys". She says that the current baseball and softball field "are not compatible". Also, it was recommended that the Gender Equity Review Committee "closely examine the need for an additional locker room for female athletes".
