Tryouts are announced, we have three days of clinics where the candidates are taught the fight song, and get to practice on what they do at tryouts. Each candidate is given a number and they tryout in groups of three/four. They do the fight song, a cheer, jumps and execute any tumbling they have that they would like to show. They also do stunts, showing their ability to base or fly or both. Judges score them on their skills, their grades and teacher recommendations are checked and the squad is selected from all the combined information.

4. How is each cheerleading squad assigned to home and away athletic contests? Include football as well as boys' and girls' basketball (and any other sport) at the varsity and junior varsity levels. Include any rotation plans or alternating game assignments that your squads follow.

All cheerleaders cheer all football games together and then we split the squad (as we usually have 22-24) and they rotate cheering all basketball games both boys and girls. We do not do JV or freshmen games for boys or girls. When we split, we are Red and Blue (school colors). We usually just split by stunt groups as that is the most efficient way to do it and it makes it so both Red and Blue have the same stunts.

6. Do you have any other school support groups such as pep band, dance teams or mascots that perform at athletic contests (Y/N)? If yes, name them and describe how they are assigned.

The Dance Team has a two to three day clinic to teach the routines for tryouts and then they have the official tryout. The girl's tryout for a panel of at least 4 judges and the judges make the decision on who makes the team based on the top scores. The biggest gap in scores is usually where the cut is made.

The Dance Team practices based on what fits in to everyone's schedule and it goes from there.

They perform at all home girls and boys basketball games. If they compete, the decision about which competitions is made by the sponsor as the season progresses.

The full band performs at all home football games and the playoff games.

The band is divided into two equally performing bands for basketball season. Each band performs at an equal number of boys and girls basketball games. The number of games is chosen by the band director so the band students are not out every night of the week. The two bands perform at playoff games as well.

The entire band performs at the state games.

There are two mascots at the school. There is no written policy on when they perform. It is left up to the coaches. Whoever asks for the Cardinals will be able to use them.
