The following status report has been addressed in the communication below regarding girls cross country, girls bowling.

The data and responses on the T-1, T-2, and T-3 form as well as the student athletic interest survey indicated that the school is not meeting the standard established in any of the three tests for provision of athletic opportunities. SCHOOL OFFICIALS ARE REMINDED THAT FAILURE TO PROVIDE EQUITABLE OPPORTUNITIES HAS BEEN DESIGNATED AS THE MOST SERIOUS DEFICIENCY IN TITLE IX. THE INDICATED INTERESTS IN GIRLS CROSS COUNTRY (30) AND BOWLING (27 GIRLS) NEEDS TO BE ADDRESSED FOR VALIDITY DURING THE UPCOMING SCHOOL YEAR. DOCUMENTATION OF THE ACTIONS TAKEN IN THIS ENDEAVOR SHOULD BE A PART OF THE 2012-2013 ANNUAL TITLE IX REPORT SUBMITTED TO THE K.H.S.A.A. When these interests are properly addressed the school would likely meet the standard established in test #3. In the benefits area, total athletic spending seems to be within acceptable parameters for the provision of parity when the percentage of spending is compared with the percentage of participation for both genders. Thanks for your report.

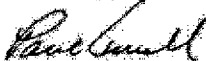
In accordance with ensuring that all booster clubs expenditures are fair and equitable as related to gender specific sports at Washington County High School, we take the following measures.

WCHS Banner Policy

Washington County High School will purchase through its' general athletic fund, a banner for any athletic team that is started. When the team wins a district, regional, or state championship; the year that they won will be added to the banner. The banner will be displayed inside the gymnasium, showcasing the year of each particular championship. Additional years of district, regional, or state championships, or runner-ups will be added to the original banner of the first team championship of that sport. Once the first banner is filled to capacity with the above stated years, the school will purchase another banner to begin the addition of future district, regional, and state championships.

Individual banners have been hung for leading scores for girls basketball and boys basketball.

Travel and Per Diem

Policy

The Washington County High School Athletics Department shall adopt an equitable policy to provide guidelines and procedures for the travel and per diem of student athletes.

Policy Statement

All athletic travel and per diem of student athletes shall be governed by the following criteria:

1. The athletics department will not provide monies for the purchase of meals during the regular season.
2. In the event that a team or individual makes the state tournament in their sport, the athletics department will purchase meals during the teams or individuals stay at the state contest. Meal money allocated for any team is \$350.00. Individual players for individual sports (golf, tennis, cross country, swim) will receive an allocation of \$28.00 each.
3. Booster clubs that purchase meals for athletes must equitably allocate the same amount of money for each meal for boys and girls. Money amounts for each meal must be the same for girls and boys similar sports (i.e. basketball, softball, etc.)
4. Booster clubs that purchase hotel rooms for athletes must be equitable (not to exceed \$100.00 per night). The rooms should provide equitable amenities. Room assignments will be as follows: 1 chaperone and 3 student athletes per room for boys and girls.
5. The athletics department will provide equitably all transportation for athletic events for male and female sports. All buses will be comparable for both male and female teams.
6. Male and female sports shall be given equitable travel opportunities for regular season tournaments, post season tournaments, out-of-region and out-of-state events. Each female and male athletic team will be given the opportunity of participating in one out-of-state contest each year. ALL out-of-state events must be approved by the board of education.
7. Out-of-state trips must have the same equitable location for each team and/or program.
8. Similar sports teams shall equitably rotate their out-of-state trips on a yearly basis. For example, if the girls' basketball team plays in the Gatlinburg, Tennessee Christmas tournament one year. That

year the boys' team may not travel out-of-state. However, the next year the boys' basketball team may travel out-of-state while the girls' team remains in state.

9. The head coach shall submit travel requests for bus transportation to the Athletics Director prior to the start of the competition season. Any additional requests must be made ten days in advance before transportation is required.

10. Student athletes shall ride the athletic bus to any scheduled event.

11. Student athletes that do not ride the bus will not be allowed to participate in the scheduled event for that evening. All student athletes traveling by bus to school sponsored activities MUST return to the school on the same bus unless the parent or legal guardian personally addresses the coach or other supervising school authority and takes custody of their child and signs them out with the coach.

12. Student athletes may not be released to ride with any person other than their own parent or legal guardian. (NO EXCEPTIONS)

13. Student athletes with extenuating circumstances may request approval for another means of transportation, by the principal or athletics director.
