Accommodation of Interests and Abilities	X		<p>The most recent Student Interest Survey was administered during the 2013-2014 school year. Submitted data indicated that students in grades 8-11 were surveyed with a return rate of 80.4%. Reported data supports the information as provided on the T-3 form(s) with reference to interest as shown on the survey. Allen Central High School currently offers five (5) sports for males and five (5) for females. Bass Fishing activity is also provided, but, currently only males have participated. Interviews with administration also indicated that bowling will be offered this school year for males and females. A total of ten (10) sport level opportunities are provided for males and ten (10) for females.</p>
Equipment and Supplies	X		<p>There was written evidence of a three (3) year uniform review plan for the sports of volleyball, basketball, softball, baseball, and football. Uniforms for golf, archery, and bass fishing are purchased yearly and retained by each participating athlete. Uniforms viewed appeared to be of high quality and comparable in the quantity provided. A review of expenditures for this category showed that approximately \$189.00 was spent per male athlete and \$327.00 spent per female athlete. All other viewed equipment appeared to be of good quality and available for equitable access.</p>
Scheduling of Games and Practice Time	X		<p>There was viewed evidence of the most recent game schedules for all sports. Viewed schedules showed comparability and equity with regard to the number of competitive event opportunities provided. There was also viewed evidence of equitable scheduling of the</p>

			<p>gymnasium, as a shared facility. Interviews with coaches indicated equitable usage and access to the indoor hitting facility for baseball and softball, however, there was not written evidence of a schedule or guideline.</p> <p>(see KHSAA recommendation 7.a.)</p>
Travel and Per Diem Allowances	X		<p>Interviews with athletes and coaches indicate transport to athletic contests by school bus. Interviews with administration indicated that meals and/or overnight stay require school administrative approval and that the school purchase order process is used to handle expenditures. Information received appeared to be equitable, however, there was not written evidence to ensure overall equivalence.</p> <p>(see KHSAA recommendation 7.b.)</p> <p>An overall review of expenditures for this category showed that approximately \$87.00 was spent per male athlete and \$188.00 spent per female athlete.</p>
Coaching	X		<p>There was viewed evidence of a school board approved salary schedule which showed overall equivalence in salary provided and comparable in the number of coaching positions. The approximate athlete to coach ratio, with regard to accessibility, was 13:1 for both males and females. Interviews indicated that end-of-season review meetings take place with each coach. These are conducted by the athletic director.</p>
Locker Room, Practice and Competitive Facilities	X		<p>There was evidence of locker room and storage assignment for all teams. Viewed locker rooms appeared to be equitable and with similar amenities. The gymnasium and</p>

			<p>football facility are located on the school campus area. The boys and girls golf teams practice and play at a local golf course, and the bowling teams will utilize the Pin Zone facility in Prestonsburg. The baseball team uses the community field located in Drift, approximately 7 miles from school. This field is also shared with South Floyd High School. The softball team has had access to two fields for usage. One field is located in Martin, approximately 8 miles from school and the other field is located in Garrett, approximately 6 miles from school. All fields are maintained, regularly, by local government agencies. All fields provide similar amenities and have also been host sites for district tournament play. There is also an indoor hitting area for softball and baseball located on the lower level of the main school building. The archery team has a practice area that is situated in the upper bleacher section of the gymnasium.</p>
<p>Medical and Training Facilities and Services</p>	<p>X</p>		<p>There was viewed evidence of one (1) weight room located on the lower level in the main school building. It is spacious and with appropriate equipment for female use. Interviews with students and coaches indicate usage of the weight room by several teams. Usage and access appear equitable, however, there was not a written plan in place.</p> <p>(see KHSAA recommendation 7.c.)</p> <p>There are currently no athletic training services provided. An emergency vehicle is on site for all home football, boys and girls basketball games. Athletic physicals are the responsibility of each student. There was viewed evidence of emergency plans for all venues in the school file.</p>

Publicity	X		There was written evidence of an awards guideline that gave the provision for picture display in the gym or banner display at each respective competitive site for regional championships. There was viewed evidence of schedule cards published for all sports and larger poster schedules also made available for all sponsored teams. School administration indicated that there is one cheerleading squad that provides support for all home football, boys and girls basketball games, as well as away district games. The pep band also provides support for the same as well as home volleyball matches. An overall review of expenditures for this category showed that approximately \$9.00 was spent per male athlete and \$32.00 spent per female athlete.
Support Services	X		An overall review of expenditures for a two-year cycle shows that Allen Central High School has met the acceptable parameters both on a percentage and per athlete basis. Interviews with coaches indicated knowledge of the process for school approval to purchase items. Interviews with administration indicate that all booster fundraisers and expenditures require school approval and are monitored by school administration. All available office space appeared to be assigned on an equitable basis.

- b. Please submit to the KHSAA, no later than February 1, 2016, an expanded Travel and Per Diem that would include, but not be limited to, parameters and specifics of spending relative to meal allowance and hotel accommodations/cost.
- c. Please submit to the KHSAA, no later than February 0 1, 2016, a weight room schedule showing equitable usage and access by male and female teams.
