Accommodation of Interests and Abilities	X		The most recent Student Interest Survey was conducted during the 2011-2012 school year. Students in grades 8-11 were surveyed with a return rate of 100%. According to data submitted, there are currently 11 sport level opportunities for females and 13 for males; six (6) varsity sports for females and seven (7) for males. Information submitted on the most recent T-3 form supports the results from the Student Interest Survey with student interest indicated in the area of girls archery. To continue to meet the standard of Test 3, this interest must be pursued for validity and feasibility. The results should be included on the T-3 form of the 2014 Annual Report. (see recommendation 6.a.)	
Equipment and Supplies	x		There was written evidence of a six (6) year rotation plan for the replacement of uniforms. Viewed uniforms appeared to be of comparable quality and equitable with regard to the quantity provided. Coaches interviewed were well award of the uniform plan. All other viewed equipment appeared to be of excellent quality and available for equitable access.	
Scheduling of Games and Practice Time	x		There was viewed evidence of all sports schedules and team calendars that included scheduled contests and equitably assigned practice days and times. There was viewed evidence of equitable scheduling for the shared facilities of the high school gym, middle school gym, and athletic complex. (see recommendation 6.b.) Viewed competitive schedules were	
	_		comparable in the number of event opportunities provided and showed parity for the like sports.	

Travel and Per Diem Allowances	X	There was written evidence of a travel and per diem guideline. The modes of transportation included were use of school bus and school owned vans for travel to off campus practice sites and competitive events. There was viewed documentation regarding the administrative oversight and approval for hotel stay and overnight trips. Site Based Council policies provided the parameters and provisions in regard to food allowance.
Coaching	X	There was viewed evidence of a school board approved salary schedule which showed overall equivalence in the base salary provided and comparable in the number of positions for like sports. Slight differences in shown salary amounts were relative to the fact that coaches are given \$100.00 per year, up to five (5) years coaching experience, toward the base stipend. The approximate athlete to coach ratio is 9:1 for males and 10:1 for females. Approximately 60% of head coaches for the girls and boys teams are located on-campus. Evaluations of coaches are completed by school administration.
Locker Rooms, Practice and Competitive Facilities	X	There was written evidence of locker room assignment for all sponsored teams. All viewed locker rooms appeared to be equitable and with similar amenities. All locker rooms were designated with appropriate signage at each entrance. There was also written evidence of storage assignment for all teams. All practice and competitive facilities are located on the campus with the exception of golf. The golf team practices and plays at the Ballard County Country Club, approximately five (5) miles from the school campus. Administration indicated that school bus transportation is available to transport students to that site. The latest addition of facilities at the Ballard Memorial High School is the construction of the Athletic Complex. This is an on-campus building that provides storage space for multiple teams, two

	(2) locker rooms, and an indoor practice area that currently provides benefit to softball, baseball, golf teams, and football. There are two sets of washer/dryers accessible to all teams; one set in the athletic complex and the other located off the gym. All facilities are excellent and very well maintained. A viewed minor disparity appears to exist between the baseball and softball scoreboards. The current softball scoreboard gives score and inning information only while the baseball scoreboard gives detailed game and inning by inning information. School officials should take this into consideration for future replacement of the softball scoreboard.

Medical and Training Facilities and Services	X		There was evidence of two (2) weight rooms. One is located in a building right next to the football/track area and the other is located in the fitness/conditioning room next to the gym. Both were well maintained, spacious and provided equitable access. Calendar schedules in the file showed use of both weight rooms but posted usage schedules were not evident at either site. Interviews with students and coaches indicated use and access to both weight rooms. There are no Athletic Training services available but interviews with administration indicated availability of evaluation and treatment of injuries for all athletes at the Orthopedic Institute in Paducah. Athletic Physicals are provided to all students on designated day(s) during the summer. They are provided by local Nurse Practitioners and sponsored by the school HOSA group. A \$10.00 donation is requested, but not required. (see recommendation 6.c.)
Publicity	X		There was written evidence of an awards guideline that outlined the criteria for letters and bars specific to each team, provision for banquets, and for banner display. There is one cheerleading squad that performs at football, girls and boys basketball, and volleyball post season tournaments. The band also performs at football, boys and girls district team contests, and volleyball post season tournaments.

Support Services	X	An overall review of spending has shown that Ballard Memorial has met the acceptable parameters both on a percentage and per athlete basis. Interviews with administration indicated outside booster club accounts for baseball, softball, football, volleyball, girls/boys basketball, and girls/boys soccer. Interviews with administration indicated that a new booster agreement is in the process of being developed. (see recommendation 6.d.) There was written evidence that required school board approval for all fundraising activities. Interviews with administration and coaches indicated no administrative oversight for approval of booster expenditures. Interviews with coaches indicated knowledge of the procedure regarding the school process for approval to purchase items. All available office space appeared to be assigned equitably.
