Accommodation of Interests and Abilities	X		According to the data, Belfry High School has met the standard for Test 3, the test of Full and Effective Accommodation of Student Interests. The survey conducted February 19, 2015, had a return rate of 87%. Tennis has been introduced as a new sport at Belfry High School. The interest shown in bowling, bass fishing, and swimming was recognized by school officials. The Title IX File contained all required documents and was well organized.
Equipment and Supplies	X		Review of the uniforms showed the quality and quantity for like sports was equitable. Quality was excellent for uniforms provided. As recommended in previous audits, there is a four-year uniform rotation plan, however, it needs to be more specific showing a full cycle of review. A specific rotation schedule will also allow teams to plan ahead for raising funds for purchasing new uniforms at the determined time and that no team is overlooked. It is recommended that the GEC develop a specific uniform rotation schedule based on an equitable cycle of review. (See KHSAA Recommended Action in relation to new deficiencies) Spending in the area of equipment and supplies has not been in the acceptable range for the past two years. School officials explained that this occurred because new football uniforms had to be purchased; home uniforms purchased one year and away the next year. It is suggested that the 2014-2015 annual report reflect equitable spending in the area of equipment and supplies. Three years of inequitable spending would reflect a pattern that could cause a deficiency in this area.

Scheduling of Games and Practice Time	X	Schedules were in the Title IX file for all school sponsored teams. Like sports appeared to have equitable number of events and were compatible in scheduling events. Weight room schedules for teams were on file and posted outside the weight room. In addition, schedules for shared practice facilities were posted and filed.
Travel and Per Diem Allowances	X	In the previous audit it was stated that no written guidelines for travel and per diem were observed. There is now written travel guidelines on file, however, the guidelines did not address parameters for overnight trips. There were guidelines addressing meal provisions for regular season games. It was stated that the teams have not taken overnight trips in recent years unless it was involved in a state play-off championship. For future reference, it was suggested that the GEC develop guidelines that have more specific details regarding per diem allowance. The GEC is recommended to develop a guideline of Travel and Per Diem for all teams in the event that they may participate in an overnight regular season competition.
Coaching	X	As in the 2008 audit, all head coaches are on campus making access of coaches by athletes very easy. Compensation for head coaches is equitable for like sports, but compensation to assistant coaches is provided for football and girls' and boys' basketball only. All other assistants are volunteer. This situation is something that the district needs to reconsider. Paid assistants, instead of relying on volunteers, may ensure more dependability and loyalty to that position and also, a more experienced coach for the athletes. The ratio of coach to athlete is equitable for male and female athletes. There is no formal evaluation of coaches; an informal evaluation by the AD or principal is the present process.

Locker Rooms, Practice and Competitive Facilities	X	The athletic facilities are all excellent, both indoors and outdoors. Schedules for facilities of like sports were on file and where possible, posted. Locker rooms were equitable for girls' and boys' basketball. The baseball and softball teams dress at the restrooms at the field. Because every athlete should have the benefit of privacy and security for personal items, these teams should have locker rooms within the school until a field house is constructed by the baseball/softball fields. It was also noted that the golf and tennis teams need a designated locker room. It is recommended that these teams be assigned locker room inside the school. (See the KHSAA Recommended Action). The physical education locker rooms could be used as part of these locker room assignments.
Medical and Training Facilities and Services	X	The weight room is located in the field house by the football field, but because the field is very close to the school it is very accessible for the female athletes. A usage schedule is in the file, as well as being posted by at the facility. Appropriate equipment for female use is available.
		There is no trainer available, but there are two rooms available. Each is equipped with a washer/dryer, ice machine, and training table. Coaches use the facilities as needed. A local physician provides services to the athletes. Physicals are provided by a local physician free of charge at the school on a designated date.
Publicity	X	There is only one cheering squad at Belfry High School and the AD has oversight on the assignment of girls' and boys' basketball games. The same is true with the band. The spending in the area of publicity is within the generally acceptable parameters.

		In the file, there are guidelines for earned awards, banner and picture displays, as well as for the hall of fame. Schedule cards were only seen for football, but it was stated that occasionally other sports will have them. There is also a fall sports program that features athletes for all fall sports. A handbook for athletes and also one for coaches was available.
Support Services	X	Overall spending totals for the past two years has not been in the acceptable range for the amount per athlete. After examining the data available and through interviews, it appears that the area of equipment and supplies is a contributing factor in this area. There are no booster clubs. Fundraising is sometimes done by individual teams, but most teams have concessions which provide extra income for their teams. All funds raised are deposited in the school accounts. The process of purchasing an item requires a purchase order, approved by AD or Principal, and the Site-Base council.

7. KHSAA Recommended Action in relation to new deficiencies

Although no deficiencies were designated in this report, the following benefit categories should be addressed:

- In the area of Equipment and Supplies, it is recommended that the Belfry High School Gender Equity Committee develop a specific (for each team) uniform rotation schedule based on the four year rotation plan already in place. Submit on or before April 30, 2015 to the KHSAA office.
- 2. In the area of Locker Rooms, Practice and Competitive Facilities, the school is to submit a complete listing of locker room assignment showing provision for all teams on or before April 30, 2015.

10. Comments

Belfry High School's athletic facilities are of top quality. The school personnel has continued to provide excellent facilities for the athletes and opportunities for participation in a variety of sports. The willingness of the school and community to support these teams is obvious as the facilities and equipment are maintained at a very high level. The Athletic Director appeared to be well prepared for the school visit. Both students and coaches appeared to have a lot of pride in the athletic program and the school.
