# 5. Brief Summary/Analysis of the Corrective Action Plan (T-60)

The addition of more female participants was a top priority on the Corrective Action Plan for all three years of reporting. Volleyball was added as an intramural sport in 2001-2002 and then as an interscholastic sport in 2002-2003. Along with gaining a new position for a separate girls' tennis coach, school personnel are continuing efforts to encourage participation in that sport by adding more tennis courts. The survey of student interests indicated a strong interest in golf and soccer as well as tennis. A preliminary attempt to add a girls' golf team did not match the interest indicated on the survey. Soccer interest has not been pursued. School personnel will carry out a plan that has been devised to make cheerleading assignments equitable this school year in basketball.

#### 6. Observed Deficiencies in Overall Girls and Boys Athletics Programs

Lack of participation in girls' sports was the overriding deficiency observed. Providing opportunities for sports in which girls indicated an interest has been addressed to a degree, but the promotion of girls' sports and the continued provision of qualified coaches are necessary for continued progress. There is a need to provide more apparel and equipment for spring sports for both boys and girls. More administrative oversight is suggested over booster participation and records. Since the athletics director is also a coach, more overall general administrative attention to the athletics program would be advisable. Such items as policies on awards and recognitions, written schedules for use of facilities, uniform purchase, and general record keeping were not evident during the on site visit.

#### 7. Facility Recommendations or Concerns

The clean-up, repair and refurbishing of the softball training center needs to be provided by the school so that the facility can be used as an exclusive locker room for the softball team. This would balance out the exclusive locker room space provided to the two boys' teams. The tennis courts are in need of repair, and other courts should be provided until repairs are made or new courts are constructed. Alternate courts should be provided to the girls' teams because of the positive impact it would have on overall female participation.

If these corrected calculations do not meet any of the three tests for compliance, school personnel will attach a plan for further addressing the problem to the 2002-2003 Annual Title IX Report, due **April 15, 2003**.

(Equipment and Supplies) Included in the 2002-2003 Annual Title IX Report due to the KHSAA on April 15, 2003, the school is requested to provide a copy of the policies applicable to all teams that were generated by the Gender Equity Review Committee on the provision of food/meals to athletes.

(Locker Rooms) School personnel shall submit its plan to clean up and refurbish the softball training center to the KHSAA office by December 15, 2002.

(Prime Time Contest/Girls' Basketball) Included in the 2002-2003 Annual Title IX Report due April 15, 2003, the school is requested to provide information to the KHSAA concerning the number of "prime time" games scheduled (games to be played on Friday and/or Saturday nights) for its girls' varsity basketball team during prime times (when compared with the percentage of boys' games scheduled for prime times), the school shall advise the KHSAA of action it intends to take to immediately correct the difference.

A. Notes

- 1. It is imperative that school personnel review the original compliance document submitted in 1999-2000 and clear up the ambiguities, enter missing data, and redo forms that were computed incorrectly in order to have in place the base data needed for subsequent evaluation.
- 2. It is recommended that the Gender Equity Review Committee review the following benefits to ascertain whether or not results reasonably match the participation ration of male and female athletes:
  - a. the number of away competitions in all sports
  - b. the number of athletes given access to sports camps
  - c. the number of athletes eligible for individual awards and recognitions
- 1. It is strongly recommended that school personnel develop policies that require

approval by the principal for all fund raising events, special events, and for all expenditures by booster organizations. Inclusion of a booster representative on the Gender Equity Review Committee is advised. It is also recommended that notice of the Gender Equity Review Committee meetings be better publicized.
